SUBJECT: CONSIDERATION OF A REAPPROPRIATION ORDINANCE TO AMEND FISCAL YEAR 2004 APPROPRIATION

**ISSUE:** Consideration of a Reappropriation Ordinance to amend Fiscal Year 2004 Appropriation.

**RECOMMENDATION:** That City Council:

- (1) Pass this proposed ordinance (Attachment I) on first reading and schedule it for public hearing, second reading, and final passage on Saturday, November 15, 2003; and
- (2) Accept the monetary and non-monetary gifts and donations to the City described in the Report on Monetary and Non-Monetary Gifts and Donations (Attachment III).

**DISCUSSION:** Each year City staff submits a Reappropriation Ordinance to City Council to reappropriate monies authorized and obligated in the prior fiscal year but not expended as of June 30. By City Charter, all appropriations lapse at the end of the fiscal year. When budgeted equipment is ordered prior to the end of the previous fiscal year, but not delivered until the next fiscal year, monies need to be reappropriated to cover the expenditures paid in the current fiscal year. This ordinance also includes the appropriation of grants, donations, and other resources received in the current fiscal year. Staff recommends that the Fiscal Year 2004 Appropriation be amended to accomplish the following purposes:

Section 1. The reappropriation of monies to pay for commitments, in the form of encumbrances, established prior to June 30, 2003, but not paid by that date. Encumbrances totaling \$3,589,845 include \$2,386,468 of General Fund obligations for purchase orders authorized and issued but not paid by year end; \$1,203,000 of Equipment Replacement Reserve Fund obligations (primarily for vehicles and equipment ordered in FY 2003 but not yet delivered until FY 2004); and \$377 of Alexandria Transit Company obligations.

- Section 2. The reappropriation of grant revenues authorized in Fiscal Year 2003 or earlier, but not expended or encumbered as of June 30, 2003. Of the \$18,954,654 previously appropriated, \$9,874,623 is associated with Housing and includes \$2,212,358 in federal grant monies (Community Development Block Grant and HOME Investment Partnerships Program), and \$6,053,647 in Housing Trust Fund monies; \$684,868 is associated with Human Services for Youth, Aging and Social Services programs, and \$263,976 with the Economic Development Disaster Recovery Grant primarily for tourism promotion and revitalization planning.
- Section 3. The appropriation of grant revenues accepted or adjusted in FY 2004, but not yet appropriated. A listing of grants is included (Attachment II) and totals \$1,043,900.
- Section 4. The reappropriation of balances remaining as of June 30, 2003, in donation accounts or activities. Of the \$718,920 reappropriated, \$195,303 is associated with the seized asset programs for the Police Department and the Commonwealth Attorney's Office; \$24,964 is from the Department of Human Services primarily for Aging and Youth programs; \$117,318 is associated with Historic Alexandria donations including Gadsby's Tavern, Fort Ward, the Black History Resource Center and the Lyceum; \$4,724 is associated with the Recreation Department primarily for landscape and King Street Gardens projects. The City is obligated to use these monies for the specific purposes for which they were donated.
- Section 5. The appropriation of \$58,139 of General Fund balance representing revenue earnings of certain City agencies. This appropriation includes: \$53,538 of revenues earned in excess of budget estimates for Historic Alexandria; and \$2,134 of revenues from the sale of publications by the City Clerk and Clerk of Council; and \$2,467 of revenues from the sale of publications for Citizen Assistance.
- Section 6. The appropriation of \$1,184,951 of General Fund balance for the continuation or the completion of projects and initiatives authorized in FY 2003 but not yet completed. This appropriation includes \$309,136 to Transportation and Environmental Services for storm sewer initiatives, solid waste tip fee costs, transportation policy and program and for planned traffic modeling study; \$270,000 previously appropriated for the Alexandria Community Foundation; \$25,000 to Recreation for the Public Arts Program contingent and \$99,295 for planned Windmill Hill Park capital improvements; \$100,000 for software purchases; \$91,679 for the Neighborhood Partnership Fund; \$50,000 for a before/after childcare consultant; \$50,000 for the Teen Center contingent; \$50,000 for the closed captioning contingent; \$48,841 for the Marketing Fund in unexpended FY 2003 funds; \$40,000 for sign planning; \$21,000 for planned office improvements and renovations in the Personnel Office; \$20,000 for employee tuition reimbursement; \$5,000 for Eisenhower Partnership-Retail Marketing; and \$5,000 to Historic Alexandria for equipment.

**FISCAL IMPACT:** The six sections of the ordinance appropriate a total of \$25,550,409 as follows:

AN ORDINANCE making provision for the support of the government of the City of Alexandria, Virginia, and for the payment of municipal expenditures by providing supplemental appropriations of amounts required to defray certain expenditures and liabilities of the city for fiscal year 2004, which began on the first day of July 2003 and ends on the thirtieth day of June 2004.

THE CITY COUNCIL OF ALEXANDRIA HEREBY ORDAINS:

**Section 1.** That the Council of the City of Alexandria, Virginia, does hereby make provision for and appropriate to the funds hereafter named the amounts required to defray the expenditures and liabilities of the city for which commitments were established in the form of encumbrances or otherwise on or before June 30, 2003, but which are payable in fiscal year 2004, and for which amounts were appropriated but not expended in fiscal year 2003, and further that the council does hereby allot the amounts so appropriated to the several city departments for fiscal year 2004, as follows:
