

Subject Resolution

Mr. Mayor, Members of Council, Fellow Stakeholders, and Neighbors:

Today I will deliver to Mr. Mann for forwarding to Council copies of the signatures on the petition (attached) that states unequivocal and overwhelming citizen support for maintaining the status of BOTH Hunting Towers AND the remaining Hunting Terraces as affordable housing for our community.

It further supports the principle of "no evictions without just cause," a matter that seems to have slipped through the cracks in this current debate.

I noted with interest that Council recently responded favorably on another matter to a citizen's petition containing roughly forty signatures.

This petition was signed in a few short weeks just prior to the most recent Council elections by more than ONE THOUSAND of our citizens—including HUNDREDS of current and past residents of the Towers and Terraces, SCORES of neighbors, Council Members, Stakeholders, our Congressman James Moran, and fellow Virginia citizens including members of the Commonwealth legislature..

If it is necessary to obtain additional signatures to adequately convey the sense of the citizens of Alexandria and the Commonwealth of Virginia to the Council on this matter, please advise me. If required, I and others will obtain additional signatures to reinforce the opinion of our community regarding the

principles stated in the petition, so that Council may be able to respond appropriately to the specific wishes of the citizens of Alexandria.

# *Petition of the Citizens*

**Whereas it is in the interest of the working and retired citizens of the City of Alexandria and of the Commonwealth of Virginia to have access to affordable and safe housing, secure from displacement through means not of their choosing nor under their control;**

**&Whereas affordable housing has become an increasingly endangered resource in the City of Alexandria and throughout Northern Virginia;**

**&Whereas construction of the new Wilson Bridge has already resulted in the destruction of approximately 300 units of affordable housing in the Hunting Towers/Hunting Terrace apartment complex;**

**&Whereas the residents of the remaining 645 units, some relocated from the destroyed units, some having called the complex home for over 50 years, have borne and are continuing to bear the brunt of bridge construction impacts of all shape, manner and kind;**

**&Whereas said residents are now facing an increasingly uncertain future with the possibility of losing all remaining units, a potential loss that would impact not only current residents but future generations of Alexandrians as well;**

**Therefore the undersigned citizens, in the name of fair play for current residents, and in the interests of preserving this affordable housing resource for future generations of Alexandrians and keeping our community a diverse home for middle and lower income residents as well as the more affluent, demand of their government that:**

- NO further destruction of any housing units at the Hunting Tower-Hunting Terrace complex be permitted except as part of a guaranteed agreement with prospective developers that would preserve affordable housing units at the site sufficient in number to house all current residents.**
- NO evictions of residents be carried out without just cause, unless, concurrently, all of those residents are provided with equivalent on-site safe and affordable housing, together with reasonable compensation for relocation costs incurred.**

The final version **should not** included the language, "saving affordable housing in Alexandria, and Hunting Towers".

Rather, since the resolution is pertaining to Hunting Towers specifically it should read as, "saving affordable housing at Hunting Towers".

Even Councilman Smedberg, who wants to change the language of the resolution, abstained from a recent vote that would give DC residents voting rights. He reasoning was that the DC agenda was not pertinent to Alexandria business. Therefore, the inclusion of his revised language is not pertinent to the resolution, since the resolution is specifically aimed at saving affordable housing at Hunting Towers, not affordable housing throughout the entire city.

If Staff and Council truly feel it is important to save affordable housing throughout Alexandria, a second resolution should be drafted and presented to Council at another time.

Hello,

Below is an email I received pertaining to the Hunting Towers resolution. The same resolution that was deferred by Council, until such time as the Stakeholder Panel has an opportunity to view and discuss its contents. Again it appears that the Stakeholders will not be permitted the promised time to meet and collaborate on any concerns they have, if any, with either of the two resolutions presented to us. While the preservation of Affordable housing at Hunting Towers is crucial, it is inappropriate to have undisclosed, backroom dialogue between Staff and Stakeholder representatives for the following reasons:

1. No verifiable disclosure of these email comments will be available for public record. Staff already has much on its plate, and it is unlikely they will have the time to forward all comments to all Stakeholders for review before May, 2nd.
2. No opportunity for public group discussion by community members, including Towers and neighborhood residents, will be available.
3. A second draft of the original resolution has been forwarded to us without prior discussion as to the contents, or review and/or acceptance by the Stakeholders.

Therefore, why should we now expect our comment to be included or addressed?

It was the desire of many Stakeholders at the inception of the panel that a democratic process would be embraced, providing a fair and unbiased means to discuss all issues that impact this redevelopment of the Hunting Creek area. To this point the ideas presented by the Stakeholders have been largely ignored. The apparent embracing of the IDI-Kay plan, as the only option, has been the direction IDI-Kay and Staff has focused its attention. If this process continues in its current state, Council will not receive any pertinent or relevant suggestions/input from the Stakeholders. Instead, Council is forced to assume that all involved are accepting of the current IDI-Kay plan, and this is not the case.

While I do support the resolution to save Hunting Towers as affordable housing, I have issue with the process the Stakeholders have been subjected to. The cancelled meetings, incomplete minutes, ignored site-plan alternatives, and finally the last minute resolution review request all point to preferential treatment being provided for the IDI-Kay interest, and not the citizens.

There is still time to step back and take a moment to listen to the real concerns of the Stakeholders and community, and then legitimately address them. If this is not the intent of IDI-Kay, Staff, and Council please let us know, for we are very busy in our daily lives and should not be forced to squander time on platitudes and placation.
