SUBJECT: CONSIDERATION OF A REAPPROPRIATION ORDINANCE TO AMEND FISCAL YEAR 2007 APPROPRIATION

ISSUE: Consideration of a Reappropriation Ordinance to amend Fiscal Year 2007 Appropriation.

RECOMMENDATION: That City Council:

- (1) Pass this proposed ordinance (Attachment 1) on first reading and schedule it for public hearing, second reading, and final passage on Saturday, November 18, 2006; and
- (2) Accept the monetary and non-monetary gifts and donations to the City described in the Report on Monetary and Non-Monetary Gifts and Donations (Attachment 3).

DISCUSSION: Each year City staff submits a Reappropriation Ordinance to City Council to reappropriate monies authorized and obligated in the prior fiscal year but not expended as of June 30. By City Charter, all appropriations lapse at the end of the fiscal year. When budgeted goods and services are ordered prior to the end of the previous fiscal year, but not delivered until the next fiscal year, monies need to be reappropriated to cover the expenditures paid in the current fiscal year. This ordinance also includes the appropriation of grants, donations, designations and other resources received in the current fiscal year. Staff recommends that the Fiscal Year (FY) 2007 Appropriation be amended to accomplish the following purposes:

- Section 1. The reappropriation of monies to pay for commitments, in the form of encumbrances, established prior to June 30, 2006, but not paid by that date. Encumbrances totaling \$916,599 of Equipment Replacement Reserve Fund obligations (primarily for vehicles and equipment ordered in FY 2006 but not yet delivered until FY 2007).
- Section 2. The reappropriation of grant revenues authorized in Fiscal Year 2007 or earlier, but not expended or encumbered as of June 30, 2006. Of the \$10,669,047 previously appropriated, \$7,537,148 is associated with Housing for the Affordable Housing Fund and includes \$1,260,003 in Housing Trust Fund monies; \$1,281,708 is associated with Human Services for Youth, Aging and Social Services programs and \$817,981 for Police grants.

- Section 3. The appropriation of grant revenues accepted, which need adjustment in FY 2007, but not yet appropriated. A listing of grants is included (Attachment 2) and totals \$889,867.
- Section 4. The reappropriation of balances remaining as of June 30, 2006, in donation accounts or activities. Of the \$1,194,796 reappropriated, \$381,760 is associated with the seized asset programs for the Police Department and the Commonwealth's Attorney Office; \$203,746 is associated with Historic Alexandria donations including Gadsby's Tavern, Fort Ward, the Black History Museum and the Lyceum; \$154,103 is associated with the Recreation Department, primarily for the Commission for the Arts and living landscape projects; \$125,868 is associated with the Department of Human Services, primarily for Aging and Youth programs. The City is obligated to use these monies for the specific purposes for which they were donated.
- Section 5. The appropriation of \$28,187 of General Fund balance representing revenue earnings of certain City agencies. This appropriation includes: \$20,000 of revenues earned in excess of budget estimates for Historic Alexandria; \$4,737 of revenues from the sale of publications for Citizen Assistance; and \$3,450 of revenues from the sale of publications by the City Clerk and Clerk of Council.
- Section 6. The appropriation of \$2,649,421 of General Fund balance for the continuation or the completion of projects and initiatives authorized in FY 2006 but not yet completed. This appropriation includes \$517,521 to Housing for grant cash match; \$391,760 for City efficiency and best practice studies; \$231,900 previously appropriated for the Alexandria Capital Development Foundation; \$170,782 for the Safe Haven construction project; \$132,000 for a maintenance management system; \$50,000 for economic development related financial consulting such as for Landmark Mall; and \$219,000 for renovation costs.
- Section 7. The reduction in appropriation of \$1,634,744 transfer to the Affordable Housing Fund. Appropriations are being reduced to reflect the debt service payments on the \$15 million for the affordable housing taxable bonds issued in June 2006. The City Council dedicated one cent of Real Estate Tax revenue (\$3,288,608) in the original FY 2007 budget. After this reduction, the net amount transferred to the Affordable Housing Fund will be \$1,653,864.
- Section 8. The transfer of budget authority from non-departmental to various City departments to establish budget authority in the department in which the program or activity is carried out.
- Section 9. The appropriation of \$4,971,406 of General Fund Balance designated in the Comprehensive Annual Financial Report for the fiscal year ended June 30, 2006. These funds represent the 2.0% market rate adjustment to General Schedule employee compensation (\$3,000,000) approved and implemented prior to the start of FY 2007; Federal or State Intergovernmental Revenue or Grant Reductions particularly for the mandated activities related to foster care and special education

services (\$1,000,000); Monroe Avenue pedestrian bridge design (\$300,000); Affordable Home Ownership Preservation (AHOP) tax grants (\$120,000); Affordable Housing Fund (\$275,703); and Open Space fund (\$275,703). The \$275,703 each for Affordable Housing and Open Space fund represents the increase in the value of one cent of the Real Estate Tax in the last half of FY 2006 for increased 2006 Real Estate assessments.

FISCAL IMPACT: The nine sections of the ordinance appropriate a total of \$19,684,579 as follows:
