Dear Danielle,

I am resigning my position on the Environmental Policy Commission effective immediately.

As you are aware, I do not have the time to satisfy the demands and responsibilities that continue to be placed on the members of the Commission. While I can deeply appreciate the responsibility City Council places in the Commission, I am still flummoxed by the accelerated timeline the Commission was given to develop Phase Two of the Environmental Action Plan, in particular given the Commission's recent success in drafting and adopting the Eco-City Charter and the Phase One Action Plan. Given the additional Commission meetings required for Phase Two and the Commission's regular business, I simply do not have enough time to become sufficiently informed about the activities the Commission may propose under the Phase Two Action Plan. Therefore, I do not expect to feel comfortable with voting on those activities. Furthermore, I believe it would be best to begin implementing the Phase One Action Plan, which may be subject to neglect due to work on Phase Two.

It has been an enjoyable fifteen months. I have learned much, deeply enjoyed my interaction with the City staff, and am proud of my small contribution to the Commission's recent accomplishments. I offer my assistance to the Commission to inform and evaluate any proposals related to energy use and climate change policy under the Phase Two Action Plan, and to implement the action items in Phase One.

I am certain they will follow on the success of the Eco-City Charter and the Phase One Plan and develop implementation policies and a Phase Two Action Plan of which they and the City can be proud.
