SUBJECT: CONSIDERATION OF AN ORDINANCE TO ESTABLISH THE CHARLES HOUSTON RECREATION CENTER (IN LIEU OF FIRE DEPARTMENT HEADQUARTERS) AND THE PATRICK HENRY RECREATION CENTER (IN LIEU OF ST. MARTIN DE PORRES SENIOR CENTER) AS POLLING PLACES IN THE CITY OF ALEXANDRIA

ISSUE: Consideration of an ordinance to establish the Charles Houston Recreation Center (in lieu of Fire Department Headquarters) and the Patrick Henry Recreation Center (in lieu of St. Martin De Porres Senior Center) as polling places in the City of Alexandria (Attachment).

RECOMMENDATION: That City Council pass the ordinance on first reading and set it for public hearing, second reading and final passage on Saturday, June 13.

BACKGROUND: The Alexandria Electoral Board, which is composed of three bipartisan members who are appointed by the Alexandria Circuit Court for staggered three year terms, is responsible for making recommendations to City Council about changes in precinct boundaries and for establishing new precincts. Council has the authority to make these changes. The Electoral Board surveys existing polling places and available facilities on a regular basis in an effort to provide voters with accessible and suitable polling places. In addition, the Board is required to consider possible moves from private to public facilities whenever possible because State law (Section 24.2-310 of the Code of Virginia) which requires that, "each polling place shall be located in a public building whenever practicable."

On April 14, 2009, the Electoral Board voted to recommend that City Council establish the Charles Houston and Patrick Henry Recreation Centers as polling places in lieu of the Fire Department Headquarters and the St. Martin de Porres Senior Center polling places.

DISCUSSION: On June 16, 2001, Council approved an ordinance amending the City Code to change polling places and precinct lines in the City, including the addition of the Fire Department Headquarters polling place. This polling place, which is located at 900 Second Street, was added to serve a portion of the population that previously voted at Annie B. Rose and to accommodate future growth in the Potomac Yard area. Currently, the voting space at the Fire Department Headquarters is located in the Fire Department bay where a fire truck usually parks

because this is the only space that is fully accessible. Although Fire Department staff have been very accommodating to voters and election officers, and many voters enjoy visiting the Fire Department on election day, this site suffers from extreme weather conditions during June primaries and winter elections such as the February Presidential Primary Election. The Electoral Board recommends that the polling place be moved to the new Charles Houston Recreation Center, 905 Wythe Street, because this new center offers space that is much more comfortable and convenient for voters.

On February 21, 2004, City Council approved an ordinance to establish the St. Martin Senior Center as a polling place to replace the Patrick Henry Recreation Center, which was scheduled to undergo construction in 2004 and 2005. The Senior Center is located across the street from Patrick Henry. The Electoral Board recommends that Council establish Patrick Henry as a polling place again (in lieu of St. Martin) because there is more space for voting at this location and State law requires polling places to be located in public buildings whenever practicable.

If Council approves the ordinance, the United States Justice Department will be requested to approve this request to facilitate the change in these polling places, which would take effect with the November 3, 2009, General Election. The City Attorney has prepared a submission for the Justice Department. In addition, after the request has been approved, the Electoral Board will send notifications to all of the registered voters in these precincts, and will also advertise the change in the local newspaper.

FISCAL IMPACT: It will cost approximately \$3,000 to send notifications to all of the registered voters in the affected precincts, and this can be absorbed in the Office of Voter Registration and Elections operating budget.

AN ORDINANCE to amend and reordain Section 2-2-10 (ESTABLISHMENT OF ELECTION DISTRICTS AND POLLING PLACES), Chapter 2 (ELECTIONS), Title 2 (GENERAL GOVERNMENT) of The Code of the City of Alexandria, Virginia, 1981, as amended.

THE CITY COUNCIL OF ALEXANDRIA HEREBY ORDAINS:

Section 1. That Section 2-2-10 of the Code of the City of Alexandria, Virginia, 1981, as amended, be, and the same hereby is, amended and reordained to read as follows:

Sec. 2-2-10 Establishment of election districts and voting places.

The following election districts and voting places are hereby established for the City of Alexandria, Virginia:

(a) The Ladrey Senior Building Election District shall be bounded and described by the census blocks shown on the map adopted by section 2-2-13 of this code as comprising the said district. The voting place within the Ladrey Senior Building Election District shall be at the Ladrey Senior Building, located at 300 Wythe Street.

(b) The City Hall Election District shall be bounded and described by the census blocks shown on the map adopted by section 2-2-13 of this code as comprising the said district. The voting place within the City Hall Election District shall be at City Hall, located at 301 King Street.

(c) The Lyles Crouch School Election District shall be bounded and described by the census blocks shown on the map adopted by section 2-2-13 of this code as comprising the said district. The voting place within the Lyles Crouch School Election District shall be at the Lyles Crouch School, located at 530 South St. Asaph Street.

(d) The Durant Center Election District shall be bounded and described by the census blocks shown on the map adopted by section 2-2-13 of this code as comprising the said district. The voting place within the Durant Center Election District shall be at the Durant Center, located at 1605 Cameron Street.

(e) The Lee Center Election District shall be bounded and described by the census blocks shown on the map adopted by section 2-2-13 of this code as comprising the said district. The voting place within the Lee Center Election District shall be at the Lee Center, located at 1108 Jefferson Street.
