I am writing to you as Chair of the Alexandria Archaeological Commission to

provide the commission's recommendation regarding the FY2011 proposed

budget--the retention of the FY2010 archaeology budget rather than approval

of the proposed reductions. The Alexandria Archaeology budget within the

Office of Historic Alexandria has a proposed decrease of \$7400: \$3500 to

eliminate part-time, roster staff that keep the Archaeology Museum in the

Torpedo Factory Art Center open on Sundays 4 hours weekly; and \$3900 non-personnel funding. While we recognize the need to economize, we

recommend maintaining the current archaeology budget due to the negative

impacts of such a reduction just at a time when many City initiatives call

for these archaeological services. Most notably, these reductions will

negatively impact on the City's ability to increase tourism visitation,

revenue and equitable public access to African history and cultural

resources--all important goals in your recent strategic plans.

The

proposed budget erroneously states that "existing full-time staff already work" on Sundays and can keep the museum open on Sundays so reduced funding of \$3500 will not decrease public access to the museum. However, in actuality without the \$3500 funding for Sunday roster staff, the museum will close. The consequences are dramatic. The four hours on Sundays account for 20 to 25 percent of the annual visitation. Closing a historic attraction for a savings of \$3500 does not fit short- or long-range planning goals, such as: 1)increasing attractions on the waterfront to encourage visitors from National Harbor to come and stay longer; 2) using history to increase the unique character of Alexandria in waterfront planning; and 3) attracting people to the Torpedo Factory Art Center. The water taxis and new waterfront signage, including the successful historic timeline, and history shop, have helped to increase visitation to the Archaeology Museum. Having visitors to the Art Center encounter a closed museum during the busiest hours of the week reduces the attraction of the entire south end of the third floor of the Factory and sends the wrong message--that the City is closed to visitors. The Torpedo Factory Art Center study documents the attraction role of the Museum. The City's Archaeology Museum was the first interactive

Comments:

archaeological museum in America and has been hailed as innovative for 30 years. It is the only place where Alexandria's oldest artifacts--dating back to 13,000 B.C.--can be seen and questions answered which promote the City's role as a leader in community archaeology. The Museum also acts as a resource for visitors related to destinations for eating, shopping, history and biking and distributes literature to promote tourism. The 9 part-time staff, who work on a revolving basis on Sundays, have gained a great deal of information over the years about archaeology and the City. Their expertise, and their ability to work independently and provide security for the entire archaeology facility (computers, files, photographs, artifacts) would be difficult to regain if funding was restored at a later time.

Reducing the operating funds for

archaeological activities by \$3900 reduces the ability to promote public activities, educate the public, provide equitable access to the City's black history and conduct research central to important City projects: preservation planning for the waterfront; Fort Ward African American research and archaeological study to manage the park as a historic site and interpret the black experience; plan and implement the 2011 opening of Contrabands and Freedmen's Cemetery Memorial--including developing the web site & cell phone tours to tell the story of the slaves who escaped to Alexandria seeking freedom; plan and conduct activities to promote tourism and community understanding during the 150th anniversary of the Civil War starting in 2011. We recommend that these funds be retained at a critical time in heritage promotion--the beginning of the Civil War anniversary years of which both Fort Ward and Freedmen's Cemetery are central. This is a case where retention of funding to promote archaeology/history will gain both revenue and prestige to the City of Alexandria in a critical heritage tourism year--2011. It will also increase access to people who want to know about their own African American past and Alexandria's diverse heritage.

Thank you for considering our recommendation. The Archaeological Commission will be communicating with you shortly on other key issues, including the Torpedo Factory Art Center Study, as well as the commission's visions for the waterfront and the future role of archaeology in the fabric of the community.

Dear Mayor Euille, Vice Mayor Donley, and Members of Council:

l am

writing to ask that you keep all options available to avoid cuts to

Metrorail and Metrobus service during next fiscal year. WMATA is

projecting a

\$189 million budget gap in FY 2011. The WMATA General

Manager proposes to close

part of this budget gap with one of the largest

fare increases in Metro's

history. Unfortunately, fare increases alone

are not enough to close the budget

gap, and an additional \$30 million in

service cuts will be needed even if the

full fare increase is adopted.

Service cuts directly impacting Alexandria

include the elimination of

Yellow Line service after 9 pm weekdays and all day

on weekends, and

reductions in Metrobus service, particularly on the 29 line. Midday,

evening, and weekend service on all Metrorail lines, including the Blue

line, will also be reduced, and eight car trains during rush hour will be

eliminated.

Preserving Metro is important to me because I have a back condition and must rely on Metro bus and rail for transportation. I am in favor of paying higher fares because I think it would support Metro safety which is a very real concern.

On June 18, 2009, I was aware

that the signal system failed at Braddock Road Metro Station one day after new signals were installed at numerous other stations including Takoma. I was lucky because the signal at Braddock Road failed completely that day, so Metro compensated for it and did not have an accident. A few days later, the signal at Takoma Station on the red line failed intermittently,

according to Metro officials, causing a confusion in the communications system and a subsequent accident that killed 10 people. Cuts in service cause dangerous overcrowding and hectic conditions and I fear riding Metro if such a situation occurs, because the crowds would become dangerously large and surely contribute to yet another disaster. In fact, many years ago I was personally involved in a Metro rail incident that involved dangerous overcrowding.

With all the wealth and privilege in Alexandria,

I cannot imagine why such political leaders here as Mr. Terry McAuliffe,
Senator Mark Warner and other Democrats would not want to have the city of
Alexandria pay its fair share of the Metro subsidy so that riders who
accept higher fares can be free of worries about Metro accidents or those
who rely on Metro like me will not have to suffer. We cannot ride in
limousines as I am sure these gentlemen do on a daily basis.

WMATA's

hearings on its FY 2011 budget do not begin until the third week of

March. Because the WMATA budget has so many moving parts, it is

important that the Council maintain maximum flexibility until riders have

had an opportunity to weigh in at the public hearings being held by the

transit authority. If you do not advertise a maximum property tax rate

high enough to accommodate the additional WMATA subsidy, then an option !

support will be taken off the table before members of the public and the

City Council have even had an opportunity to discuss it.

I am extremely upset that the Library Board and the City Manager have proposed cutting Duncan Library's operating hours. This is an incredibly short-sighted and unreasonable cut, particularly considering that, during an economic downturn, library resources are in greater demand.

For

working families, the reduced hours would make the libraries virtually inaccessible during the week. For children, these shortened hours would mean morning programs and storytimes would be delayed or cut, and evening storytimes would be eliminated. For adults, evening programs -- such as book clubs and author talks -- would likely be eliminated, and the meeting rooms would be inaccessible for community groups and library events, as all these typically begin at or after 7pm.

Is this worth a savings of just

\$173,000 annually, when the cost is reducing access to all of Alexandria's neighborhood branches?

If you've never visited Duncan Library, I

encourage you to do so. It's a true neighborhood library; many patrons live within walking distance, and the staff knows practically every child by name. It is, without a doubt, a central part of the Del Ray community and an valuable City service.

Please keep the library open in the evening.

The impact of the reduced hours is extremely disproportionate to the amount of the budget cut achieved.

Having purchased a home in Hume Springs recently, I was a little nervous

about having my wife living in this "transition" neighborhood;

however, one of the things that appeared my worries was the presence of the

Community Police Officers - particularly Officer Ruggiero. The recent

downturn in crime in the neighborhood, in fact, can be directly attributed

to his very visible presence. I think by now everyone has read Malcolm

Gladwell's book The Tipping Point in which he discusses NY's downturn in

Dear Members of the Alexandria City Council:

I write today in support of the request before you from Melinda Douglas, the Public Defender for the City for Alexandria, for a city supplement for staff salaries in her office. I spent a decade in the Alexandria Public Defender's Office, during more than half of which I served as the Deputy Public Defender. In that capacity, I oversaw many of the day-to-day operations for the office, and I served as counsel to the attorneys in matters both professional and personal. On the personal front, time and again, attorneys would express the difficulty in living in the City of Alexandria on their modest salary. I watched dedicated defenders make the difficult choice to leave the work and the office that they loved in order to support a family. In 2002, after a decade of service, I left the office for the same reason.

Like many of my colleagues who spent years working in the Alexandria Public Defender's Office, I developed considerable expertise in the field of criminal defense – so much so that I am now a law professor teaching Criminal Law, Constitutional Criminal Procedure, and a Capital Punishment seminar. My clients were pleased with the representation that they received from me, and my colleagues in the Commonwealth's Attorney's Office welcomed the opportunity to work with me because my experience and expertise simplified an often complex and emotionally challenging enterprise. Moreover, I loved the work and found it extremely rewarding. But in 2002, I could no longer afford to continue the work that I loved. I had risen to the highest level in both title/position and salary, and the future held no opportunity for advancement. There was no hope of a salary increase based on my performance, as the state did not provide any increase beyond a yearly cost-of-living assessment, and often even that modest annual cost-ofliving adjustment was frozen for years at a time. Extra money, in the form of a City salary supplement, in the Public Defender's budget would offer her the flexibility to retain seasoned attorneys, like me, who were committed to a career as a public defender but who could not support a modest lifestyle on the restricted salary. Career defenders deserve career salaries just like all others who devote a lifetime of work to the City and its citizens.

I live in the City, as I have for 17 years, though I commute to Baltimore, where I teach, several days per week during the academic semesters. Financially, I am better off commuting to Baltimore for work than walking to my former office in Old Town and serving the population that could benefit from my expertise. Additionally, my current work will offer several opportunities for significant salary increases at various stages in

my career. I am fortunate in that I love my work, but as with my job as a public defender, I would not be able to continue with it if there were no opportunity for financial advancement.

Through our active Hume Springs

Neighborhood Association, I heard this weekend that the City intends to remove the Community Officer position in my neighborhood. I am completely dismayed to hear this.

As a six year resident of the community and a single woman, security is very important to me. The neighborhood has transitioned from one where, when I moved in there were Bowie knives and broken bottles strewn through my hedges and incidents regularly to one where I feel safe and engaged in civic betterment, especially due to the new citizens who have been encouraged by the upswing to move into the neighborhood and participate actively.

But this does not mean that

incidents have stopped - my scooter was stolen from my fenceline last year;
I regularly find "40s" and boxes of used beer bottles in the
alley along my fence; and we call our community police officers regularly

each week to break up large groups of young men creating mayhem and/or neighbors who violate civic order. The community officers, through their regular engagement, were able to drive away the young men who used to deal drugs along my fenceline and the group who rented the house next to me and had regular poker games and cockfights. They even were able to deal with the dangerous gang one block from my house.

Comments:

If they leave now, it's

entirely too soon. Especially with the depressed housing prices, it would be easy for more unsavory individuals and gangs to move right back in. As witnessed by successful programs like the Gang Intervention Program, the City reaps immense benefits in community engagement, safety and betterment through small investments in wise programming. The Community Police Officer for Hume Springs is exactly this type of low-investment/high-yield program.

I work for the National Headquarters of the American Red Cross.

We are intimately familiar with the value of community investment and engagement. My 129 year old organization could not have achieved its national success without the relatively lean investments in growing communities throughout the nation in communities like Hume Springs.

urge you not to eliminate your investment in my community. It has come so far, and the community police officers are an essential part of building an Alexandria in which we all have pride and all have faith in high quality community investment.

Dear Mayor Euille and Council Members,

I recently heard that the

community officer position for several neighborhoods is on the chopping block due to budget cuts. I would be extremely disappointed were this to go forward. I have worked side-by-side with the Hume Springs/Lynhaven community officers over the past 5 years. Early on in my time in the neighborhood, I was subjected to threats by former neighbors, had property stolen, my car broken into, my fence graffitied and have even had to "hit the deck" during a starter pistol drive-by (someone's idea of a joke). That said, year by year, problems have been fewer and farther between. Groups of teens and 20-somethings that used to fight and hurl epithets back and forth on the playground have been replaced with kids playing for the most part, and Type 1 crime is definitely down. This all provides evidence that our community officers are making a huge difference.

Furthermore, I don't fully understand how this "cut" would

save the City the \$200K it purports. Moving our community officers to patrol would only slightly alter their job function. They already spend much of their time on patrol, primarily located in/near the community they serve.

These officers act as the point men for the area and help prevent many crimes before they happen. Moving them exclusively to patrol would cut them off from the communities where they've invested time on neighborhood contacts, learning the lay of the land, and learning names, faces, and probation officers for many offenders. When we found hundreds of malt liquor bottles where Four Mile Run Park meets the neighborhood, our community officer lead other Sector 2 patrol officers to the location.

They busted numerous offenders at that location and the public drinking and

trash problems have been driven down, but without follow-through, the fairer weather could bring the same problems back to the area.

Hume

Springs and Lynhaven have undoubtedly cleaned up their acts over the years, but that improvement is the result of our Community Officers and not in spite of them. You can look at Crime Reports and see that many of the crimes are displaced out of the residential neighborhoods, but still take place nearby. The extreme crackdown on the neighborhoods by our community officers makes our streets an undesirable place to attempt to commit crimes. We are not yet locked in as a low-crime, safe neighborhoods. Removing our conduit to the police force now could set us back years on our efforts to eradicate crime from our streets.

The Hume Springs Citizens

Association feels this is a real threat to all the progress that has been made over the years. Please don't cut the program we consider to be among the most important to our community. Our safety, whether real or perceived, should not be a line item that can be struck from the budget.

To the Mayor and Members of City Council:

The little neighborhood of Lynhaven occupies a big place in the history of the Alexandria Police Department's (APD) efforts at community outreach. The first iteration of today's Community Oriented Police Program (COPs) was piloted in Lynhaven. Some 30 years ago, Lynhaven was deeply scarred by drugs, crime and prostitution. Working together with our civic leaders, the APD was able to clean the neighborhood up. As partners, we were able to create the desirable—yet fragile—community that now sits at the northern end of Alexandria.

That partnership is now in jeopardy. In Lynhaven, and in our neighboring communities of Hume Springs and Arlandria, we are deeply concerned with the City Manager's proposed budget that cuts a COPs officer from each neighborhood.

The COPs program takes Alexandria's best patrol officers and puts them in a situation much harder than patrol. They are introduced to a neighborhood and asked to learn everything about it. Every dark corner, every troublemaker, every problem house. Our officer—Nick Ruggiero—is so much more than a face at a community meeting. He is the face of the APD in Lynhaven.

COPs officers work with their fellow police officers to issue traffic tickets, arrest drug dealers and break up domestic incidents. But those are the things you can read about in the crime statistics. What you don't read about is the tireless work Officer Ruggiero and his predecessors put in to know what's happening here. He knows everyone in the neighborhood. He knows every kid on probation. He knows their parents. He knows where they live and where they hang out. He even knows their teachers.

This intelligence doesn't come easily. He has put in months and months to build rapport and learn this information that none of his colleagues in the APD know. This intelligence is priceless. Not just for Lynhaven but for the whole City: when there's a problem out west with someone suspected to be from here, the first call they make is to Officer Ruggiero. In some cases, the relationships he builds help to steer those kids in the right direction. You don't read in the crime statistics about kids who don't get in trouble because of Nick's hard work.

The crime numbers in Lynhaven may look good to you. Much better than even this time last year. That's due in large part to the work of our COPs officers. But things aren't perfect here, and the work of the COPs program in Lynhaven is not done. There is still domestic abuse here. There are still drugs here. There are still kids getting into trouble. To cut this program now would do a great disservice to this community. Not only would crime certainly increase, but all that intelligence, all that work Officer Ruggiero and his predecessors have put in would be lost.

Some of my older friends insist their contractors use the city bags because they care about the problems throwing leaves into the street like trash causes.

Alexandria could sell its' vacuum trucks as many

other cities have. We save money by not having to buy or repair specialized equipment that sits useless for nine months. Instead you get more bang for your buck

This year, the borough discontinued its practice of vacuuming leaves raked or blown to the curbside. Instead, residents were required to bag their leaves and place the bags at curbside for Department of Public Works (DPW) pickup.Borough officials said the change was made to cut costs, better utilize the borough's workforce, provide the same services to all local residents and comply with state Department of Environmental Protection storm water regulations, which require storm drains to remain clear...the new leaf removal practice has improved the appearance of the borough. "People have called me and complimented the borough on the new leaf policy. Some who have called said they didn't want to bag their leaves at first but have said the town looks better than it ever has"

Dear Mayor Euille, Vice Mayor Donley, Members of City Council, City Manager Hartmann and Assistant City Manager Collins:

The Alexandria Council for Human Service Organizations' (ACHSO) purpose is to improve human services through cross sector collaboration to benefit the entire Alexandria community. Thus, we send this letter to convey our interest in making improvements to the City's Community Partnership Funds.

We believe the changes recommended below can enable the City and the nonprofit organizations that provide human services to Alexandria residents to better deliver needed services in our community. Decreased revenues at a time of increased needs is a plight both ACSHO member organizations, as well as the City, face. While the need for our services has grown during this time of reduced revenues, many of our organizations have drawn down on our reserve funds to increase our service delivery. Of course that trend will not be able to continue indefinitely. With funding restored at least to FY09 levels, it can have a significant payoff for our clients. Our ability to leverage private resources means our City's residents have even more benefit because of the City's investment.

The Alexandria Council for Human Services Organizations (ACHSO) recommends the following changes to the City of Alexandria's Community Partnership Funds (Community Partnership, Youth and Children's Funds):

- Restore the funding for each of the three City funds that grant funding to nonprofits to carry out needed human services in the City of Alexandria to their FY09 level. While Alexandria reduced funding for nonprofits to provide human services last year, neighbor jurisdictions Fairfax and Arlington Counties maintained level funding. The reduction last year, combined with no increases in previous years, has stressed both organizations and the services delivered, while the need for services has increased. During these especially difficult economic times, both the challenge and need for services for our vulnerable population, are at an all time high. Thus, we are asking for at least a restoration of the FY09 funding level for the Alexandria Community Partnership Funds.
- Return to the practice of funding nonprofit organizations (for whom they provide grants for City human services) for a two-year cycle. We strongly recommend this approach even if during this challenging economic climate, the City wishes to include as part of a two-year cycle, a stipulation that the grants are contingent **on**

- **each City budget year's status**. This enables an organization to do more effective planning on a two year cycle. It also would be expected that the City would ask for updates on any programmatic or budget alternations during the two year time period.
- Change (move-up) the dates of grant submissions to March 1<sup>st</sup>, and thus grant notifications to organizations by May 15<sup>th</sup> each year. Enabling nonprofit organizations to have a little more lead time on notification of grants is critical to effective planning. We suggest moving up the process so that organizations can learn of the status of their grant requests within two weeks of the City's final budget passage.

We believe these changes can mean important improvements that will make a significant difference to those who most need the human services in our City. We look forward to continuing our partnerships with the City to ensure that the most effective, efficient and critical services are delivered to our citizens.

Thank you for your attention to these important issues. We look forward to working together to make improvements to the delivery of human services in Alexandria.

It is good to see that City Manager Jim Hartman is instituting a program of "collaborative" realignment ". In private business, we would likely skip the fancy words and simply call such a program "common sense". Given the stresses on the City Budget over the last few years, one can reasonably question why such operational inefficiencies weren't addressed long ago. Regardless, it is an encouraging sign.

It would be cruel, damaging, and counterproductive to impose yet more tax increases on Alexandria homeowners and businesses as we struggle to climb out of the worst recession in recent memory. Obviously, making cuts in order to close gaps in the budget will cause a level of discomfort for the professional politicians that occupy our City government, but the Mayor and Alexandria City Council must learn to live within their means like any other American institution or individual.

Given the lack of imagination in the area of budget reductions expressed by our Mayor, I thought it would be appropriate to make a few suggestions as follows:

#### General Reform

- 1. Close City coffers to new programs. For example, the City shouldn't even consider jumping into the financial morass (easily worth tens of millions of taxpayer dollars) associated with proposed street cars.
- 2. **Transparency**. Post all financial information, contracts, invoices, etc. on the City's web site so we can see where our money is being spent. Of course, there should be some exceptions to this, such as payments associated with police investigations.
- 3. **Zero Based Budgeting**. Programs shouldn't be funded just because they exist. Start from the ground up and justify costs on an annual basis. Weed out the bad and fertilize the good.
- 4. **Litigation Board.** Create a nonpartisan board of retired judges and lawyers to review all pending and future litigation involving the City. This volunteer board should be able to veto new and settle pending litigation. Each member should voluntarily agree to abstain from running for public office for five years beginning with the end of their service to the City.
- 5. **Auditing Board.** Create a nonpartisan board of auditors, business executives and individuals who have served in local governments outside of Alexandria to review operations and budgeting. These volunteers should also foreswear running for public office in Alexandria for five years at the end of their service.
- 6. Cease using the powers of the City as political weapons. It appears that the elected leadership doesn't like business, especially if it deals with goods or services that some may consider "politically incorrect" such as fuel oil or high quality sporting weapons. After all, the elimination of one discreet, high end sporting goods store resulted in the unexpected opening of the first "adult" shop on King Street, with more to come.

#### **Specific Programs**

Here are a few items for immediate savings.

- Terminate the "Safe Haven" Program. Though created with the best of intentions, this
  controversial, misguided, multi-million dollar program designed to provide luxury
  apartments in the heart of Old Town to a dozen homeless people is a gold plated monument
  to waste. As of this date, the poorly managed, over budget program has yet to service a
  single person.
- Terminate the Sister City Program. Surely, Alexandria's tourism industry benefits much more from its location at the step of our nation's capital than association with a city an ocean away.
- 3. **Terminate the iPod/key chain giveaway.** Sure, it's only \$30,000, but how many meals could that buy for the truly needy had the city left those dollars in the hands of charitable private citizens?
- 4. **Verify that all public school students are legal residents of Alexandria**. Transfer non-residents to the appropriate school district, and fine the parents for the cost of the services provided by the City. Why should Alexandria taxpayers pay the tab for students sneaking in from other jurisdictions?
- 5. **Terminate City participation in the NVTA.** By any reasonable expectation, The Northern Virginia Transportation Authority (NVTA) has been an abject failure. Its finances were gutted as unconstitutional; its original "priority" projects met with ridicule from its closest allies as being politically motivated and ineffective; and even one of its staff members was arrested for allegedly defrauding the organization. There are better solutions for our transportation problems, beginning with cutting all support for this failure.
- 6. **Planning and Zoning.** Readers may recall that it was only a few months ago that Planning Director Faroll Hamer's arbitrary, capricious, or simply unreasonable actions in a recent land use case were overturned by the BZA. Now taxpayers deserve an answer to this question: why have staffing and other costs increased when economic activity, such as building, has declined? Replace Faroll Hamer with a professional urban planner, down size the staff and keep personal political agendas out of this office.
- 7. **Divest of land holdings and leave the Old Dominion Boat Club alone**. Instead of attacking an Alexandria institution with an unwarranted land grab, the city should focus on reducing its property holdings and improving management at existing locations.

Obviously, with a bloated budget that has grown so quickly over the past few years, there is plenty of room for additional reductions and no need to raise taxes yet again. Hopefully, the Mayor and City Council will be up to the task to make these decisions and do their jobs. Goodness knows, the taxpayers have done more than their fair share.

**Dear Council Members:** 

I write to urge the City Council to adopt pay parity for the employees of the Office of the Public Defender by budgeting salary supplements for that office. By granting supplements the City can assure that attorneys at the Public Defender's office are offered the same career opportunity as their colleagues in the Commonwealth's Attorney's Office.

I had the great honor and privilege to start my career as an attorney in that office and worked there from June 2002 through October 2008. My resignation in 2008 was based primarily on my need to earn a higher income in order to support my growing family.

The Office of the Public Defender has a stellar reputation for competent and zealous representation. I learned this quickly my first days on the job. Attorneys in that office hale from some of the best law schools in the country and are often in the top of their classes. More importantly, every one of my colleagues in the office possesses the most important quality a good attorney can possess: The sincere desire to do the very best they can for each and every client, no matter what. As a member of the defense bar, I've also had the opportunity to observe many other attorneys in practice and I can honestly say that the large majority simply don't compare to the level of practice expected from an Alexandria Public Defender. Having skilled and respected attorneys benefits our community because cases are resolved efficiently and fairly either through bargaining through a prosecutor and defender who have mutual respect for the other's experience and judgment or through resolution before the court.

When I accepted the position at the Public Defender's office, I believed I would be a career public defender. I wasn't drawn to the position to make a fortune. I chose that career because I believe we all have an obligation to work for the Greater Good. During my tenure, I got married, bought a home (a humble 2 bedroom condo), and had a child. In addition to paying back a student loan debt of over \$105,000, my wife and I also had to manage our family budget, a mortgage, and the

cost for daycare (nearly \$2700 monthly for two kids) because we both work. We now have a second child, and have outgrown our first home. It is clear to me now that I could not sustain a family while working as a defender because there limited opportunity for advancement.

When I left, I felt a tremendous loss. My colleagues in that office were and still are my closest friends. When I left, the office also lost an experienced and seasoned attorney. With over five years experience, I had handled thousands of cases. I had tried hundreds of bench trials and about a dozen jury trials. I was successful because I was able to judge the merit of each case accurately and I had gained a wealth of knowledge and experience that made me a formidable litigator. On the flipside, I also resolved cases by plea expeditiously because I knew what they were worth, and I did all I could to gain my client's trust in my skills and knowledge so that they knew they were making the right decision. Plus, I had the experience and knowledge of my colleagues to draw from whenever those resources were needed. When I left I also felt that I was letting my colleagues down. We all shared the same sincere belief that we were fighting for a worthy cause. But worse yet, my resignation caused my colleagues to shoulder a heavier burden of caseloads because they had lost a senior attorney.

I did not simply take the job to gain experience and move on. Skilled criminal defense attorneys can and do demand top dollar for their work, which puts that resource out of reach for all but the wealthiest defendants. Melinda Douglas has spent literally decades building a highly reputed office. The attorneys who are offered an opportunity to work in that office accept that opportunity knowing that they are joining a family of dedicated attorneys who sincerely believe in public interest lawyering.

The last thing I want to share is information which you are all already aware. The Office of the Public Defender is the only criminal justice agency that does not receive salary supplements. The Alexandria Office of the Commonwealth's Attorney offers supplements to their attorneys, causing inequity between their salaries and their counterparts in the Public Defender's Office. In 2008 the General Assembly passed legislation to permit localities to supplement public defender salaries. This legislation was proposed by Del. Moran and was part of the City's legislative package. The legislation makes sense and it makes sense to treat Public Defenders equally to attorneys in the Commonwealth's Office. A comparison of retention between the two offices proves it. After about 4 or so years, a defender typically will max out their salary, as I did, and may only receive a cost-of-living increase after that point. If that individual wants to own a home, or have a family, they will be forced to change career paths and leave the office. Having competent and experience attorneys working as defenders is efficient for the system and benefits the community. Experienced attorneys can handle cases more expeditiously. And they've built reputations and trust with prosecutors, judges, and clients that allows an expedient and fair outcome in each case.

The Alexandria Office of the Public Defender is a tremendous resource that deserves pay parity and I hope that the City Council will include this worthy cause in their future budget.
