On behalf of the Alexandria Human Rights Commission, I would like to encourage you to appoint incumbent Patricia Spurlock on April 27. She has been a valuable member of Commission and is currently serving as Vice Chair. Ms. Spurlock has served on hearing panels and has chaired a committee that drafted templates for City Department Heads who report annually to the Commission, so that Commissioners can analyze and compare data and spot trends year-to-year. For example, the Commission meets annually with the Chief of Police, the Fire Chief, the Sheriff and the Superintendent of Schools and is concerned with crime, hate crimes, internal investigations, recruitment, hiring and promotions, conditions at the Detention Center, and school suspensions and expulsions.
