Title

3 AN ORDINANCE to amend and reordain the 1992 Master Plan (2008 ed.) of the City of
4 Alexandria, Virginia, by adopting and incorporating therein the amendment heretofore
5 approved by city council to such master plan as Master Plan Amendment No. 2009-0001,
6 and no other amendments, and to repeal all provisions of the said master plan as may be
7 inconsistent with such amendment.

9 WHEREAS, the City Council of the City of Alexandria finds and determines that:

10
11 1. In Master Plan Amendment No. 2009-0001, the planning commission, on its own
12 motion, initiated a comprehensive amendment to the 1992 Master Plan (2008 ed.) of the City of
13 Alexandria, by adopting the Urban Forestry Master Plan as a chapter of said Master Plan.

14
15 2. The said amendment has heretofore been approved by the planning commission
16 and city council after full opportunity for comment and public hearing.

17
18 3. All requirements of law precedent to the adoption of this ordinance have been
19 complied with; now, therefore,

20
21 THE CITY COUNCIL OF ALEXANDRIA HEREBY ORDAINS:

22
23 Section 1. That the Urban Forestry Master Plan, attached hereto and incorporated
24 fully herein by reference, be, and the same hereby is, adopted as chapter of the 1992 Master Plan
25 (1998 ed.) of the City of Alexandria, Virginia.

26
27 Section 2. That all provisions of the 1992 Master Plan (2008 ed.) of the City of
28 Alexandria, Virginia, as may be inconsistent with the provisions of Section 1 of this ordinance
29 be, and same hereby are, repealed.

30
31 Section 3. That the director of planning and zoning be, and hereby is, directed to
32 record the foregoing master plan amendment, as part of 1992 Master Plan (2008 ed.) of the City
33 of Alexandria, Virginia.

34
35 Section 4. That the 1992 Master Plan (2008 ed.) of the City of Alexandria, as
36 amended by this ordinance, be, and the same hereby is, reordained as the 1992 Master Plan (2008
37 ed.) of the City of Alexandria, Virginia.

38
39 Section 5. That the city clerk shall transmit a duly certified copy of this ordinance to
40 the Clerk of the Circuit Court of the City of Alexandria, Virginia, and that the said Clerk of the
41 Circuit Court shall file same among the court records.
