I am writing to express support for the application of Grape and Bean to operate a dining facility with indoor and outdoor seating at the corner of Commonwealth Ave and East Walnut St. Grape and Bean's owners propose to operate exactly the kind of local, modestly scaled restaurant that our community wants and needs.

In the relatively short period of time since Grape and Bean's owners purchased the property, they have transformed it from a ramshackle corner store to a very attractive shop with excellent coffee, wines, ice cream, and a small range of fresh products. The shop has become a neighborhood gathering place; every time I stop by I see friends and neighbors from nearby streets. So, my concerns are:

- 1. The noise from the 32 outdoor seats on Walnut. The planning commission staff also mentioned their concern about proximity of the outdoor seating to residential uses in Section II of the application.
- 2. the fact that there is no type of noise mitigation proposed, and
- 3. the potential parking issue caused by the total of 56 seats

At a minimum, I would like the council to increase the review proposed in Section III, Item 20 of the Application. The only review proposed now is one review 6 months after the restaurant has been operational, which will be in winter, and there will be no outdoor seating at that time. I think it is important to see how things go next spring, so I think there should be a one year review. In addition, I think there should be one or two more annual reviews after that.
