MEMORANDUM

SEPTEMBER 29, 2011 DATE: TO: THE HONORAN E MAYOR AND MEMBERS OF CITY COUNCIL BRUCE JOHNSON, ACTING CITY MANAGER FROM: ORDINANCE TO ADD CODE SECTIONS NOT PREVIOUSLY INCLUDED, SUBJECT: TO CLARIFY HOW A PARKING CITATION CAN BE CONTESTED, AND TO PROVIDE A DEADLINE FOR CONTESTING A PARKING CITATION.

ISSUE: Consideration of an ordinance to:

- Amend and reordain City Code Section 3-2-353 to include code sections that were not previously included therein;
- Amend and reordain City Code Section 3-2-353 to clarify the language regarding how a parking citation can be contested and to provide a deadline for contesting a citation; and
- Amend and reordain City Code Section 3-2-354(c) to more clearly follow the authorizing statute in Code of Virginia § 58.1-3958, which allows the City to recoup certain costs associated with parking citations.

<u>RECOMMENDATION</u>: That City Council pass the proposed ordinance (Attachment 1) on first reading and schedule it for public hearing, second reading and final passage on Saturday, October 15, 2011. The proposed ordinance would modify the language of City Code Section 3-2-353 and City Code Section 3-2-354(c).

DISCUSSION: Currently, City Code Section 3-2-353 does not include language that registered owners may contest a citation by contacting the Parking Adjudication Office or provide a deadline for contesting a ticket. Furthermore, it does not explicitly state that certain citations issued under the City Code can be contested by the registered owner of a motor vehicle. The modifications being proposed to City Code Section 3-2-353 would provide the foregoing.

City Code Section 3-2-354(c) does not reflect as clearly as it could the language that allows the City to collect payments of administrative costs for delinquent taxes or other delinquent charges, such as parking citations, as provided by Code of Virginia § 58.1-3958. The proposed language would clarify this provision.

These amendments will have no effect on City revenues but will introduce the new policy to provide a deadline for contesting a citation.

FISCAL IMPACT: This will have no financial impact.

AN ORDINANCE to amend and reordain Section 3-2-353 (CONTESTED PARKING CITATIONS) and Section 3-2-354 (PENALTIES FOR UNCONTESTED CITATIONS) of Article S (PAYMENT, CONTEST AND ENFORCEMENT OF PARKING CITATIONS) of Chapter 2 (TAXATION) of Title 3 (FINANCE, TAXATION AND PROCUREMENT) of the Code of the City of Alexandria, Virginia, 1981, as amended.

THE CITY COUNCIL OF ALEXANDRIA HEREBY ORDAINS:

Section 1. That Section 3-2-353 of the Code of the City of Alexandria, Virginia, 1981, as amended, be, and the same hereby is, amended and reordained to read as follows:

Sec. 3-2-353 Contested parking citations.

The registered owner of any motor vehicle receiving a parking citation issued for a violation of the provisions of sections <u>3-2-336</u>, 5-8-72, 5-8-114, 9-12-162 through 9-12-164, <u>10-3-1242</u>, <u>10-4-1</u> through 104-18, 10-4-22 through 10-4-25, 10-4-28, 10-4-30, 10-4-33, <u>10-4-34</u>, 10-4-39 through 10-4-412, <u>10-4-44</u> of this code who wishes to contest the same may do so, <u>by</u> <u>contacting the parking adjudication office or</u> by executing on an appropriate form provided by the director of finance, an affidavit of his intent to contest the citation <u>in court</u>. The director of finance shall certify the same in writing on an appropriate form to the general district court or, in the case of a juvenile, the juvenile and domestic relations court. <u>The registered owner must</u> contest the ticket within 10 calendar days of the issuance of the parking citation.

Section 2. That Section 3-2-354 of the Code of the City of Alexandria, Virginia, 1981, as amended, be, and the same hereby is, amended and reordained to read as follows:

Sec. 3-2-354 Penalties for uncontested citations.

Any other provisions of this code to the contrary notwithstanding, the penalty for any of the following violations of this code shall, when the citation which was issued for the violation is uncontested, be as follows:

(a) If a payment is tendered to the director of finance within 30 calendar days from the date the citation was issued:

(1) \$40 for a violation of section 10-4-1, "Stopping contrary to directions of police officers;"

(2) \$40 for a violation of section 10-4-2, "Permitting vehicle to remain parked contrary to the directions of an official sign;"

(b) If payment is not tendered to the director of finance with 30 calendar days of the date the citation is issued, a penalty of \$25 in addition to the penalty imposed by subsection (a) for the violation for which the citation was issued; provided, that, in the event the 30th calendar day from the date the citation is issued is a Saturday, Sunday or legal holiday, such additional penalty shall not be imposed if payment is tendered in the amount required by subsection (a) on the next succeeding business day; provided further, that if payment is remitted to the director of finance in a sealed envelope bearing a postmark on or before midnight of the 30th calendar day from the date the citation is issued, no such additional penalty shall be imposed; and provided further, that the director of finance may waive such additional penalty, even though payment has not been tendered or mailed within 30 calendar days of the date the citation was issued, whenever the owner of the vehicle identified in the citation establishes any of the following to the satisfaction of the director:

(i) that the owner did not find the citation at the time of its issuance on the owner's vehicle and only learned of the citation after the day on which it was issued, and has tendered the required payment with 30 days of first learning of the citation;

(ii) that, within 30 days after the issuance of the citation or, if later, after first learning of the citation, the owner has made a written request to the director for information concerning the citation, and has tendered the required payment within 30 days of the director's response; or

(iii) that the owner was medically incapable of making the required payment within 30 calendar days of the date the citation was issued.

(c) In addition to the fees and charges imposed pursuant to subsections (a) and (b) hereof, upon collection the director of finance shall impose on each person chargeable with a delinquent parking citation fees to cover the administrative costs and reasonable attorney's or

<u>collection agency fees actually contracted for.</u> The attorney's or collection agency's fees shall <u>not exceed a fee of 20 percent of charges collected</u>. The <u>administrative costsfee</u> shall not exceed \$30 for any amount collected subsequent to 30 days or more after notice of a delinquent parking citation is provided by the director of finance but prior to taking judgment and shall not exceed \$35 for any amount collected subsequent to judgment.

Section 3. That this ordinance shall become effective upon the date and at the time of its final passage.
