CONSIDERATION OF THE REPORT OF THE CITY COUNCIL NAMING COMMITTEE ON THE PROPOSED NAMING OF THE ALEXANDRIA ADULT DETENTION CENTER IN HONOR OF THE

LATE DEPUTY SHERIFF WILLIAM TRUESDALE

<u>ISSUE</u>: City Council consideration of the City Council Naming Committee's recommendation on the proposal by Sheriff Dana Lawhorne to name the Alexandria Adult Detention Center in honor of the late Deputy Sheriff William Truesdale.

RECOMMENDATION: That Council receive the Naming Committee's recommendation and schedule the proposal to name the Alexandria Adult Detention Center in honor of the late Deputy Sheriff William Truesdale, who was killed in the line of duty in 1981, for public hearing and consideration on Saturday, November 13.

<u>DISCUSSION</u>: On January 27, 1981, Alexandria Deputy Sheriff William Truesdale, 47, was killed by inmate Wilbert Lee Evans when Deputy Sheriff Truesdale was transporting three inmates from the detention center to the Alexandria Courthouse (Attachment 1). Deputy Truesdale is the first and only member of the Alexandria Sheriff's Office to be killed in the line of duty.

Sheriff Lawhorne has requested that Council name the Alexandria Adult Detention Center, located at 2001 Mill Road, in honor of the late Deputy Sheriff William Truesdale.

In 1985, City Council passed a resolution honoring the late Deputy Sheriff Truesdale. During the dedication and opening of the detention center in 1987, a short entrance roadway adjacent to the center was named Truesdale Drive. The Sheriff has asked that Council consider the naming of the detention center in honor of the late Deputy Sheriff Truesdale in order to acknowledge the ultimate sacrifice made by the only deputy sheriff in the history of the office to be killed in the line of duty. The naming of the detention center also would be an important recognition of the danger deputy sheriffs face on a daily basis in the course of their work in the detention center, the courthouse and in the community.

The City Council Naming Committee (Councilwoman Pepper, Councilman Fannon and City Manager James Hartmann) considered this request at its meeting on October 15. The committee voted to recommend that the proposal to name the Alexandria Detention Center after the late Deputy Sheriff William Truesdale be presented to City Council at its October 26 legislative meeting, set for public hearing and consideration on Saturday, November 13. The Committee recommended that Council approve naming the facility in honor of the late Deputy Sheriff William Truesdale.

Deputy Truesdale was shot and killed with his own weapon while transporting prisoners from court back to the jall. One of the prisoners overpowered Deputy Truesdale and shot him with his own weapon. The suspect then shot his handcuffs off and attempted to flee but was Immediately apprehended.

The suspect was sentenced to death in April 1981 and executed on October 17, 1990.

Deputy Truesdale was survived by his wife and three children.

Honoring the Fallen

New plaque at City Hall honors sheriff's deputies who have died in the line of duty.

Nobody involved in the deadly jailbreak will forget what happened that chilly January day in 1981, when a 40-year-old inmate from North Carolina grabbed a deputy sheriff's service revolver and began shooting. Two hours later, 47-year-old Sheriff's Deputy William Truesdale was dead after being shot once in the chest with his own Model 64 Smith and Wesson .38-calibur revolver. Truesdale was the first and only Alexandria Sheriff's Deputy to die in the line of duty.

"His death is a sharp reminder that on every level, we the citizens employ a group of people who daily take chances in order to protect us," the *Alexandria Port Packet* editorialized at the time.

Flash forward a generation later. Alexandria Sheriff's Association Vice President Monique Edwards was walking through a vestibule at the south entrance of City Hall when she noticed something missing. There was an elaborate plaque on the west side of the door marking the names of firefighters who died in the line of duty. And then she noticed another plaque honoring police officers who died in the line of duty on the east side of the vestibule. But nothing honoring sheriff's deputies who have given the last full measure of devotion — Truesdale and future deputies.

"Of course, we don't want anyone to be killed in the line of duty," said Edwards, who's worked in the Sheriff's Office since 1993. "But if that happens, we should be ready to honor them in the same way that firefighters and police officers are honored."

So she and the Alexandria Sheriff's Association went to work, starting a yearlong process of adding a new plaque to the south entrance of City Hall. She worked with the city manager's office and General Services, moving the process from concept to design and finally installation. This week, city officials gathered at City Hall for an official unveiling.

"It reminds us that there's a thin line between order and chaos," said Sheriff Dana Lawhorne, glancing at the names of police officers who died in the line of duty. "These are people who have made the ultimate sacrifice so that we could live in a free society, so it's appropriate that they are honored here at City Hall."

Dear Mayor Euille,

The Del Ray Citizens Association (DRCA) Land Use Committee and Executive Board discussed this SUP application, a request to operate a restaurant with a parking reduction at their monthly meetings in October.

The applicant is requesting restaurant hours generally consistent with the hours of other restaurants on Mt. Vernon Avenue. The applicant will have 82 indoor seats and 66 outdoor seats.

The property has four dedicated spaces in the parking garage and the applicant requires a parking reduction of 21 spaces. There are 34 marked spaces on the street along Mt. Vernon and Commonwealth Avenues bordering the property. Residential apartments located above the property have adequate reserved parking in the parking garage.

The general consensus of the DRCA Land Use Committee and Executive Board was that there is adequate on-street parking for the restaurant provided that the parking is zoned. The zoned parking should not impact the residences since each unit has assigned parking in the garage. The applicant applied for 2-hour zoned parking in front of the property and a loading zone from 8:00 AM to 11:00 AM. The applicant's request was discussed at the October Traffic and Parking Board hearing.

At the November membership meeting the DRCA members voted to support the application including conditions relating to zoned parking for which the applicant has already applied.
