Colleen,

The Safeway store achitect Lee Quill and I met and discussed the sidewalk and planting strip along Braddock Road. The preference of my wife and I would be that the additional 2 feet be added to the planting strip rather than to the sidewalk. As people who walk to the store and to Bradlee and adjacent bus stops most days (we don't own a car), we are intimately aware of the experience of the residents, school kids, and others who walk down this segment of Braddock Road. We feel that the additional buffer between the sidewalk and the street is what is most needed - both for pedestrian comfort and to provide space for trees to actually grow and thrive. If you look at the existing trees along the narrow strip, you will see that most are stunted and cannot grow very well. While a slightly wider sidewalk may be desirable, given the trade-off of adding either to the existing 6' sidewalk or adding to the 3.5' planting strip, we would choose adding to the planting strip as the sidewalk is fairly adequate in width.

Overall my wife and I support the Safeway plan, but would like the Braddock Road planting strip widened to make this a more pleasant place for pedestrians to walk and to provide an adequate width for shade trees to grow, further enhancing the sense of safety and overall attractiveness of the corridor.

Thank you for writing to let us know about your interests and concerns regarding the proposed project at the Mt. Vernon Village Center site. I will say that all of the City staff working on this project had sincerely hoped to get to public hearing in November, as had the applicant, and we share your disappointment at the delay. Everyone involved worked very hard to try to make the date, however, as the November hearing deadlines approached, there were some remaining loose ends and, to quote the applicant, the project wasn't fully "baked."

As you noted, one of the outstanding items was finalizing the affordable housing plan, however, providing the units on-site was not a requirement from the City, but a choice made by the applicant. Prior to the public meeting on October 5, 2011, the applicant planned to provide a voluntary financial contribution to the affordable housing program at the full amount per the guidelines established by the Developer's Housing Contribution Policy Work Group (DHCPWG) and adopted by The Alexandria City Council on June 14, 2005. As a separate part of their application, they were requesting additional height for the central portion of the building through a Master Plan Amendment. After hearing the concerns of the community, they have opted to request a <u>provision</u> in the City's Zoning Ordinance that allows an additional height request through a contribution of on-site affordable units.

Section 7-700 of the Zoning Ordinance can only be used with the provision of affordable housing. Therefore, this change in approach makes the inclusion of affordable housing in this instance mandatory. The commonly used formula calls for one-third of the square footage made possible by the bonus to be provided as affordable housing. Depending on the actual square footage of the units, this would produce 23 - 24 affordable units; the additional 4 - 5 are being provided in lieu of the voluntary cash contribution on the non-bonus units.

Housing staff has researched your reference to a "cry from Council not so long ago when considering the Wesley apartment project, that those would be the last income restricted units placed in Arlandria." A review of the audiotape from the June 28, 2005 Council meeting where a City loan to Wesley Housing for the Beverly Park Apartments was approved included discussion related to the level of affordable rental housing in the area but did not reveal any promise.

The Mt. Vernon Village development is projected to have approximately 479 rental units; in staff's view, the inclusion of 28 reduced-rent units scattered through the property will not change the market rate nature of the project or its anticipated positive impact on the community. The inclusion of the affordable units is an important community benefit in light of the actual and anticipated losses in affordable housing the City is experiencing due to market forces and redevelopment pressures. With regard to securing such units elsewhere in the City, all of the currently approved but not yet completed bonus density projects with affordable housing are located in other areas of the City: Lane Condominiums (32 affordable condo or 38 affordable rental units); Hoffman Blocks 11 and 12 (55 affordable rental units) and Carlyle Block O (6 affordable rental units) in Eisenhower East; and Stevenson Avenue (9 affordable rental or condo units) in the Landmark Van Dorn

The City has a long-standing commitment to maintaining affordable housing options in Arlandria, as well as to provide support to all of the community members and businesses. This site, along with the Birchmere site and the old Safeway site, was for identified for redevelopment with the approval of the 1992 <u>Potomac West Plan</u>, and again with the 2003 <u>Arlandria Neighborhood Plan</u>. One of the major benefits of focusing on these particular properties was the opportunity to transform large surface parking lots using infill development, with no loss of existing housing.

As you know, in December 2009, the City Council approved the creation of the Arlandria Advisory Group, a community-based stakeholder group, which has the sole purpose of working with City staff on the implementation of the Arlandria Neighborhood Plan. Sue Hernandez, from Tenants and Workers United, is one of our members, and has attended many of the meetings. The group has had seven meetings, including a developer forum, to discuss neighborhood revitalization. The Chirilagua Co-Op, Presidential Greens, ANHSI, the Wesley Housing Development Corporation, St. Rita's, and ARHA are all members of the group and receive regular updates. We have also worked closely with the Arlandria Service Providers organization, which includes Community Lodgings, Casa Chirilagua, CFNC, and the Four Mile Run Farmers Market. The City has also been working closely with the Alexandria Economic Development Partnership (AEDP) to help to form the Arlandria Chirilagua Business Association.

As you noted, we held a community meeting at the Four Mile Run Community Center (former Duron building) on October 6th. The meeting was advertised through the Arlandria Advisory Group, the City website, e-News and the Arlandria Service Providers. The had about sixty Arlandria residents in attendance, which is a good number for a City meeting. Based in part on the concerns raised at the meeting, the applicants postponed their scheduled hearing on the project by one month (from November to December) and have revised their proposal. They have opted to provide 28 on-site units affordable at 60% of the Area Median Income (AMI) for 30 years. This represents approximately 6 % of the units in the entire project.

Small group meetings have also been held with the North Ridge Civic Association and the Chirilagua Co-Op. City staff and the applicant are also available to meet with your constituents, if you think they would find it helpful. Also, at the request of Ms. Hernandez, staff made a plan set of the full application available on October 6^{th} , which has not yet been picked up.

In response to requests about additional information, I am putting together a FAQ list for this project, based on questions that you, and other community members, have asked, and I will forward the link to you as soon as it is ready. Please feel free to follow up with a phone call or email if you would like further information, or need

clarification on any of the information. You also mentioned that many people have approached you with questions; please pass along my name and contact information with them, as well as this email.

A maximum of three minutes will be allowed for your presentation, except that one officer or other designated member speaking on behalf of each *bona fide* neighborhood civic association or unit owners' association desiring to be heard on a docket item shall be allowed five minutes. In order to obtain five minutes, you must identify yourself as a designated speaker, and identify the neighborhood civic association or unit owners' association you represent, at the start of your presentation. If you have a prepared statement, please leave a copy with the Clerk.

Additional time not to exceed 15 minutes may be obtained with the consent of the majority of the council present; provided notice requesting additional time with reasons stated is filed with the City Clerk in writing before 5:00 p.m. of the day preceding the meeting.

The public normally may speak on docket items only at public hearing meetings, and not at regular legislative meetings. Public hearing meetings are usually held on the Saturday following the second Tuesday in each month; regular legislative meetings on the second and fourth Tuesdays in each month. The rule with respect to when a person may speak to a docket item at a legislative meeting can be waived by a majority vote of council members present but such a waiver is not normal practice. When a speaker is recognized, the rules of procedures for speakers at public hearing meetings shall apply. If an item is docketed *for public hearing* at a regular legislative meeting, the public may speak to that item, and the rules of procedures for speakers at public hearing meetings.
