- (89) One member representing the Alexandria Branch of the NAACPa community organization with specific outreach to the African-American community;
- (910) <u>TwoOne at-large members</u> from and representing the <u>youth of the City of</u> Alexandria <u>Youth Council</u>;
- (1011) One member from and representing the Alexandria Interfaith Council; and
- (1112) Two citizens-at-large-;
- (13) One representative of the Alexandria business community; and
- (14) One representative from and representing the parents of youth of the City of Alexandria.

(The remaining sections are unchanged)

Section 2. That this ordinance shall become effective upon the date and at the time of its final passage.
