THE CITY COUNCIL OF ALEXANDRIA HEREBY ORDAINS:

(The following is all new language)

Section 1. That Section 2-4-180, Article W, Chapter 4 of Title 2 of the Code of the City of Alexandria, Virginia, 1981, as amended, be, and the same hereby is, amended and reordained by the addition of the following new article and sections to read as follows:

ARTICLE W – ALEXANDRIA GANG PREVENTION COMMUNITY TASK FORCE

Sec. 2-4-180 Creation, composition and organization.

(a) There is hereby established a task force known as the Alexandria Gang Prevention Community Task Force ("Task Force").

(b) The Task Force shall consist of 137 members to be appointed by the city council. The composition of the commission shall be as follows:

- (1) Two members from the city council;
- (2) One member from the Alexandria School Board;
- (3) The City Manager or his designee;
- ~~(34)~~ One member from and representing TC Williams High School;
- ~~(45)~~ One member from and representing Alexandria City Middle Schools;
- ~~(56)~~ One member from and representing Alexandria City Elementary Schools;
- ~~(67)~~ One member from and representing private schools in Alexandria;
- ~~(78)~~ One member from and representing the Alexandria Tenant and Workers Support Committee community organization with specific outreach to the Latino community;
- ~~(89)~~ One member representing the Alexandria Branch of the NAACP a community organization with specific outreach to the African-American community;
- ~~(910)~~ Two One at-large members from and representing the youth of the City of Alexandria Youth Council;
- ~~(1011)~~ One member from and representing the Alexandria Interfaith Council; ~~and~~
- ~~(1112)~~ Two citizens-at-large;
- (13) One representative of the Alexandria business community; and
- (14) One representative from and representing the parents of youth of the City of Alexandria.

- (~~9~~10) ~~Two~~ One at-large members from and representing the youth of the City of Alexandria Youth Council;
- (~~10~~11) One member from and representing the Alexandria Interfaith Council; ~~and~~
- (~~11~~12) Two citizens-at-large;
- (13) One representative of the Alexandria business community; and
- (14) One representative from and representing the parents of youth of the City of Alexandria.

Section 2. That this ordinance shall become effective upon the date and at the time of its final passage.
