*WHEREAS, Councilmember Lovain serves on the City's American Recovery and Reinvestment Act Committee and before serving on Council served as chair and member of the Alexandria Budget and Fiscal Affairs Advisory Committee; and*

*WHEREAS, he has been active in the non-profit and volunteer community serving as Deputy Chair of the Alexandria United Way Campaign, as a member of the Alexandria United Way Regional Council and as a board member of the Alexandria Volunteer Bureau; and*

*WHEREAS, Councilmember Lovain has been a strong advocate of public transportation and has sought to have street cars become a vital part of the City's transportation network; and*

*WHEREAS, he introduced a proposal for the City's state legislative package to ban the use of plastic bags in grocery stores and has worked hard on public education on the environmental concerns about the continued use of plastic bags; and*

*WHEREAS, he has been a strong advocate for the City's youth and has encouraged the development and expansion of mentoring and school drop-out prevention efforts; and*

*WHEREAS, the Alexandria City Council wishes to recognize Councilmember Lovain for his service to the City and the region;*
