REQUEST TO VACATE TWO POSITIONS ON THE ALEXANDRIA

COMMISSION ON HIV/AIDS

<u>ISSUE</u>: Request from the Chair of the Alexandria Commission on HIV/AIDS to vacate two positions on the Alexandria Commission on HIV/AIDS (Attachment).

RECOMMENDATION: That City Council declare as vacant one of the citizen positions and the position for a representative of the Alexandria Chapter of the American Red Cross and authorize the City Clerk to advertise the vacancy.

<u>DISCUSSION</u>: Section 2-4-7(i)(1) of the City Code requires all board and commission members to attend at least 75 percent of the yearly meetings of the bodies on which they serve, and authorizes City Council to vacate any position if Council determines that a member has missed a sufficient number of meetings such that the 75 percent attendance requirement cannot be met.

The Alexandria Commission on HIV/AIDS will meet 10 times this fiscal year. Tom Suydam, Chair of the Commission, has requested that Isaac Green be removed from the Commission because Mr. Green has attended only one meeting since he was appointed in June 2010 and efforts to reach him by phone and e-mail have been unsuccessful. Melissa Arons has not attended a meeting this fiscal year (four meetings) and outreach efforts to encourage her to attend the Commission meetings have also been unsuccessful. Therefore, I recommend that Council vacate these positions and authorize the City Clerk to advertise the vacancies.

Rose, I would appreciate your help in removing two Commissioners from our rolls.
