- > THIS RECOMMENDATION IS IN DIRECT RESPONSE TO THE
CITY'S STRATEGIC PLAN WHICH CALLS FOR "A PROACTIVE
HEALTH PROGRAM TO REDUCE RESPIRATORY ILLNESS BY
REDUCING EXPOSURE TO SECOND HAND SMOKE."
- > THE COMMISSION'S PRIMARY OBJECTIVE IN MAKING THIS
RECOMMENDATION IS TO REDUCE THE LEVEL OF EXPOSURE
TO SECOND HAND SMOKE OF OUR CHILDREN, YOUTH AND
NON-SMOKING ADULT POPULATION.
- > WE KNOW THAT THERE IS A LOT OF MYTHOLOGY AND
MISINFORMATION OUT THERE ABOUT SHS, AND WE BELIEVE
THESE SIGNS WILL MAKE AN IMPORTANT CONTRIBUTION IN
EDUCATING SMOKERS AND NON-SMOKERS AWARE ABOUT
THE DANGERS OF SHS.

- > IN ISSUING A GROUNDBREAKING REPORT ON SHS IN 2002,
THEN SURGEON GENERAL OF THE US RICHARD CARMONA STATED
" THE DEBATE IS OVER. THE SCIENCE IS CLEAR:
SECOND HAND SMOKE IS NOT A MERE ANNOYANCE, BUT A
SERIOUS HEALTH HAZARD THAT CAUSES PREMATURE DEATH
AND DISEASE IN CHILDREN AND NON-SMOKING ADULTS "
- > THE SURGEON GENERAL FOUND THAT SHS IS A PREVEN CAUSE
OF LUNG CANCER, HEART DISEASE, SERIOUS RESPIRATORY
ILLNESSES SUCH AS BRONCHITIS & ASTHMA, LOW BIRTH WEIGHT
AND SUDDEN INFANT DEATH SYNDROME.
- > THE CURRENT SURGEON GENERAL RECENTLY DECLARED:
" THERE IS NO RISK FREE LEVEL OF EXPOSURE TO SHS.
EVEN SMALL AMOUNTS OF SHS EXPOSURE CAN BE
HARMFUL TO PEOPLE'S HEALTH."
