SUBJECT: RESOLUTION REAFFIRMING THE CITY OF ALEXANDRIA'S
SUPPORT OF THE VIRGINIA COOPERATIVE EXTENSION SERVICE

ISSUE: Resolution reaffirming the City of Alexandria's support of the Virginia Cooperative Extension Service.

RECOMMENDATION: That the City Council adopt the resolution.

DISCUSSION: The Commonwealth of Virginia reduced the Virginia Cooperative Extension Service's (VCE) budget by \$1.1 million in fiscal year 2011 and \$5.5 million the following year. VCE is in the midst of a strategic reorganization and part of that reorganization includes the consolidation of extension offices in Northern Virginia, including the Arlington and Alexandria extension offices. VCE offers community-based programming in partnership with RPCA in City recreation centers, schools and other venues. State budget reductions have resulted in the elimination of some positions and programs in FY 2011. RPCA staff is working primarily with Arlington County's Extension Office to consolidate offices and programs with the goal of continuing to provide community-based programs focused on current and emerging needs. The attached resolution is aimed at expressing the City's support of VCE to Virginia Tech (which operates VCE) and to State leaders.

FISCAL IMPACT: Statewide for VCE, the budget impact is a negative \$1.1 million in FY 2011 and a negative \$5.5 million impact in FY 2012.


