THE SPECIAL STATUTORY FUNDING PROGRAM FOR TYPE 1
DIABETES RESEARCH

ISSUE: Resolution memorializing Congress to renew funding for the special statutory funding program for Type 1 diabetes research.

RECOMMENDATION: That Council approve the attached resolution and authorize the mayor to forward the resolution to the City's congressional delegation.

DISCUSSION: The Public Health Service Act is a federal law which authorizes funding for a number of public health programs, including the Special Diabetes Program. This program sponsors researchers who are seeking a cure for juvenile diabetes, which affects as many as three million Americans. It was begun in 1997, and its current funding authorization expires this year.

Councilman Krupicka has asked that Council approve the attached resolution, which urges Congress to renew the funding and authorization for the Special Diabetes Program.

BACKGROUND: Legislation reauthorizing the Special Diabetes Program (H.R. 3668, and S. 3058) was introduced in the 111th (current) Congress. Although this legislation has strong support in both bodies, it has not made it to the floor of either house.

Congress has not yet passed any bills appropriating funds for FY 2011. Although it is unlikely that either of the stand-alone bills listed above will be enacted in the few days remaining in this Congress, it is possible that the Program's reauthorization could be included in an Omnibus Appropriations bill, if one is passed.



NOW, THEREFORE, BE IT RESOLVED, by the Alexandria City Council that it


