Frank, as you well know, has done an extraordinary job on behalf of his neighborhood and the larger community particularly in regard to the Group Home issue and Burke Library. However we have just been informed that Frank is now withdrawing his application for Planning Commission and will seek appointment to the Board of Zoning Appeals. Again SHA supports Frank in his efforts to be appointed to the BZA. His familiarity with issues in the West End, his skill as a lawyer and as one who can find a creative solution to seemingly intractable issues, and his proven willingness to do the necessary homework underscores his ability to perform well on the BZA.
