In follow up to a question from Mayor Donley at a budget work session, the following information is provided about the City's financial support of regional, state and national governmental planning and advocacy organizations. This listing excludes service delivery regional organizations such as the Northern Virginia Regional Park Authority, as well as professional organizations such as the American Planning Association.

### National League of Cities
