DISTRICT

<u>Issue</u>: Adoption of an ordinance to establish the Ladrey Senior Building Election District in replacement of the United Way of America Election District.

Recommendation: That city council adopt the ordinance.

<u>Discussion</u>: In June 2000, the City established the United Way of America Election District, and designated the United Way of America Building, at 701 North Fairfax Street, as the voting place for the precinct. The United Way has indicated to the Electoral Board that the organization no longer wishes to make their building available as voting place.

Accordingly, the Electoral Board has arranged with ARHA to utilize the Community Room in the Ladrey Senior Building, at 300 Wythe Street, as a voting place for this precinct, and has requested that City Council approve and implement this change.

The proposed ordinance accomplishes the change. No change is made to the existing boundaries of the election district. However, in accordance with the practice of naming the election districts after the associated voting place, the name of the district is changed to the Ladrey Senior Building Election District.

Summary

The proposed ordinance changes the voting place within the United Way Election District from the United Way Building, located at 701 North Fairfax Street, to the Ladrey Senior Building, located at 300 Wythe Street. No change is made to the existing boundaries of the election district. However, in accordance with the practice of naming the election districts after the associated voting place, the name of the district is changed to the Ladrey Senior Building Election District.

AN ORDINANCE to amend and reordain subsection (a) (UNITED WAY OF AMERICA ELECTION DISTRICT) of Section 2-2-10 (ESTABLISHMENT OF ELECTION DISTRICTS AND VOTING PLACES), and to amend and reordain "The Official Map of the City of Alexandria, Virginia, Designating Election Districts and Voting Places," adopted by Section 2-2-13 (MAP OF ELECTION DISTRICTS AND VOTING PLACES), all of Chapter 2 (ELECTIONS), Title 2 (GENERAL GOVERNMENT) of The Code of the City of Alexandria, Virginia, 1981, as amended.

THE CITY COUNCIL OF ALEXANDRIA HEREBY ORDAINS:

Section 1. That Subsection (a) of Section 2-2-10 of The Code of the City of Alexandria, Virginia, 1981, as amended, be, and the same hereby is, amended and reordained to read as follows:

(a) The United Way of America Ladrey Senior Building Election District shall be bounded and described by the census blocks shown on the map adopted by section 2-2-13 of this code as comprising the said district.

The voting place within the United Way of America Ladrey Senior Building Election District shall be at the United Way of America Building, located at 701 North Fairfax Street Ladrey Senior Building, located at 300 Wythe Street.

Section 2. That "The Official Map of the City of Alexandria, Virginia, Designating Election Districts and Voting Places," adopted by Section 2-2-13 of the Code of the City of Alexandria, Virginia, 1981, as amended, be, and the same hereby is, amended and reordained as shown on Exhibit 1, attached hereto and incorporated fully by reference, to reflect the designation and description of the Ladrey Senior Building Election District, in replacement of the of the United Way of America Election District.

Section 3. That the general registrar of voters be, and he hereby is, directed to record the foregoing amendments on the said map.

Section 4. That this ordinance shall become effective upon the date and at the time of its final passage; provided, however, that the changes in the Election District names and voting places herein made shall not be implemented until the changes are first submitted to the Attorney General of the United States and no objection is interposed within 60 days of the submission, as required pursuant to Section 5 of the Voting Rights Act of 1965, as amended.

Section 3. That the general registrar of voters be, and he hereby is, directed to record the foregoing amendments on the said map.

Section 4. That this ordinance shall become effective upon the date and at the time of its final passage; provided, however, that the changes in the Election District names and voting places herein made shall not be implemented until the changes are first submitted to the Attorney General of the United States and no objection is interposed within 60 days of the submission, as required pursuant to Section 5 of the Voting Rights Act of 1965, as amended.
