Dear Mayor and Council Members:

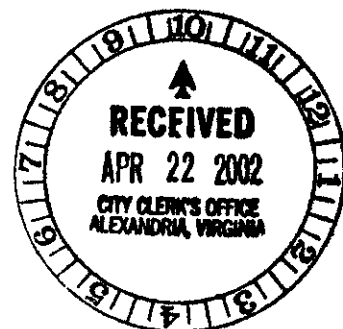
