SUBJECT:

TRANSFER RESOLUTION - FY 2003 OPERATING BUDGET

ISSUE: Transfer Resolution - FY 2003 General Fund Operating Budget.

RECOMMENDATION: That City Council adopt this resolution which adjusts the various departmental accounts to projected final expenditure patterns.

DISCUSSION: In accordance with § 5.07 of the City Charter, at the end of each fiscal year, staff submits a resolution to Council to transfer appropriations to adjust the various departmental accounts according to projected final expenditure patterns. The transfers, in the amount of \$2,520,782, are required to accomplish the following:

To adjust various departmental accounts, in the aggregate amount of \$2,020,782 for the following: to transfer funding to the Office of the Sheriff's budget for expenditures related to the sniper incident as well as security at the Alexandria Public Safety Center (\$1,000,000). Some of these security expenditures may be reimbursed by the Federal Government if the City's proposed grant application (docket item #13) is approved. To transfer funding to the Department of General Services budget for expenditures associated with overtime for snow removal during the winter of calendar year 2003, and higher than budgeted expenditures associated with fuel and parking management costs (\$300,000); to transfer funding to the Fire Department (due to retirements and turnover) for the approved overhire of twelve fire suppression personnel and eight emergency rescue technicians (\$500,000); to transfer funding to the Finance Department budget for the transfer of a Pension Administrator position and related non-personnel costs from the Personnel Department (\$80,000); to transfer funding to Information Technology Services from the Accounting Division of the Finance Department for the Clerk Typist position responsible for the billing component of the City's telecommunication system (\$35,811); to transfer to the Office of Human Rights the Affirmative Action Officer position and related non-personnel costs from the Office of the City Manager (\$84,045); to transfer funding to the Office of Human Rights for office space rental costs from the Office on Women (\$3,926); and to transfer funding from Non-Departmental to the Alternative Community Service Program more appropriately located in the Other Public Safety and

Justice Activities account to establish budget authority in a more appropriate account (\$17,000).

To transfer budget authority for City legal expenses budgeted in a non-departmental account, in the amount of \$500,000 for the use of outside attorneys for special legal work, which, for administrative purposes (such as monitoring billable hours) are charged against the budget for the City Attorney's Office.

FISCAL IMPACT: The resolution balances operating budget accounts by transferring approved appropriations. There is no net change in total budgeted expenditures as a result of the transfers included in this resolution.
