SUBJECT: CONSIDERATION OF CLOSING EAST MASONIC VIEW AVENUE AT
BRADDOCK ROAD TO MOTOR VEHICLES

ISSUE: City Council consideration of closing a 40-foot section of East Masonic View Avenue between Braddock Road and Little Street.

RECOMMENDATION: That City Council approve the closing of East Masonic View Avenue at Braddock Road.

BACKGROUND: Staff has worked with residents of the Braddock Road area between Mount Vernon and Commonwealth Avenues since November 2002 to develop a traffic calming plan for Braddock Road. This plan includes the construction of sidewalks on sections presently lacking them, and bulb-outs, lane narrowing, removal of parking, side street closure and the formation of a chicane using an alternating parking pattern.

Due to the addition of 5' wide segments of sidewalk on the north side of the street, parking on adjacent segments on the south side of the street will need to be removed. This is due to the right-of-way restrictions on Braddock Road. The donation of private property on the north side of the street where sidewalks are needed was considered, however, deemed not feasible due to the costs of moving utility poles and constructing retaining walls for some of the properties with steep front yards.

This plan, contingent upon City Council's approval of the closure of East Masonic View Avenue, was approved at the April 26 Traffic & Parking Board meeting. Additionally, the Del Ray and Rosemont Citizens Associations have approved of this plan.

DISCUSSION: The primary purposes for closing East Masonic View Avenue at Braddock Road are to reduce the amount of intersection area that must be crossed by pedestrians and to provide additional parking on a street where parking will be removed. The removal of parking is necessary in order to construct a sidewalk, as the lanes must be shifted southward by 5' to accommodate it. The sidewalk will provide safe walking facilities for residents of 21 homes and users of the nearby Braddock Road Metrorail station while the parking removal will affect two property owners. Presently, many walk between parked cars on the street to reach the Metrorail station.

The two property owners on the south side of Braddock Road, which will be affected by the parking removal, expressed their concern to staff. One property owner, the Church of Christ, has a parking lot with ten spaces and on-street parking on two of its three sides. Its members use the on-street parking on Braddock Road on Sunday mornings. The other property owner, a private residence, has a driveway and an additional curb cut.

The closing of East Masonic View Avenue at Braddock Road would replace 10 of the 17 parking spaces that would be removed on the south side of Braddock Road between Wayne and Ramsey Streets under the traffic calming plan. Residents on East Masonic View Avenue and Little Street would still be able to access their homes via Little Street. (See attachments.)

Benefits of the street closure include improving pedestrian safety with the addition of a sidewalk and the removal of a confusing “V”-shaped intersection. Presently, motorists tend to run the stop sign at the East Masonic View Avenue/Braddock Road intersection and residents also have shared stories with staff of teenagers driving circles around the island. A few neighbors on Myrtle and Spring Streets have expressed concern that by closing East Masonic View Avenue, cut-through traffic would increase on their streets. These residents believe that westbound Braddock Road traffic would use Myrtle or Spring Streets to bypass the traffic signal at Commonwealth Avenue. Staff and the neighborhood traffic calming committee believe that Myrtle and Spring Streets will not see a significant increase in cut-through traffic due to the closure of East Masonic View Avenue since Little Street will remain open. In addition, no modifications will be made to the Braddock Road/Commonwealth Avenue intersection, other than the addition of a sidewalk.

FISCAL IMPACT: The cost of the entire traffic calming project is \$57,000. This project will be funded with monies budgeted in the Capital Improvement Program (CIP) traffic calming project account.

To the Members of the City Council:

I am very concerned that the current plan for Braddock Street calming will redirect traffic to the diagonal side streets specifically, Spring Street, between Braddock and Commonwealth. I have attended 3 Braddock traffic-calming meetings and at each meeting three different persons, including myself, have raised this same issue. The traffic-calming commissioner or representative answered each of us in the same way, "We do not anticipate any redirection to the diagonal streets." Admittedly, the commission has not based their opinion on any concrete data, nor have they gathered, as part of this plan, any present baseline data from which to measure the future impact to these streets. Their opinion is unrealistic and illogical. Each of these diagonal off-shoot streets already deals with cut-through traffic, especially during rush hours. Rather, my neighbors and I (see list below), project that drivers that are slowed on Braddock and closed off from the shortest East Masonic entry, will

redirect their courses to the diagonal streets, especially Spring, which offers both cut-through access and traffic light avoidance. (I did submit a traffic-calming plan for our street in May 2004, and data was collected, though the results have not yet been reported.)

I respectfully request, along with my neighbors, that the following actions be included as part of the Braddock traffic calming:

1. Traffic data for Spring Street is collected 6 months after the Braddock Street Calming is complete.
2. Traffic volume or "85 percentile speed" increases of more than 10% as compared to the May 2004 result in speed bump installation on Spring Street.


I am writing to support the closing of a 40-foot section of East Masonic View Avenue as part of a sorely need traffic-calming project on Braddock Road. This matter is on the docket of your June 22 meeting.

Braddock between Commonwealth and Mount Vernon Avenues is heavily used by people walking to the METRO station, as well as by schoolchildren attending George Washington Middle School. It is incredible that no sidewalk currently exists on the north side of Braddock.

The section of Braddock covered in this traffic-calming plan is currently a mini-freeway. Police have long documented many vehicles traveling at excessive speeds. The narrowing of the travel lanes and other features of this plan should help to lower those speeds. In addition, because of the proposed new crosswalk with bulb-outs at Little Street, pedestrians will have a much easier time crossing Braddock.

The loss of seven parking places seems to me to be, at worst, a minor inconvenience given the substantial public benefits of this plan. To truly protect the safety of pedestrians and increase the number of people who walk rather than drive, the Council must approve traffic-calming plans such as the one for Braddock Road.

As a Rosemont citizen, I appreciate your attending the RCA meeting last night.

I don't know how much of the Braddock Road traffic calming discussion you heard, but as a resident of Oak Street, I am still quite disturbed by the process of the calming project and the outcome. Like many others in the area, I was totally unaware of the project until the Friday before the Monday, April 26 hearing, which I happened to find out about when I saw a sign on Little Street. It was the first I had heard of it. I was unable to attend the Monday meeting, although I did send an e-mail indicating I was concerned about the effect of closing East Masonic on surrounding streets.

I have no problem with a traffic calming project for Braddock Road, and am in favor of. I do have a problem with the attitude that "it is for the greater good of safety and all of Alexandria and it's unfortunate if your streets get more traffic, live with it. " I chose to live on a narrow, side street so as not to have to deal with a lot of fast cars coming down my street. I understand that increased traffic is a by-product of development and have come to, reluctantly, accept it. I do not understand deliberately putting more traffic on some select streets and inconveniencing their residents with road restrictions without ensuring that their input and ideas are solicited.

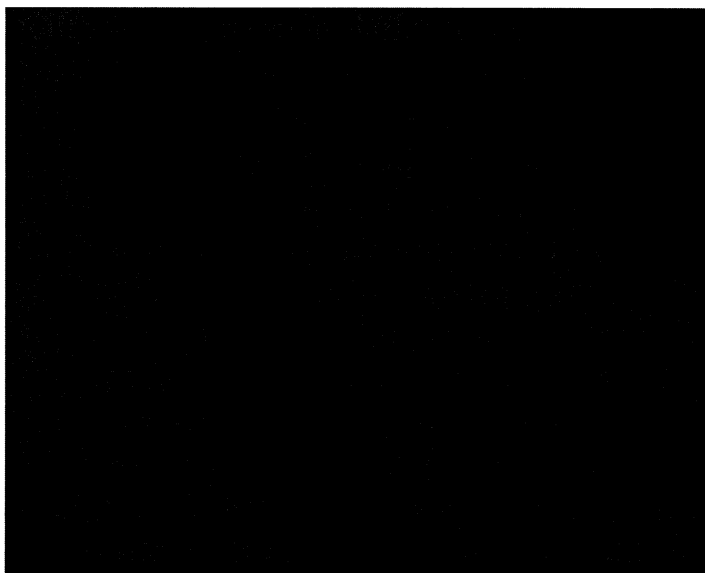
For example, I do not know the true purpose of closing off Masonic Avenue--is it to create parking spots for the people who will lose them on Braddock Road? Is it to create a safe crosswalk? Is it to reduce speeding and traffic on Masonic Avenue? (I owned a house on East Masonic during the 90s and am well aware of the speeding cars). I do not understand why the project will fail if Masonic is not closed off. Why not make it one way or put a "do not enter" or "no left turn" sign on Braddock Road to prevent westbound traffic from entering Masonic? Because I was not involved in the entire process, I do not know what alternatives were considered.

I would like to know when the process started, by whom, and what the purpose of all the changes are. While it may be that residents of Braddock Road have

been involved from the beginning, they are not the only ones who have to live with it. As far as I know, other traffic calming projects in the city have not involved intentionally re-routing traffic through residential neighborhoods (correct me if I'm wrong). Because this one does, I think greater efforts should have been made to include the entire area that will be affected by the project. And, by the way, had I not attended the Rosemont meeting last night, I would not have known that the City Council would be discussing it next week and that the meeting was changed to Wednesday.

I would appreciate anything you can do to slow the project and get more input from residents beyond Braddock Road. Please let me know if there is anything I can do to help. Thank you. Joanna Chusid

Dear Mayor and Council:

I am writing you regarding the proposed closing of

East Masonic View and Braddock Road. I have so many questions and concerns. At the very least I would request a delay in your decision for the following reasons. I also would like you to instruct your staff at Transportation to meet with us on Little, Oak, Walnut and Maple to allow us some input and explain fully their reasoning.

□ Minuscule notice and involvement by City officials of the people most directly implicated in this proposed change. (Our first notice was that this was a proposal was 40 days ago.

We, on Little Street, were informed on June 3rd this process was being reviewed since February. We were told the Church on the corner was involved, the residents up Braddock Road who are in need of a sidewalk were involved, the home owner at 205 Braddock was involved, as well as the Del Ray Citizens Association, who are not at all affected, was involved. The residents on Little Street, the residents on Oak Street, The residents on Walnut and Maple, who are most directly affected by the closing of this intersection, were not informed of this proposal until less than one week before the April 26th or 29th public hearing was to take place. We on Little were informed with a notice on a light post, of a public hearing on this proposal. I have ascertained that there is confusion by Little residents among those who actually saw the notice, the assumption being made that the City would actually involve us on some, even minimal level, of this proposal at some date. This was especially stated by our senior residents. We were not.

The last week in May I received the Rosemont Notice which stated a presentation was being made by Bob Garbasz of the City's Transportation and Environmental Services Division regarding the Braddock Road Traffic Calming Project. A neighbor and I attended, saw our first diagram, heard that discussions have been going on since February. We were told this was a "done deal"; that this closing of the intersection was inextricably intertwined with others getting their side walk, that this is a dangerous intersection, that our newly expressed concerns regarding: 1) being completely ignored in this process, our legitimate concerns regarding the quality of life and medical safety on Little Street, were of no importance and would not be addressed directly. It was stated that it is true that some people would be directly impacted negatively, but "I have looked at it all and this is the best solution". It is a "done deal".

I can completely appreciate the amount of work that went into this plan by our City officials. I cannot appreciate the fact the two short sentences on a public notice on a light post just over one month ago dictates a "done deal" because: we have been working on this since February: we know best: your concerns will not be addressed directly because we have already been over this with other people; constitutes citizen input by those who are so directly affected! I want these concerns addressed for myself and my neighbors. So I am going to express my concerns now, directly to you before your decision on June 9, less than a week away.

Comments:

☐ Why are speed bumps on Braddock Road so inappropriate for fire and rescue when we were told last year when they were placing these speed bumps on Commonwealth and Russel that the speed bumps would in no way interfere with fire and rescue. I can see that they are effective on those two streets.

☐ Why are the new sidewalks across the street on Braddock, in Del Ray, inextricably intertwined with the closing of our intersection.

☐ How is a fire and rescue coming up a narrowed Braddock Road going to effectively make the left hand turn approximately 110 degrees to service us on Little Street. We have seniors and chronically ill residents on our short street and fire and rescue have been called approximately 5 times since January 2004. As it is the fire truck struggles to get down our narrow street. And how are they going to make the left 100 degree turn left onto Little and the immediate right turn onto East Masonic View to service that community in a medically efficient fashion?

☐ How are school buses and trash trucks going to make the right hand turn off of Little Street onto a narrowed Braddock Road. Last year was the first year in the 14 years I have been here that Little Street was consistently plowed in a snow storm. Usually, just going straight is difficult. Making a 110 degree right turn onto a narrowed Braddock Road thrusts these large vehicles out into traffic on Braddock.

☐ Why does speed control on Braddock require closing off our intersection?

☐ Why will people not follow the path of least resistance and turn onto Glendale and Myrtle to

cut over increasing traffic on those two streets?
Has the Transportation Department discussed
this with these residents?

□ Why is closing this intersection the only
effective way of eliminating or curtailing the
dangerousness of this intersection? In the 14
years I have been here, I know of no incident at
that intersection. What other controlling avenues
have been studied and why won't they work? I
can think of several alternatives I would like to
see discussed.

These are a few of our legitimate concerns which
your Transportation representative at the
Rosemont Civic Association meeting refused to
discuss with us stating it was a done deal.

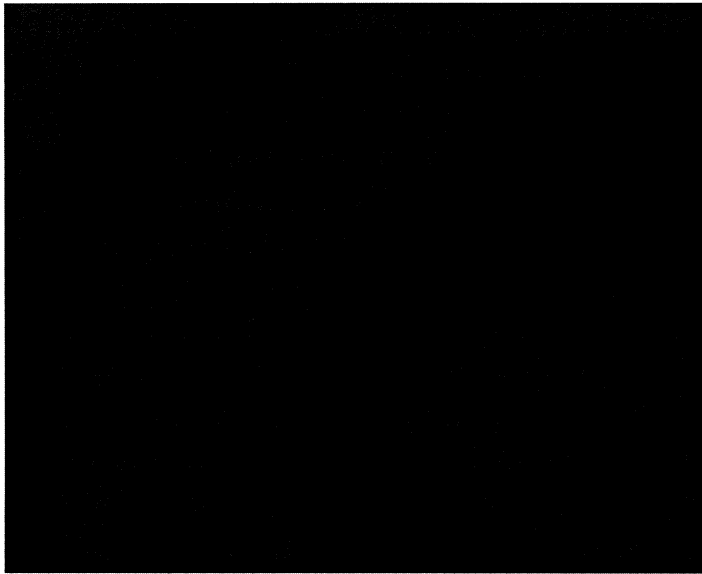
I sincerely hope that the Council delay a decision
on this, and that you instruct your Transportation
representatives to make legitimate effort to meet
with those most directly affected. This involves
the people on Little Street, Oak Street, Myrtle and
East Masonic View. Not the Del Ray Citizens

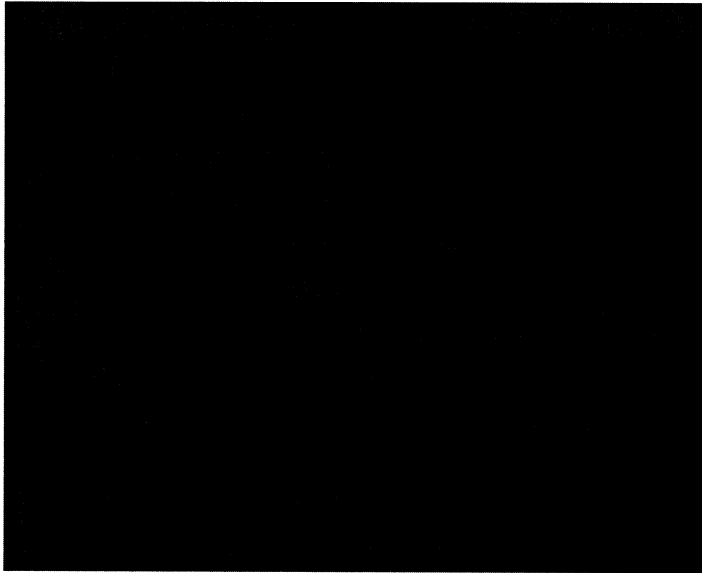
Comments:

Richard Baier, Director of Transportation and Environmental Services made a telephone call to me on June 8, 2004 and offering to hold another meeting regarding the closing of East Masonic View at Braddock Road. I too, feel we could take steps to make that intersection safer for pedestrians.

However, I have, as of this morning, been informed that the process involving the closing of East Masonic View at Braddock Road for "traffic calming procedures" has been actively ungelating among those in the know for two years. And now we understand why the Del Ray Civic Association was so intimately involved. However, I wonder why the residents of East Rosemont, who are the most directly and negatively impacted, were never summoned for input, were never asked for feedback or even informed fully of the plans for this proposal. We in East Rosemont were not approached by either the City, The Department of Transportation and the Rosemont Civic Association. We view that with great dismay. Diligence appears to be a prerequisite to protect your rights in this scenario.

East Rosemont may not be as wealthy or influential as the aforementioned; however we consider ourselves a valuable resource within the community of Alexandria. Our expectation is to be treated with the same regard as others within Alexandria. We are unhappy that we were not. We are unhappy that now, as it is becoming clear that this planning process going on for two years, included everyone else but those os us who are most directly and negatively involved.

We now know for instance that:

- 1: This has been an ongoing process for two years
- 2: That in the fray to clam traffic expected from what we consider over development, concerns were raised in the methods investigated (speed bumps and fire and rescue) which I contacted the Council about
- 3: That the residents in Del Ray from Mount Vernon Avenue to Street wanted a sidewalk in front of their house
- 4: That in order to obtain these sidewalks they were unwilling to give up their easements
- 5: That others, who expressed concern regarding the plan, were told that the easements are only 1 ½ feet back from the street even though the light posts were further back on the property

Comments:

6: That to obtain this, Braddock Road would be narrowed during a short stretch on Braddock Road to accommodate new sidewalks and calm traffic

7. That as a necessary part of this plan to succeed, the City would have to remove parking from the Rosemont side of Braddock

8. That to allow more parking and alleviate the lack of parking, and solve a pedestrian problem at East Masonic View and Braddock, the City would close it off

9. That , that, that , that , that.

10. And that we just won't tell the people of East Rosemont - fill the int blank.

These are the sentiments floating around in East Rosemont. We could be wrong on some of these sentiments, but, you know what, we just don't know. We've not been informed at any meaningful point in this planning.

In my telephone conversation with Richard Baier, and I have been told he is good at traffic flow, he indicated that you were not going to "rehash this with the whole community". My response was; don't waste our time in an attempt to merely placate us. If this meeting you are going to allow us is not one to involve us actively in the decision making process - then the meeting is a waste of our time and his time. You cannot rehash what has never been hashed before!!

In my telephone conversation with Richard Baier as well, he indicated that he would not notify residents on Oak Street as "where do you draw the line?" This affects all residents of East Rosemont, period. We are making every effort ourselves to notify as many as possible to include:

Ramsey, Wayne, Myrtle, Glendale, and Oak Street. Our time is very limited to mobilize but we are doing what we can. Everyone we have talked to is resentful of this decision.

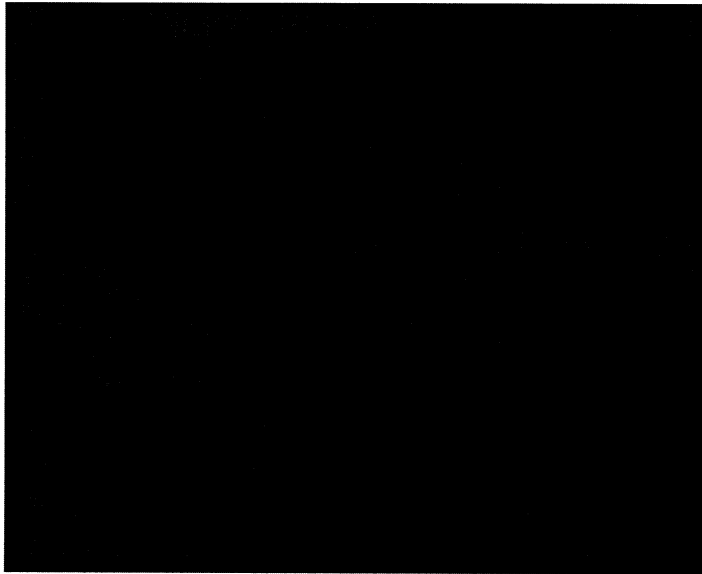

Comments:

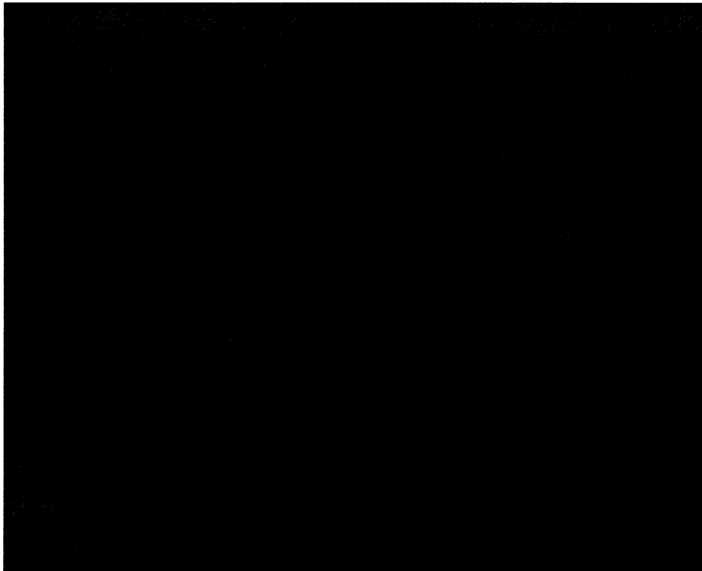
- The Del Ray Citizens Association voted in support of the proposal at its April membership meeting.

The recent modification calls for closure of East Masonic View at East Braddock Road in a way similar other problem intersections in the neighborhood such as the closure at West Glendale and Commonwealth Ave.

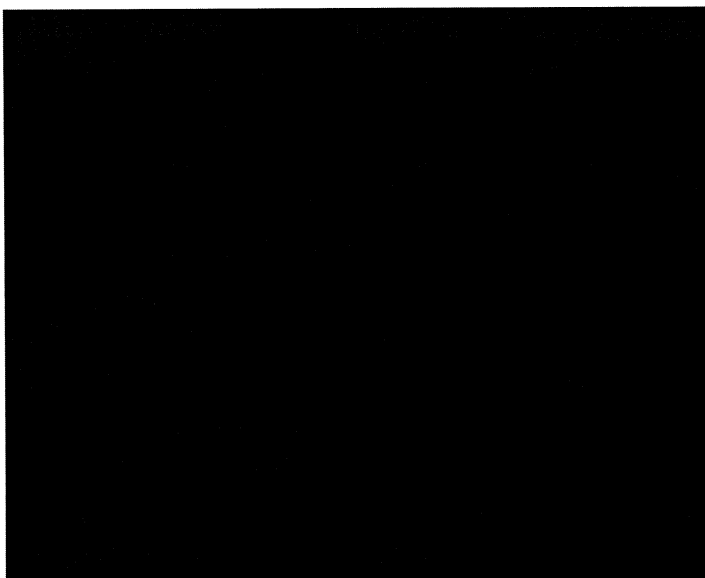

For 11 years I lived at 100-A E. Braddock Road, and pestered Officer Nasibi of the Alexandria Police and others to ticket speeding drivers on E. Braddock Road, to put up the digital speed boards, and to do something about the dangerously fast drivers on the road which is used by many pedestrians and commuters like me.

Rick Baier can testify to my efforts, as well as Tom Van Wagner's, to develop a speed calming plan for the Braddock Road.

3. It was approved by the Del-Ray Citizens Association meeting at the April membership meeting, and the association fully supports it.

4. It has the backing of Marguerite Lang, the president of the Rosemont Civic Association, who sent her endorsement to Paul DeMaio, T&ES. There is a small group of residents of nearby streets who have expressed their concerns to you, and their concerns arise from amendments made to the original proposal to accommodate the Church of Christ and residents of E. Masonic View.

The amendments call for the closure of E. Masonic View at E. Braddock Road in a way similar to other problem intersections in the neighborhood, such as the closure of W. Glendale and Commonwealth Ave.

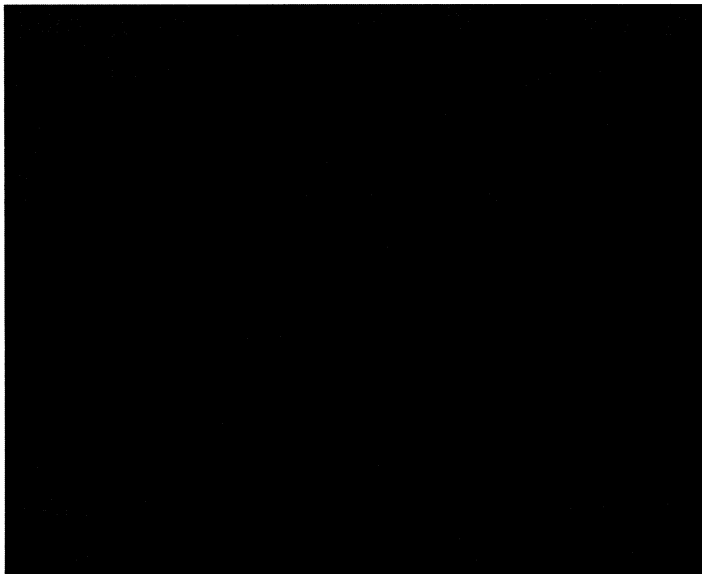

A meeting was held this evening at GW school

with the Department of Transportation and Environmental Services and the interested residents of East Rosemont regarding the closing of the East Masonic View and Braddock Road intersection.

The residents of Little Street and those representatives from the surrounding streets in East Rosemont were exceedingly upset with the original proposal and the lack of participation we were afforded in the process of deciding what was best to do. We felt we were the dumping ground for what was "left over": a ten space parking lot at the end of our street. My neighbors made terrific points. I was very impressed with their commitment to this process.

Near the end of the meeting Mr. Richard Baier presented a modified plan which actually addressed our concerns, the City's concerns, the concerns of our neighbors across Braddock Road in need of a side walk.

Comments:

The modified plan directly addresses my issues of; easy access by fire and rescue down Little Street and up East Masonic View by modifying the present round brae (a grassy knoll). The turn for fire and rescue will not be as dramatic and does not require the previous recommendation of slanting the curb to allow the trucks to drive over it. The modification of the brae will also allow and easier right turn onto Braddock Road from Little Street and East Masonic View, while still limiting drive through traffic on East Masonic View. In the modified plan the City would save 4 parking places for those affected on Braddock Road, (one home) and the Church for Sunday services. The Church did lose 6 spaces, but they do have a parking lot in the rear of the Church and because parking is not that bad on surrounding streets, they will still have ample parking. My last concern was a parking lot at the end of my street and its impact on my financial investment in my home as well as my neighbors.

Most of the Little Street residents, East Masonic View residents, Oak Street residents were pleased with the modified plan. We do however, being a community, want to lend our support for speed bumps in from of Wayne, Glendale and Myrtle as an aid for traffic calming for those streets because we know this neighborhood, and know people are going to cut through on those streets now. Richard Baier indicated the issue was money. I would request that the Council also include these residents in this plan and set aside

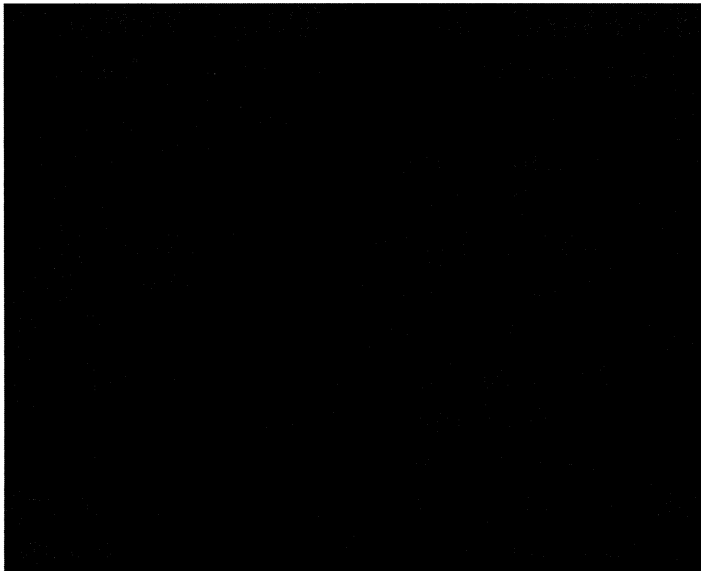
the \$10,000 that would help them from something that is going to come.

I was impressed with my neighborhood. But this is a personal statement. I was also impressed with Richard Baier. His willingness to listen, hear, assimilate and then accommodate was so skillful I just kept watching him. A fine, fine addition the City has in this fellow. I started in another camp and now am firmly in support of his modified plan. I won't oppose him again until I have to!!

Braddock between Commonwealth and Mount Vernon Avenues is heavily used by people walking to the METRO station, as well as by schoolchildren attending George Washington Middle School. It is incredible that no sidewalk currently exists on the north side of Braddock.

Comments:

The section of Braddock covered in this traffic-calming plan is currently a mini-freeway. Police have long documented many vehicles traveling at excessive speeds. The narrowing of the travel lanes and other features of this plan should help to lower those speeds.
