As you may know, I recently replaced Rob Krupicka as the President of the Del Ray Citizens Association.

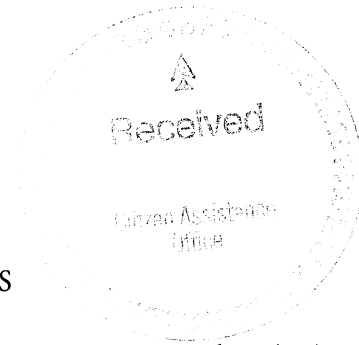
Our Membership meetings are the second Mondays of each month, which puts me in conflict with the IT Commission meetings.
