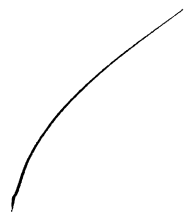





approach to planning and development, a great  
concern for community, and the brains and  
dedication to really be an asset to the

commission. If, as I suspect, the seats will be reappointed this year and none will be available, then I suggest you employ him in any other capacity on the commission that he might be of use. You don't want anyone with the skills and ability of Roger Wood to get away!
