


Dear Ms. Henderson,

Subject Alexandria's Economic Diversity

Dear Vice Mayor Pepper, Councilman Gaines, Councilman Krupicka, Councilman Macdonald, Councilman Smedberg, and Councilwoman Woodson,

Diversity is one of Alexandria's most valuable elements. I ask that you back up your commitment to socioeconomic diversity as well as racial diversity by supporting the 3% Compromise.

When I began working for a living, back in the late sixties, I, too, was discriminated against -- in terms of education, jobs, and income -- but on the basis of my gender. Later (though surprisingly not all that much later), I was discriminated against on the basis of my age. Finally, I found an employer with the good sense to refrain from discrimination. Now, as I contemplate working full-time until I am at least 70 in order to have any hope of keeping my home, current real estate tax increases threaten to effect a new kind of discrimination against me -- discrimination based on the fact that I have succeeded somewhat, but just not enough for Alexandria.


I have been an Alexandrian for 11 years, and I love our City. I lived in an apartment out in the West End for about seven years. Then I was fortunate, through working very hard, saving as much as I could, and "living small" to save enough for a down payment on a condominium at Carlyle Towers. It will be paid off when I am nearly 90. But I will need to add some extra principal to my mortgage payments for the next 15 to 20 years to have any hope of being able to keep my home when I am too old to work. If our real estate taxes are not reined in, and strenuously, all my work will have been for nothing. I will lose the home I worked more than 30 years to even begin to pay for.

Please don't let Alexandria become a "boutique" city -- a city that is populated only by the Very Rich, playing Lord and Lady Bountiful to the Very Poor, who will work (as it now looks that I did) under the threat that, if they surpass their economic origins by a moderate margin, they will have to abandon their homes and their City in their success.

Please support the 3% Compromise. Businesses need to pay more to support our City, and we need to tighten our belts and cut back on luxuries that only the very rich can afford.




