
I am writing to inform you that I will be resigning from the Design Review Board as my wife and I are relocating.

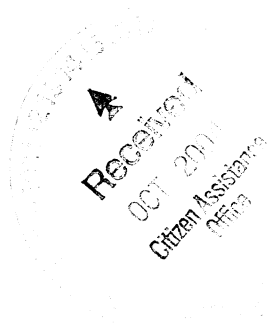
I have enjoyed working with you and I hope to do so again in the future.

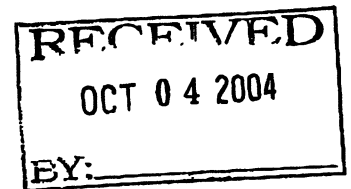

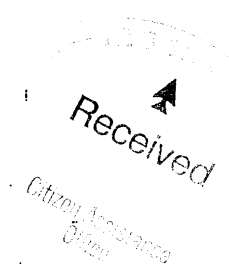


