INFORMATION ON PROPOSED ORDINANCE

Title

AN ORDINANCE to amend and reordain Section 12-7-12 (COMPOSITION; OFFICERS; APPOINTMENT, TERM AND COMPENSATION OF MEMBERS), of Article B (CONSUMER AFFAIRS COMMISSION), Chapter 7 (CONSUMER AFFAIRS), Title 12 (EDUCATION, SOCIAL SERVICES AND WELFARE), of The Code of the City of Alexandria, Virginia, 1981, as amended..

Summary

The proposed ordinance modifies the membership requirements for the Alexandria Consumer Affairs Commission to permit a representative of a non-profit organization which deals with consumer issues, or an employee of a state or federal agency which deals with consumer issues, to be appointed to the Commission, if one of the positions designated for a member of a local consumer action organization remains unfilled for three months or longer.

9 THE CITY COUNCIL OF ALEXANDRIA HEREBY ORDAINS:

10  
11 Section 1. That Section 12-7-12 of The Code of the City of Alexandria, Virginia,  
12 1981, as amended, be, and the same is hereby, amended to read as follows:

13  
14 Sec. 12-7-12 Composition; officers; appointment, term and compensation of members.

15  
16 The commission shall consist of 11 members appointed by the city council; two of whom shall  
17 be members of the business community, two of whom shall be members of local consumer action  
18 organizations and seven of whom shall be citizens at large; provided ~~that initial members of the~~  
19 ~~commission shall be appointed as provided hereinbelow , however, that one of the positions~~  
20 ~~designated for a member of a local consumer action organization may be filled by a~~  
21 ~~representative of a local non-profit organization which deals with consumer issues, or by an~~  
22 ~~employee of a state or federal agency which deals with consumer issues, and provided, further~~  
23 ~~that the vacancy for the consumer action organization member has been advertised and has~~  
24 ~~remained unfilled for a period of three months or longer.~~ All members shall be residents of the  
25 city; except that one member of the business community and one member of a consumer action  
26 organization may be a nonresident of the city but a resident of the state. ~~Members of the~~  
27 ~~consumer affairs committee appointed by city council pursuant to resolution no. 282, who are~~  
28 ~~members of this committee on the date of final passage of the ordinance from which this article~~  
29 ~~was derived, are hereby appointed as members of the consumer affairs commission established~~  
30 ~~herein for a term of one year from the date of final passage of this article. Should said committee~~  
31 ~~consist of less than 11 members on the date of final passage, council shall appoint sufficient~~  
32 ~~members, for terms of one year from the date of final passage of this article, necessary to bring~~  
33 ~~total membership of the commission to 11 members.~~ All members thereafter shall be appointed  
34 by city council for three year terms; ~~except, that as decided by lot, the initial term of four~~  
35 ~~members shall be two years and the initial term of three members shall be one year. Members~~  
36 ~~may be reappointed.~~ Any vacancy shall be filled by the council for the unexpired portion of a  
37 term. The commission shall select a chairperson, vice chairperson and secretary by a majority  
38 vote of all members of the commission. The chairperson shall serve a two year term and may not  
39 succeed himself. In the event that the chair is vacated for any reason, the vice chairperson shall  
40 succeed and serve as chairperson for the remainder of the term. A vice chairperson shall be  
41 selected by majority vote of all members of the commission to serve as vice chairperson for the  
42 unexpired term. Members shall serve without compensation but may receive reimbursement for  
43 expenses, subject to the availability of funds.

1           Section 2. That no provision of this ordinance shall be deemed to affect the  
2 appointments or terms of the members of the Alexandria Consumer Affairs Committee in office  
3 on the effective date hereof.

5           Section 3. That this ordinance shall become effective upon the date and at the time  
6 of its final passage.
