WHEREAS, residents of the District of Columbia currently
have no vote in Congress; and

WHEREAS, on April 19, 2007, the United States House of Representatives passed H. R. 1905, which would give Washingtonians a voting member of Congress for the first time in over 200 years; and

WHEREAS, this legislation is not expected to change the partisan balance of the House, since it pairs a seat for traditionally Democratic Washington, D.C., with an additional seat for Republican-leaning Utah; and

WHEREAS, this legislation has bipartisan support, its two strongest proponents being Congresswoman Eleanor Holmes Norton (Democrat, District of Columbia) and Congressman Tom Davis (Republican, Fairfax County); and

WHEREAS, this legislation now goes to the United States Senate for its consideration; and

WHEREAS, the City of Alexandria believes that all Americans should be represented in the United States Congress; and

WHEREAS, without enactment of this legislation, District of Columbia residents will continue to lack representation on the floor of the House of Representatives;

NOW, THEREFORE, BE IT RESOLVED that the Alexandria City Council express its support for full voting rights in the House of Representatives for a Representative of the District of Columbia; and

BE IT FURTHER RESOLVED that City Council requests that Senator John W. Warner and Senator James Webb support this legislation and President George W. Bush sign it; and

BE IT FURTHER RESOLVED that copies of this resolution be sent to President George W. Bush, Senator John W. Warner and Senator James Webb, to apprise them of the City's position.

- The bill permanently expands the House of Representatives from 435 to 437 seats.
- It eliminates the DC Delegate position and gives the city a Representative in the House. A special election would be held to fill the seat.
- It also adds a seat to the next state in line to gain a Representative based on U.S. Census numbers. That currently is Utah. That seat would be at-large until 2012, when House seats are reapportioned based on the Census. That representative would also be chosen in a special election.
- The new representatives would take their seats during the current Congress.

What's Next

Approved by the House, it moves to the Senate.
