SUBJECT: CONSIDERATION OF A RESOLUTION TO AMEND THE CITY OF ALEXANDRIA PENSION PLAN FOR FIREFIGHTERS AND POLICE OFFICERS TO REQUIRE A MANDATORY LUMP SUM PAYMENT TO A TERMINATING PARTICIPANT WITH A VESTED BENEFIT PRESENT VALUE OF \$1,000 OR LESS

ISSUE: Consideration of a proposed change to the City of Alexandria Pension Plan for Firefighters and Police Officers (the "Old Plan").

RECOMMENDATION: That City Council adopt the attached resolution (Attachment 1) amending the City of Alexandria Pension Plan for Firefighters and Police Officers to comply with federal law. The threshold allowing a plan to provide a lump sum payment to a terminated participant with a vested accrued benefit valued at \$3,500 or less is changed to \$1,000 or less.

DISCUSSION: The Pension Plan for Firefighters and Police Officers, a defined benefit plan, became effective July 1, 1956. The Plan currently requires that a single lump sum payment be made to a terminating participant if the present value of the participant's vested accrued pension benefit is \$3,500 or less. The value of the vested accrued pension benefit needs to change for the plan to comply with the federal Economic Growth and Tax Relief Reconciliation Act of 2001 (EGTRRA). EGTTRA allows a plan to have a mandatory distribution provision if the present value of the vested accrued benefit is value at \$1,000 or less.

As required by the Plan document, participants were provided with written notice of these proposed changes and had a 60-day comment period and the opportunity to participate in several public meetings. It should be noted that the plan was closed to new members in the late 1970's. This is a technical amendment only since no plan participant has a balance of \$3,500 or less.

FISCAL IMPACT: This change will have no fiscal impact.

FOURTH AMENDMENT

TO THE CITY OF ALEXANDRIA PENSION PLAN

The "\$3,500" reference in Article X, Section B is hereby changed to "\$1,000" effective as of January 1, 2006.

The City of Alexandria Pension Plan for Firefighters and Police Officers, as in effect on December 31, 2001, and as previously amended by a First, Second and Third Amendments, and as amended by the foregoing changes, is hereby ratified and confirmed in all other respects.

	The Honorable Mayor, Vice Mayor and Council members,
	I am a fire department employee representatives to the Pension Board for the Firefighter's and Police Officer's Pension Plan. I feel my fiduciary responsibility to the Pension Plan requires that I express my opposition to the 50% subsidy that has been added to the service buy back proposal (Fourth Amendment to the Pension Plan) that will be heard at the June 12, 2007 Council Meeting (Docket Item #33). I urge you to consider one of three options for this issue: 1.) The City will make a lump sum payment to the pension plan for the full cost of the subsidy. 2.) Remove the subsidy

from the buy back proposal, and approve the original Fourth Amendment document presented to the Council Pension Committee. 3.) Reject the buy back proposal in whole as presented before you for consideration.

I have many concerns that arise from including a subsidy to the buy back proposal. I am concerned about the precedence that subsidizing this buy back proposal will have when the Board considers how to proceed on the additional 56 active participants that have requested a buy back option; the financial impact the subsidy will have on a new pension plan, making annual payments to fund the subsidy will cause the pension plan earnings to be the first mechanism for funding the subsidy; and the plan actuary has presented a draft report that suggests that both employee and employer contributions will need to be increased to fully fund the pension plan when the report is finalized in July.

The Pension Board appointed a committee at the December 15, 2005 meeting to explore the feasibility and costs associated with offering a service buy back amendment. The intention of the Board was that the employee would pay the full cost for a service buy back and remain cost neutral to the pension plan. The scope of the buy back option was to include active plan participants with previous City service. I served on this committee to represent the fire employees.

The first committee meeting was held on February 2, 2006. At this meeting, the Plan actuary presented a report that identified 71 active employees that had prior City service; and, that the total cost of a service buy back was valued at \$6,547,000. The actuary cautioned the committee of possible IRS complications for permitting employees to purchase service credit for non-covered employment, especially for non-qualified service the employee will receive retirement benefits for under another City pension plan.

We determined that we should proceed with the 15 active employees with a break in service as a firefighter or police officer since they were covered employees with qualified service; therefore, there would be no complication with IRS rules. The committee intends to explore the feasibility of providing a buy back opportunity for the remaining 56 active employees with other City service. The committee presented a proposed plan amendment to the Pension Board at the June 12, 2006 meeting that would offer a buy back of prior service in whole year increments up to the maximum eligible prior service. This proposal required the eligible member to pay the full actuarial cost of the time being purchased with the Plan covering the residual cost to the Plan. There was significant discussion at this meeting, including the discussion of offering a subsidy to offset some of the employee costs. The Board approved the plan amendment without a subsidy with the voting results of 6 in favor, 1 against, and 1 abstention.

There was a 60 day notice and public comment period on the plan amendment, as approved without a subsidy, that began in July 2006. The plan amendment was presented to the Council Pension Committee on October 3, 2006. During this meeting, a couple of participants that will be eligible for the buy back expressed that the cost to purchase back time was too expensive and asked that a subsidy be included in the buy back proposal to make the purchase of time more affordable. The Committee asked for cost estimates for offering a subsidy and a survey of the participants to their desire for a subsidy. After reviewing the costs of offering a subsidy to the buy back, the Council Pension Committee agreed to include the subsidy to cover 50% of the cost for up to 3 years of service on March 14, 2007. The anticipated total cost could be a lump sum of \$384.918, or annualized at an estimated \$10,600 per vear over 23 vear.

Comments:

I have a concern about the precedence that is set by offering a subsidy for the buy back proposal and the effect it will have on future buy back proposals. The Pension Board has been petitioned from other employee groups asking for a buy back of prior service. These employees would include Deputy Sheriffs and Emergency Communications Technicians that have become Police Officers and Medics and Emergency Communications Technicians that have become Firefighters. At the first committee meeting to consider the buy back proposal, we recognized there were 56 additional employees that would be eligible for an expanded buy back proposal. These additional employee groups surely are going to ask for their buy back proposal to be subsidized as well if this proposal is subsidized.

I have a concern about the financial impact the subsidy will have on our new pension plan. The

pension plan was converted from a defined contribution plan to a defined benefit plan effective January 1, 2004, that included nearly \$43M in unfunded liabilities that was amitorized over 25 years. A Pension Board was established to create policies and manage the financial stability of the plan. The cost of the subsidy is not being funded in a lump sum; however, it will be added to the existing unfunded liability to be amitorized over the next 23 years. With only three years of history as a defined benefit pension plan, the Plan has not established itself with a financial history to be in a position to absorb additional debt.

I have a concern that funding the subsidy through annual payments will cause the pension plan earnings to be the first mechanism for funding the subsidy. Making annual payments causes the Pension Plan to absorb the financial debt into the existing unfunded liability. The City will make payment on this debt based on the contribution rate the actuary determines the cost of the plan will be. This valuation is done annually and is expressed in the recommended employers contribution rate, and includes the market value of the plan assets. The Plan's investment returns help to pay down the accrued liabilities BEFORE the employer's contribution rate is determined. Therefore, the pension plan earnings will offset the unfounded liability before the City makes additional contributions.

I have a concern that the Plan actuary has presented preliminary valuation results at the April 17, 2007 Board meeting that suggest that both employee and employer contributions will need to be increased to fully fund the Pension Plan when the report is finalized in July. The employee contribution increase will be necessary to maintain tax-free non-service disability benefits (IRS requires the employees to pay the cost of the non-service disability benefits). It will be extremely difficult to make a decision to increase the employee contribution rate after the employees have been told that the City is paying for this subsidy proposal.

As a fiduciary to the Pension Plan, I am compelled to express my concerns of subsidizing the buy back proposal that was added by the Council Pension Committee to the Fourth Amendment to the Pension Plan. The original proposal presented to the Committee required the employee pay full actuarial cost to purchase previous service (fore which they have already received full benefit from the pension plan). Making the Pension Plan absorb an additional debt will have a financial impact on the Pension Plan assets. I urge you to reconsider the subsidy provision and consider one of three options: 1.) The City will make a lump sum payment to the pension plan for the full cost of the subsidy. 2.) Remove the subsidy from the buy back proposal, and approve the original Fourth Amendment document presented to the Council Pension Committee. 3.) Reject the buy back proposal in whole as presented before you for consideration. Sincerely,

	Dear Honarable Mayor & City Council Members;
	I am an active participant from the fire department that is covered by the Firefighter's and Police Officer's Pension Plan. I am opposed to the subsidy provision that is included in the service buy back amendment to the Firefighter and Police Officer's Pension Plan (Fourth Amendment) that you will be considering at the June 12, 2007 City Council meeting.
Comments:	The 13 participants that are eligible for the buy back provisions have already received a lump sum distribution (or rollover) of the City's 20% contributions made on their behalf to their pension plan at the time they separated service. With the proposed 50% subsidy, they will only be contributing back half of the cost to purchase the service to which they have already received benefits. The estimated cost to subsidize all eligible years of service is almost \$385,000 (1), which could average almost \$30,000 in additional benefits to each buy back participant.
	The participants eligible for the buy back proposal make up less than three percent of the active

employees (13 people eligible out of 468 active employees in the pension plan). Although it may be well intentioned, subsidizing the buy back proposal gives a significant additional benefit to a small group of employees that have already received their full pension benefits from the pension plan.

I ask, and urge, you to reconsider offering a subsidy as part of the buy back proposal.

RESOLUTION NO. 2231

FOURTH AMENDMENT TO THE CITY OF ALEXANDRIA PENSION PLAN FOR FIREFIGHTERS AND POLICE OFFICERS

The "\$3,500" reference in Article X, Section B is hereby changed to "\$1,000" effective as of January 1, 2006.

The City of Alexandria Pension Plan for Firefighters and Police Officers, as in effect on December 31, 2001, and as previously amended by a First, Second and Third Amendments, and as amended by the foregoing changes, is hereby ratified and confirmed in all other respects.
