Title

AN ORDINANCE to amend and reordain Section 3-2-52.1 (ASSESSMENT OF FEE FOR COURTHOUSE SECURITY PERSONNEL) of Article E (ASSESSMENT OF COURT COSTS AND FEES), Chapter 2 (TAXATION), Title 3 (FINANCE, TAXATION AND PROCUREMENT) of The Code of the City of Alexandria, Virginia, 1981, as amended.

Summary

To implement a change in state law adopted by the 2007 General Assembly, the proposed ordinance increases, from \$5 to \$10, the courthouse security fee (which funds the costs of courthouse security personnel) that is assessed as part of the costs imposed in criminal and traffic court cases adjudicated in the Alexandria circuit court and general district court. The ordinance also deletes language that has become moot as the result of the General Assembly's repeal of the expiration date previously contained in Va. Code § 53.1-120(D).
