SUBJECT: CONSIDERATION OF A TRANSFER RESOLUTION - FY 2007 GENERAL FUND OPERATING BUDGET

ISSUE: Transfer Resolution – FY 2007 General Fund Operating Budget.

<u>RECOMMENDATION</u>: That City Council adopt the attached resolution which transfers \$4,064,000 in budgeted funds to eight departmental accounts from seventeen departmental accounts.

DISCUSSION: In accordance with Section 5.07 of the City Charter, at the end of each fiscal year, City staff submits a resolution to City Council to transfer existing current year appropriated funds to adjust the various departmental accounts up and down as necessary, without increasing total appropriations, according to projected final expenditure patterns. These transfers represent less than one percent of the FY 2007 General Fund budget. The transfers, in the amount of \$4,064,000, are recommended to accomplish the following:

To adjust various departmental accounts (\$2,491,000) and the non-departmental budget (\$1,573,000) for a total of \$4,064,000, for the following:

- General Services (\$570,000): for City fleet vehicle fuel cost increases (\$231,000) and utilities (\$339,000).
- Department of Human Services (\$1,500,000): including the previously projected¹ grant shortfall (\$1,000,000) previously appropriated to the Non-departmental budget. Additional shortfalls were driven by the mandated Community Services Act (CSA) expenses that represent the required local match (54 %) to State grant funds (46 %) as expenditures have increased due to an increased number of higher cost children served, as well as the change in federal Title IV-E regulations
- Finance (\$116,000): for consulting costs related to pensions and purchasing.
- Fire Department (\$250,000): for personnel costs;
- City Attorney's Office (\$1,500,000): for outside legal counsel;
- Personnel (\$107,000): for personnel costs (\$33,000), fees for professional services (\$30,000) and increased costs associated with the annual employee service awards program (\$44,000).
- General District Court (\$7,000): to fund additional fees for professional services; and,
- Law Library (\$14,000): to fund miscellaneous non-personnel costs.

¹ The November 2006 Supplemental Appropriations Ordinance appropriated \$1.0 million to the Non-Departmental budget for federal grant shortfalls. This potential shortfall had been anticipated in the original FY 2007 budget when City Council agreed to designate \$1.0 million for potential federal grant shortfalls in Fund Balance.

FISCAL IMPACT: The resolution balances operating budget accounts by transferring approved appropriations. There is no net change in total budgeted expenditures as a result of the transfers.
