RESOLUTION ENDORSING VIRGINIA AIR POLLUTION CONTROL

BOARD ACTION CONCERNING THE MIRANT PLANT

ISSUE: Consideration of resolution to endorse the actions of the Virginia Air Pollution Control Board taken on September 25, 2006, with respect to controlling the ongoing adverse public health and environmental impacts due to the operations of the Mirant Potomac River Generating Station.

RECOMMENDATION: That City Council adopt the attached resolution.

DISCUSSION: As you are aware, on September 25, 2006, William Skrabak, the City's Environmental Quality Division Chief, in conjunction with the City's litigation counsel and many concerned residents, made a presentation to the Virginia Air Pollution Control Board ("Board") outlining the ongoing adverse public health and environmental impacts due to the operations of the Mirant Potomac River Generating Station, and requesting that the Board take appropriate remedial action.

At that time, the Board unanimously decided to take direct control of the permit process vis-avis Mirant's Potomac River Generating Station -- meaning that in future the Board will take final action on Mirant applications, rather than delegate that authority to the Director of the Virginia Department of Environmental Quality (VDEQ) and his staff -- and to require a "transparent" process for dealing with Mirant PRGS. The board also asked asked VDEQ staff to advise it on the best way to accomplish this and to ensure that VDEQ's authority to act in an emergency or other appropriate situation is not affected.

In addition, the Board decided to consider the following remedial measures which were requested by the City:

- 1. Order the PRGS as of July 1, 2007 to cease and desist from causing or contributing to air pollution episodes or any violation of ambient air quality standards, including for PM 2.5, and significant ambient air concentration guidelines for toxic pollutants; and
- 2. Require the PRGS to submit an application for a construction permit and impose a comprehensive and vigorous review for air pollution impacts and pollutant control technology consistent with provisions of Article 9 of the Board's regulations, 9 VAC 5-80-2000, et seq.,

including, but not limited to, the submission by the PRGS of plans, specifications and data as set out in 9 VAC 5-80-2020 and -2040; and

3. Establish a local air pollution control district comprising affected areas of Alexandria City and a local air pollution control committee to monitor and report to the Board the activities and compliance of the PRGS with the Board's regulations and orders.

These measures, if ultimately adopted by the Board, will establish the most rigorous state-level review of the plant and its operations, and can be tailored to address the specific harmful characteristics of the plant on its environs.

The proposed resolution formally endorses and commends the Board for these actions, and, in addition, confirms that the City expects to work collaboratively with the Board and VDEQ to protect fully the health, safety and welfare of the City's residents.

City staff and I will be pleased to answer any questions on Tuesday night.
