# Title

AN ORDINANCE to amend Section 5-2-62 (CHANGES OF NAMES) of Article C (STREET NAMES), Chapter 2 (STREETS AND SIDEWALKS), Title 5 (TRANSPORTATION AND ENVIRONMENTAL SERVICES) of The Code of the City of Alexandria, Virginia, 1981, as amended, by adding thereto a new subsection (15) (CHANGES EFFECTIVE JANUARY 12, 2008).

## Summary

The proposed ordinance changes the name of Barecroft Place to "President Ford Lane." Barecroft Place is a new street that has been constructed in the Oak Grove development (located at the corner of Janney's Lane and N. Quaker Lane). Barecroft Place intersects Janney's Lane and provides driveway access to the homes in that part of the development. The Planning Commission approved the name change at its public hearing on December 4, 2007. Four lots will be ultimately be affected by the name change, and the owners support the requested change.
