

Facility Characteristics

- Transloading track capacity
 - 20 tankcars (additional cars on storage track)
 - -~29,000 gallons ethanol per tankcar
- Spill containment area
 - -~515,282 gallon capacity
- Four fire hydrants
- Security fencing
- Knox Box rapid entry key system for emergency vehicle access



Facility Characteristics

- Installed grounding/bonding equipment
- Climate-controlled storage shed on-site with 1,600 gallons of Alcohol Resistant Aqueous Film Forming Foam (AR-AFFF)
- Facility meets all requirements of Statewide Fire Prevention Code

Ethanol Characteristics

- Most commonly produced from corn in the United States
- Polar solvent
- Water soluble
- Flashpoint is -50 deg. F for E95
- Heavier than air (1.59 vapor density)
- Lighter than water (0.79 specific gravity)

Ethanol Characteristics

- Wide flammable range
 - -3.3% to 19% in air (NIOSH, 2008)
- Denatured with ~5% gasoline for transport (E95)
- Blended with gasoline and used as motor fuel (E85)
- Greatest hazard is flammability
 - Little or no smoke/flame produced in a fire



Emergency Scenarios

Leak Spill Fire



- Foam firefighting trailer
 - 660 gallons AR-AFFF concentrate onboard
 - 1,000 gallon per minute (gpm) nozzle
- Tow vehicle
- Leak/spill equipment
 - Absorbents
 - Collection pools
 - Recovery drums
 - Atmospheric monitors
 - Recovery pump





- Additional AR-AFFF delivery equipment:
 - Four in-line foam eductors (150 gpm flow)
 - Four air-aspirating foam nozzles





- Hazardous Materials Response Team
 - AFD, in partnership with Arlington County Fire Department (ACFD) and the Virginia
 Department of Emergency Management (VDEM), hosts the Northern Virginia Regional Hazmat Team
 - Minimum of three AFD hazmat technicians on-duty 24/7/365



- Hazardous Materials Response Team
 - Hazmat 202
 - Personal Protective Equipment
 - Computers and research
 - Leak control/containment
 - Spill recovery
 - Atmospheric monitoring
 - Support 202






Emergency Planning



Council: we have been insulted and dissed enough.


Do you wake up at
