SUBJECT: RESOLUTION TO INCREASE ADMISSION AND RENTAL FEES AT SELECT FACILITIES OF THE OFFICE OF HISTORIC ALEXANDRIA

ISSUE: Increase admission and/or rental facilities fees at Fort Ward Museum and Historic Site, The Lyceum -Alexandria's History Museum, Alexandria Black History Museum, Friendship Firehouse Museum and Lloyd House.

RECOMMENDATION: That City Council adopt the attached resolution.

DISCUSSION: The City of Alexandria currently charges admission fees at certain Cityowned museums operated by the Office of Historic Alexandria, including Gadsby's Tavern Museum and Stabler-Leadbeater Apothecary Museum. Other facilities, including Fort Ward Museum and Historic Site, The Lyceum, Alexandria's History Museum, Alexandria Black History Museum, Friendship Firehouse Museum, and the Alexandria Archaeology Museum are open to the general public at no charge.

For FY 2009 the Office of Historic Alexandria proposed, and Council agreed during the budget process, to implement a new admission policy for select sites where there is no current admission charge. At The Lyceum, Alexandria's History Museum, Alexandria Black History Museum and Friendship Firehouse Museum, a policy of "Pay What You Can, But You Must Pay Something" would be established. A suggested admission fee of \$2.00 per person would be recommended, with a payment of no less than one cent required for each general admission. Visitors would determine their own admission cost based on their ability to pay. This "Pay What You Can, But You Must Pay Something" is a policy that has been successfully adopted by other museums, in that it raises new revenues without establishing a minimum threshold that would discourage museum attendance.

Rental fees for weddings, parties special events, fundraisers, meeting, seminars and workshops at Lloyd House and The Lyceum would also be raised about 20% above the current rates to be more aligned, but still competitive, with fees charged at nearby historic facilities operated by other agencies and organizations including Carlyle House, Lee-Fendall House, Woodlawn Plantation, Gunston Hall, and River Farm.

FISCAL IMPACT: Staff estimates that the new admission and rental fees would produce an increase of \$36,315 in additional revenue annually.
