SUBJECT: CONSIDERATION OF AN ORDINANCE TO INCREASE FINES FOR PARKING VIOLATIONS

---

**ISSUE:** Consideration of an ordinance to increase the fine for parking meter violations.

**RECOMMENDATION:** That City Council adopt the ordinance on first reading, and schedule it for public hearing, second reading and final passage on Saturday, June 14, 2008.

**DISCUSSION:** The Code of Virginia authorizes the governing body of any county, city or town to provide by ordinance for the regulation of parking, stopping and standing of vehicles within its limits, and to establish the penalties for parking violations.

The City's parking fines were last increased in January 2007, when the fines for several violations were raised to be comparable with Fairfax and Arlington Counties. From 2005 through 2007, the greatest number of Alexandria's parking violations occurred in two areas:

Parking contrary to the direction of an official sign (current fine is \$40); and  
Parking violations related to meters, including exceeding the time limit of the meter (current fines are \$25).

In a continuing effort to encourage motorists to use parking garages and to turn over on-street parking spaces more frequently, staff recommended an increase in meter violation fines, from \$25 to \$35, during the FY 2009 budget process. No fine increase was proposed for parking contrary to an official sign. City Council approved the meter violation fine increases in the FY 2009 budget.

The next step in the approval process is to adopt the ordinance and to schedule it for public hearing, second reading and final passage. This ordinance, if adopted by City Council on June 14th, would become effective on July 1, 2008.

**FISCAL IMPACT:** From 2005 through most of 2007, an average of \$350,000 per year was collected for parking meter violations. Assuming that issuance and collection rates remain

constant, staff estimates that raising the fines for meter violations to \$35 will generate an additional \$141,000 annually. The FY 2009 final budget add/delete list approved by Council included a \$141,000 revenue increase from this source.

Most parking citations are issued by Parking Enforcement Officers using electronic hand-held devices that can be reprogrammed with the new fines immediately. In the relatively few cases where Police and Fire Department officers issue tickets from paper ticket books, the changes can be written on the citations. No new paper tickets will be required. This ordinance affects six specific violations (Section 10-4-22 through 10-4-27). In some areas, signs will need to be updated to reflect the new fines for meter violations.

AN ORDINANCE to amend and reordain Section 3-2-354(PENALTIES FOR UNCONTESTED CITATIONS) of Article S (PAYMENT, CONTEST AND ENFORCEMENT OF PARKING CITATIONS), Chapter 2 (TAXATION), Title 3 (FINANCE, TAXATION AND PROCUREMENT) of the Code of the City of Alexandria, Virginia, 1981, as amended.

THE CITY COUNCIL OF ALEXANDRIA HEREBY ORDAINS:

Section 1. That Section 3-2-354 of the Code of the City of Alexandria, Virginia, 1981, as amended, be, and the same hereby is, amended and reordained to read as follows:

Sec. 3-2-354 Penalties for uncontested citations.

Any other provisions of this code to the contrary notwithstanding, the penalty for any of the following violations of this code shall, when the citation which was issued for the violation is uncontested, be as follows:

Although I will not be able to attend the City Council meeting on Saturday,

I would like to comment on the proposed dog park.

I support the

applicant's proposal to dedicate land and construct a dog park on Monroe Avenue. The new park will help to alleviate the current overuse of the Simpson Dog Park.

However, with the additional 2000 residential units

planned for Potomac Yard, it is expected that approximately 40% of the residents will own at least one dog. This equates to approximately 800 new dogs within the Potomac Yard development. A .9 acre dog park will not be adequate to meet the future needs of Potomac Yard residents.

The .9

acre dog park should be considered as only partially addressing the CDD requirements for Rail Park.

The applicant should be required to

**Comments:** dedicate an additional 2 acres (not necessarily as one parcel) of off-leash recreation space within the project.

Other requirements that I do not see identified in the staff report should include:

A requirement that the applicant meet with the community of dog park users, and in particular, the Del Ray Dog Owners Group (DDOG) to provide guidance and input into the design and amenities of the .9 acre dog park.

A requirement that the applicant provide lighting in the park due to the secluded nature of the parcel and the level of landscaping surrounding the park.

(b) If payment is not tendered to the director of finance with 30 calendar days of the date the citation is issued, a penalty of \$25 in addition to the penalty imposed by subsection (a) for the violation for which the citation was issued; provided, that, in the event the 30th calendar day from the date the citation is issued is a Saturday, Sunday or legal holiday, such additional penalty

shall not be imposed if payment is tendered in the amount required by subsection (a) on the next succeeding business day; provided further, that if payment is remitted to the director of finance in a sealed envelope bearing a postmark on or before midnight of the 30th calendar day from the date the citation is issued, no such additional penalty shall be imposed; and provided further, that the director of finance may waive such additional penalty, even though payment has not been tendered or mailed within 30 calendar days of the date the citation was issued, whenever the owner of the vehicle identified in the citation establishes any of the following to the satisfaction of the director:

(i) that the owner did not find the citation at the time of its issuance on the owner's vehicle and only learned of the citation after the day on which it was issued, and has tendered the required payment with 30 days of first learning of the citation;

(ii) that, within 30 days after the issuance of the citation or, if later, after first learning of the citation, the owner has made a written request to the director for information concerning the citation, and has tendered the required payment within 30 days of the director's response; or

(iii) that the owner was medically incapable of making the required payment within 30 calendar days of the date the citation was issued.

Section 2. That this ordinance shall become effective on July 1, 2008.
