SUBJECT: CONSIDERATION OF A GRANT APPLICATION AND RESOLUTION FOR A PRESERVE AMERICA GRANT FROM THE NATIONAL PARK SERVICE, TO ENHANCE INTERPRETIVE AND EDUCATIONAL PROGRAMS OF THE OFFICE OF HISTORIC ALEXANDRIA

**<u>ISSUE</u>**: Consideration of a grant application and resolution for a Preserve America grant, from the National Park Service, enhance interpretive and educational program of the Office of Historic Alexandria (OHA).

**<u>RECOMMENDATION</u>**: That City Council:

- (1) Approve the attached resolution; and
- (2) Authorize the City Manager to:
  - a. Submit the grant application (due June 30), requesting \$228,368 in Preserve America federal grant funding; and
  - b. Execute all necessary documents that may be required.

**BACKGROUND:** Preserve America grants support designated communities that have demonstrated a commitment to preserving, recognizing, designating, and protecting local cultural resources. They are funded by an appropriation of the Federal Government and administered by the National Park Service. Eligible applicants for Preserve America Grants are federally-designated Preserve America communities and neighborhoods, certified local governments, State historic preservation offices, and Tribal historic

preservation offices. Alexandria has been designated a Preserve America community, and is eligible to receive these funds.

**DISCUSSION:** If grant funds are awarded, the Office of Historic Alexandria will expand the living history and educational programs recently developed as part of the National Harbor initiative. The funds will be used to revise and print a new *Alexandria Bikeways* map, highlighting the historic sites and cultural resources along the Alexandria Heritage Trail; and produce and provide equipment for an interpretive orientation film at each of the seven OHA museum facilities including, Gadsby's Tavern Museum; Stabler-Leadbeater Apothecary Museum; Alexandria Black History Museum; The Lyceum, Alexandria's History Museum; Friendship Firehouse Museum; Alexandria Archaeology Museum; and Fort Ward Museum and Historic Site.

If the Preserve America grant program is continued in FY 2010, OHA will continue to apply to support new initiatives, as well as expanding on-going programs.

**<u>GRANT PERIOD</u>**: Awards will be announced in September 2008. The term of the grant is October 1, 2008-June 30, 2009.

**FISCAL IMPACT:** This grant requires a 50 percent match (\$228,368), of non-federal funds, through either in-kind services or cash. The City's match will be in the form of both; \$149,472 for in-kind services; \$64,896 in cash previously allocated by Council for National Harbor initiatives, and \$14,000 in cash donations from supporters of Friends of Historic Alexandria. The \$64,896 National Harbor initiatives will continue to be expended on those initiatives, but since those initiatives are eligible activities under the Preserve America grant, those funds can be used as match.
