CONSIDERATION OF A RESOLUTION CONFIRMING THE

DECLARATION OF EMERGENCY FOR THE CITY'S PROVISION

OF SUPPORT FOR THE PRESIDENTIAL INAUGURATION

<u>ISSUE</u>: Consideration of a Resolution Confirming the Declaration of Emergency (Attachment 1) for the City's Provision of Support for the Presidential Inauguration.

**RECOMMENDATION:** That City Council adopt the resolution (Attachment 2).

<u>DISCUSSION</u>: As part of our planning for the Northern Virginia region's local response to the Presidential Inauguration activities, the chief administrative officers agreed to pursue local declarations of emergency. This declaration enables us to seek reimbursement for our local expenses in preparing for and staffing the City for this important event. I recommend that City Council adopt the attached resolution.

### DECLARATION OF LOCAL EMERGENCY CITY OF ALEXANDRIA, VIRGINIA

# January 17th through 21st, 2009

WHEREAS, as a result of the Presidential Inauguration on January 20, 2009, extraordinary and unprecedented numbers of people will be in Alexandria and attempting to pass through Alexandria in the days prior to the event and after its conclusion; and

WHEREAS, the events that are happening in and around Alexandria during this period have significant national security implications; and

WHEREAS, there is a perpetual threat of unpredictable winter weather during this period; and

WHEREAS, many of the normal mutual aid assets from immediate jurisdictions are in use; and

WHEREAS, these conditions pose a threat of substantial injury and harm to the public and substantial damage to and loss of property, and have already resulted in an unprecedented requirement for inter-agency and inter-governmental coordination; and

WHEREAS, under the best circumstances, intense coordinated governmental actions will be required to prevent and alleviate the damage and loss threatened by the event;

NOW, THEREFORE, IT IS HEREBY DECLARED that, effective January 17, 2009, a local emergency exists throughout the City of Alexandria because the circumstances associated with the Presidential Inauguration create the threat of an emergency that threatens to be of sufficient severity and magnitude to warrant coordinated local government action to prevent or alleviate the damage, loss, hardship or suffering threatened pursuant to the Code of Virginia §44-146.16 and §44-146.21(a), and that this declaration shall expire at midnight on January 21, 2009, unless extended by the City Manager.
