## STATEMENT OF LESLIE ZUPAN, PRESIDENT, INNER CITY CIVIC ASSOCIATION

## **JANUARY 24, 2009**

Good morning Mayor Euille, Vice Mayor Pepper and Members of Council:

My name is Leslie Zupan of 1309 Queen Street. I am President of the Inner City Civic Association and a 29-year resident of my neighborhood.

First, a little housekeeping – I want to thank Faroll Hamer of P&Z for identifying the error about the size of the future park at the Wythe Street Post Office. This is a mistake that I'm glad about. We still have issues regarding the park, but look forward to working with the City through the Braddock Implementation Group.

I'm here today, however, to talk about the issue of crime in the Inner City. As you all know, a Yellow Cab driver Khalil Siddiqi was murdered in cold blood at Princess and Buchanan Street less than a week ago. I ride Yellow Cab regularly and Mr. Siddiqi's colleagues are devastated that this has happened. Even more so, our community is shocked by such a blatant act.

Sadly, we are in the midst of a crime wave. In October 2008, there were three armed robberies of victims walking from Braddock Metro station. Thankfully the Alexandria police arrested suspects, but since then we've had another armed robbery. On New Year's Eve, the Smile Market at Queen & Henry Street was robbed in daylight at gunpoint, seven days later the owner of the Alexandria Fish Market was robbed at gunpoint at dusk.

What can you do to help?

The Inner City has been blessed by being able to work with an outstanding community police officer, Michael Sprague. He has been tireless and creative in his approach to solving and preventing crime. But he is only one man and can't be cloned. Are Council aware that the Inner City always had two community officers? When Walter Green was transferred to another beat two years ago, the second position was left unfilled.

We formally request that you assist us in ensuring that a second officer is immediately assigned back to the Inner City beat to deal with the crime wave.

Second, we need a police presence at Queen and Fayette during the day. The drug dealers are keeping bankers' hours, no doubt because our police force has been very effective at night. But drug dealers are taking up their posts at Queen and Fayette as early as 7:15 AM and servicing drive-up customers. We need daytime coverage.

Third, we need to have other City Departments back up our police officers. Be aware that Officer Sprague doesn't complain to me, but when I follow up on an issue I often find that he is not getting cooperation from other departments. We're happy with the support of Code Enforcement regarding blighted houses but it shouldn't have taken six months of repeated inquiries to trim overhanging trees at Queen and Fayette that hide drug activity.

Finally, given that the robberies in October were committed by individuals from PG County, and the fact that more of the loitering at Queen & Fayette is being done by strangers who not only do not live in the neighborhood but in many cases don't even live in the City of Alexandria, we are concerned about City policies both major and minor that continue to beacon to the underworld that this is the neighborhood to come to so they can commit mayhem.

We are concerned about the relaxing of standards for business SUPs, especially those involving alcohol sales, and in particular are worried about the proposals in the Braddock Road plan regarding the future of Queen Street. Queen Street is not a major commercial corridor – it is only two blocks long and half of it consists of townhomes. It is in transition now, with Sarge's, the American Legion and other structures on the market and with several older property owners who may not have a succession plan for their businesses. I can assure you our community would be happy to see the whole street ultimately go residential and that this would do much to reduce the attractions of our neighborhood to bad guys.

Finally, regarding the Braddock Road Plan, we do not want developer contributions being poured into loans for businesses on Queen Street. Developer money is better spent on capital improvements like streetscaping and open space acquisition that are permanent, that add value to surrounding properties and are accessible to everyone. The City is not skilled in managing such a fund, and we are concerned that valuable dollars could be flushed out through businesses that are poorly thought through and which may only continue to require police attention and resources in years ahead.
