

Rose,

I sent the following to the Mayor and Council this morning:

Mayor Euille and Council Members,

I understand that you have just reappointed me to the Alexandria-Caen Sister City Committee. I wrote you a rather passionate letter this summer regarding the proposal to term-limit members of City boards and Commissions and I contacted you again requesting the reappointment that you have just voted on. So, it is with a great deal of chagrin that I must inform you of my resignation from Committee, effective immediately.

Over the last six months, factionalism has raised its ugly head on the Committee. We have tried to resolve it and keep it under control, but we (or, at least, I, as the Chairman) have been unable to resolve the issues. I have become, in the last few months, a lightning rod for criticism and to some degree an object of derision among some of the members. This all finally came to a head after the conclusion of what had appeared to be a very successful visit by members of the Caen-Alexandria Association (the committee's counterpart in Caen) and the Official delegation from Caen, which included Mayor Duron and Deputy Mayor Notari. I realized after some very heated e-mails from a few of my colleagues that my continued participation on the Committee at this time truly threatened the future of the committee. When I took the Chair of the Committee a few years back, it was after a previous Chair had faced a similar situation. That chair stayed too long, and I took over a committee with only three members left. I could not let that happen again.

It has been an honor, a pleasure, and a pure joy in my life to serve this city that I love and to strengthen its bonds with our wonderful friends in the city of Caen. I had a vision that I hoped would allow us to develop some informal relationships with several of Caen's other sister cities and was actually exploring the idea with a similarly minded friend in Portsmouth, England, one of Caen's European sister cities. Perhaps this idea may be part of the legacy I leave the committee and the City.

I do truly apologize to you for making you go through the time consuming (and, now, unnecessary) task of re-appointing me to the Committee. I first sought appointment to the committee when my years of involvement at Blessed Sacrament Catholic Community were ending. Some of you may recall that there was a period about a decade ago when the clergy there shifted in perspective and many long-time active members left the Parish. I was one. I had been very involved in lay ministry, the Parish Council, etc. and suddenly found myself with a great deal of time on my hands. The committee provided me with a new exciting way to channel my time, talent and treasurer and I will always be grateful to each of you for the support you gave to me, the committee, and the ideas and ideals of Sister Cities International.

I wish you all a Happy Holiday season and a prosperous New Year for yourselves, your families, and our city.
