Subject: proposed FY10 budget

Dear Mayor Euille, Vice-Mayor Pepper and City Council Members:

As the

City's primary nonprofit partner in ending and preventing homeless,

Carpenter's Shelter would like to comment on the proposed FY10 budget. We appreciate your prior request to the City Manager to minimize cuts to the City's fraying safety net in these unprecedented economic times.

Many

of you know that Carpenter's Shelter has permanently ended homelessness for 90% of our clients who choose to participate in our post-shelter program,

Aftercare. These clients are now productive and contributing members of the Alexandria community. In good economic times, we did this through our case management outreach and education classes and by partnering with city agencies, other nonprofits, businesses and the caring Alexandria Community. Until now we offered very little financial assistance to these individuals.

Our 80 bed shelter is full with working poor families, many who just a year ago never imagined that they would be living in a homeless shelter. Most are homeless because of job losses. Today, 25 children call the Shelter home. Full occupancy is a recent occurrence – just last April we were considering using some of the bedrooms for desperately needed classrooms. According to DHS, the requests for assistance are increasing dramatically. There are eight families current on a wait list hoping to get into city shelters. DHS also noted that since last fall, there has been a 50% increase in families on the wait list and a noted increase in the number of two parent families requesting shelter. Many of our Aftercare

families are struggling to maintain their housing. They are behind in their rent, utilities and are increasingly using our limited food pantry to feed their families. A case-by-case review of these families led our Board just last week to allocate \$50,000 of our "rainy day funds" to subsidize rents so these families do not return to homelessness. With a full shelter (and we anticipate it being so for at least 18 months) where would these families go if evicted? Here are our biggest concerns about the proposed

Comments:

DHS budget:

- Most agree that FY10 will be a challenging year and expect an avalanche of anticipated human service need with an anticipated high increase in first time served. We disagree with the FY10 DHS number of projected people served 16,000 unduplicated. This only an increase of 254 over actual FY08 when we were not in this economic crisis. Is this a realistic number or will the DHS well dry within the first months of FY10??? Who will serve these people? Will their needs (housing and other assistance) go unattended? DHS acknowledges that there will be 1/3 reduction in the safety net to prevent eviction, loss of utilities. Already stretched nonprofits can not mend this net!
- Many of those
 participating in the safety net are able to do so because of the receive
 money through the Fund for Human Services (Childrens' Fund, Community

Partnership Fund and Youth Fund). The propose budget reduces these by 14.5% and proposes to serve 20% FEWER NONPROFITS which will result in critical needs going unattended throughout the city. Already in contingency planning, without full funding from the CPF, Carpenter's (which pays real estate taxes to the City) will reduce its services to the City's most vulnerable. One suggestion is to shorten our day shelter hours and/or close for certain days. This is the program where those living on the streets of Alexandria can take showers and store their belongings.

Thank

you Mr. Mayor and Council. Carpenter's knows that you are committed to sustaining the core values of Alexandria in these difficult times, and your long standing commitment to the safety net must continue. Perhaps Council should consider a 1/2 cent increase in the real property tax rate increase over and above what is currently being considered and then designate that these funds be applied to DHS and their various services (Childrens' Fund, Youth Fund, Community Partnership Funds) in order to serve the neediest and most vulnerable children and adults in Alexandria.



for ACPS decreased by about 2% for the 2010 FY? How come City Council could not grant the school board its requested budget of \$165.5 million?


Since ACPS is fiscally dependent, did a decrease in state funds hurt the education budget, or did it come more from the local level?

Patrick Henry Elementary School as well as GW Middle School.

We respect

the challenging position you are in regarding the budget. We do, however, want to ensure you fully understand the positive influence Amalia is having on a making a difference in the lives of our youth and what the loss of her means to Tucker and Brent Place.

The total annual service loss at

Tucker Elementary School:

· 200 third and fourth grade students will

not receive the classroom-based LifeSkills Training science-based

prevention program;

• 50 at-risk kindergarten and first and second grade

students will not receive the Al's Pals and Too Good for Drugs science

based prevention program;

• 30 at-risk students will not receive

individual supportive counseling;

• of the 657 Tucker Elementary School

students, more than 30% are ESL or ELL learners, and that number

continues to grow rapidly. So, many Spanish-speaking, parents will not

participate in two building-wide substance abuse prevention campaigns;

You have heard hear tonight from

families and students who live at Brent Place who depend on the services


Amalia provides. Because many of these services are not provided elsewhere,
this means some families won't get help because they will not understand
how to navigate the system of city services.

Elimination of these

positions will most likely result in an increase of youth risk behaviors as well as a demand for more intensive and expensive treatment down the road. You have heard tonight some thought-ful suggestions on how to potentially fund program and personnel requests. We ask that you consider in this case, recent research indicates that every dollar invested in substance-abuse prevention yields \$10 in savings. It's your responsibility as well as ours as a community to be fiscally responsible, to advocate for the children, and to provide the tools they need to invest in themselves to help them make good choices. Looking at both the short and long term, Amalia is their advocate, a proven resource, and an economically sound solution to a real situation.

Therefore, the Tucker PTA respectfully requests the mayor and city council members reconsider and not eliminate the Bilingual Substance Abuse Prevention Therapist based at Brent Place Apartments and Tucker Elementary

Dear Mayor Euille and City Council Members,

My name

is Elizabeth Atkinson and I am the James K. Polk PTA President. I am speaking tonight to urge that funding for the Polk gym be restored.

As

you know, funding for the Polk Gym was approved for FY 2009 in the CIP budget. We were thrilled. I, along with other parents, worked diligently with the ACPS Facilities team; school staff; and architects to come up with a wonderful design scheme that will benefit Polk and the City in many ways. It will provide a space for the children to obtain physical education; and allow organizations to rent the gymnasium thus creating a revenue stream for the city. The other KEY factor is it is designed to allow PE classes EVEN when elections are taking place or other events that require a multi-purpose space such as our science fair, colonial tea, and enrichment

programs. As we all know there are A LOT of elections coming up and EVERYTIME the community votes, our PE teacher loses her classroom.

Currently, the school system is facing growth at an un-precedented rate. While we've been able to cope in the past, our increased student population has stretched our resources to a breaking point. And based on the city estimates, this situation is going to continue.

My own

daughter's first grade class has 25 children in it. On Fridays they share
PE time with another class of 24 students. This puts 49 children in a
"multi-purpose" room that is below the state recommended gym size of 4,000
square feet as well as accommodating our treasured grand piano and racks
and racks of folding chairs.

Comments:

You really need to see the multi-purpose room to understand how desperately a real Gym is required. There are numerous opportunities to witness the multi-purpose room in full use.

On Monday and Wednesday mornings our PE teacher holds a "Healthy Heart" class at 7am that is open to the older students, and it sometimes has as many as 56 children in attendance. Alternatively, you could join us for one of the several double PE classes. We will be following up with you in the near future to see when it would be convenient for you to visit Polk.

It is our understanding that the Polk Gym is on the stimulus funding "wish list" that the City has submitted, and we urge the City to continue to push for such funding since the Gym project could provide constructions jobs to help the economy and would provide benefits for our community for many years to come.

If it is not possible to obtain such funding, we urge City Council to raise the real estate tax rate by 1 cent as proposed by the City Manager since doing so will permit the City to fund the Polk Gym and several other beneficial projects. I certainly would be willing to

pay it.

Thank you for your time and consideration. Again, we recommend you visit Polk so you can understand why funding for the Gym is so critical.

"We, children, are having so many problems" and the school system and city ageny employees are already stretched, stressed, and overwhelmed with their myriad of responsibilities. So much so that there is a waiting list or a limited time frame for us to receive the necessary services. Now, because of the budget constraints/restraints, we are going to suffer even more.

Dear Mr. Mayor, Madam Vice Mayor, and Members of Council:

I write to you regarding the City Manager's proposed FY10 City Budget. In the spirit of collaboration, both The Campagna Center and Hopkins House join in sending similar remarks under separate cover to you.

During this extremely difficult economic period, we are all pressed to make very difficult choices in the face of greatly diminished resources. Therefore we want to make it clear at the outset that, at least on the part of The Campagna Center and Hopkins House, we are not appealing to you for more money. Instead, we are asking that City Council to use this difficult period as an opportunity to strengthen the City's collaboration with nonprofits.

Through rather modest but significant changes in its grant-making process to nonprofits, the City has an opportunity to expand the funding resources available to benefit Alexandria residents. Foundations, businesses, and even the federal government have come to fully appreciate the value of "compounding" in nonprofit funding. That is, a grant from the City to a nonprofit may attract a matching grant from a foundation or business or leverage federal funds; and, with these combined resources, the nonprofit is able to produce a benefit to society at lower cost than if government were to do it. This is compounding in its best form.

With this notion in mind, we recommend that City Council consider the following:

1. Add to the existing priorities for the Alexandria Human Services Fund (AHSF) in FY10, projects that have a high likelihood of leveraging new, current, or additional private and public funds into the City (i.e. "compounding"). This

change can be implemented in the FY10 Budget process without disrupting the process.

- 2. Add to the existing priorities for AHSF grants in FY10, projects that offer a sustainability strategy that can be realistically accomplished within 3 years. (Inferred here is that grants to the same projects (as different from "Organizations") should not be indefinitely renewed). This change can be implemented in the FY10 Budget process without disrupting the process.
- 3. Consolidate all of the AHSF grant funds into a single, coherent source of financial support to nonprofits with an overarching guiding principle: That the AHSF be used to demonstrate the benefits of public/private collaboration and to draw new and additional funds into the City for the benefit of its residents. This change can be implemented in the FY10 Budget process without disrupting the process.

Second, we recommend that City Council set aside a portion of the Children's Fund FY10 allocation – in the range of \$400,000 or more:

- To help reduce the number of children on the City's list waiting for Childcare Fee Subsidies; and,
- To help serve children ages 0-5 that are ineligible for federal/state funded programs (i.e. Head Start, Early Head Start, CCDF, VPI); and
- To match childcare "scholarship" funds raised by nonprofits. Nonprofits would be invited to launch or expand private fundraising strategies based on a City match.

We understand that the City's Childcare Fee Subsidy waiting list has grown to well over 300 children. In this economy, if parents are denied help to afford childcare they will not have the help they need to find and keep jobs. Also, current eligibility requirements require that both parents be working and with the rising unemployment rate many families currently receiving Childcare Fee Subsidies will loose childcare. This will be heartbreaking for parents, tragic for their children, and costly for the City. Therefore, additional local funds need to be set aside to serve these families that are ineligible or do not have access to federal/state funding. Such an investment of City funds in FY10 could not help raise substantial private dollars to address the need but also demonstrate the clear benefits of public/private collaboration.

Third, we recommend that City Council conduct an examination of the extent to which Virginia Preschool Initiative (VPI) dollars are being fully and properly leveraged in the City. Based on information presented last fall to the Early Childhood Commission, it appears that Children's Fund money, combined with other resources, are being used to draw down VPI dollars from the state. If this is indeed the case, the City is missing an opportunity not only to attract new and additional source of money but also serving fewer

children than it might. Also, with the new VPI funding model recently approved by the Virginia House of Delegates, it is important that these new dollars are leveraged and accessible to a wide range of programs and families. Indeed, by reprogramming Children's Fund money away from VPI draw-down may provide the resources to reduce the Childcare Fee Subsidy waiting list. The VPI program could become more of a scholarship program where the money follows the child to the parent's choice of program.

Fourth, we recommend that City Council convene a meeting of Early Childhood stakeholders to consider ways to streamline the coordination of early childhood public policy and funding in the City. There are several groups and organizations invested in early childhood public policy and funding. These groups include the Early Childhood Commission, nonprofits, and the Early Childhood Directors Group, and the newly formed Alexandria-Arlington School Readiness Council. In addition to these, the Alexandria Community Trust and the Virginia Early Childhood Foundation play an important role in funding early childhood programs in the City. The Alexandria City Public Schools and the City government have also recently put forth a proposal to add an administrative oversight layer for government funding of early childhood programs. This myriad of entities and groups not only consumes a considerable amount of human and financial resources in the City, but sometimes conflicts around policy. We believe the children and families of the City could be better served by a single, comprehensive framework that includes participation of all invested partners.

And, finally, we want to acknowledge City Council's past and ongoing commitment to the children and families of this City. Please know that your support has not gone unnoticed or unappreciated.

I am a grandmother raising 3 grandchildren. Their ages are 6, 7 and 9 -all girls. I am raising these grandchildren as their mother is in and out
of jail, the first in 2005 and the last release in December 2007. After
the first year their mother was in jail, she got in trouble again. The
middle child became quite uncontrollable, both at home and school. I was
at my wit's end and turned to Mental Health Services to try to seek help
for the girls. I was able to get some help for myself in the process. The
middle child has gone from being hard to control in Kindergarten and First
Grade to being an Honor Roll Student and Citizenship for every quarter so
far this year. The 6 year old is still having trouble with her behavior

Council Members:

In reading through Councilman Wilson's news letter, I am looking at the proposed budget cuts for our City. I, for one, am not pleased at all. As a long time resident of the City of Alexandria, I have always felt our City was one of the best for taking care of our young and our old.

With the following cuts:

- Children's Fund, Youth Fund, and Community Partnership Fund
- Elimination of an infant Development Specialist
- Elimination of several mental health and substance abuse therapists positions
- Elimination of a Residential Counselor providing services to those with intellectual disabilities
- Reduction to our budget for Substance Abuse counseling prevention services at GW, Patrick Henry, and Tucker schools
- Reduction of adolescent health clinic staffing
- Cutting back hours at recreation centers
- Closing Lee and Colasanto Pools
- Eliminating after-school programs at Maury and George Mason schools
- New fees for out of school time programs
- Elimination of a building inspector who responds to resident complaints
- Reductions in nursing at the Adolescent Health Clinic
- Reductions in the Emergency Shelter Services for the homeless
- Reductions in the Senior Taxi program
- Reductions in the Crisis Child Care program
- Reduction of Youth Recreation Services
- Reduction of Adult Recreation Services

It saddens me to see these cuts as they have so much affect on our children, and our elderly. I realize that the budget planning has taken some time and consideration by you and your staff, but these cuts will have a tremendous drawback on our community. We must work together to take care of our community. Our children need and count on these programs to help them learn and grow into good citizens. We have a lot of low and moderate income families that need these programs. Without them where will our children have to go when their parents are working, how will our parents work when they

are worried about their children. Who will take care of our elderly, sure we can always say someone will step up, but I know for myself, I am already taking care of my four daughters, my two grandchildren, my elderly mother, 85, two days a week, and a friend that is very sick. I need the accessibility that these programs afford me. I need to know there are programs in place that can get my friend to the doctor, or get her medications, provide services to her when I can not. By making some of these cuts, there will be no where for our children that are in families struggling with drug or alcohol abuse to go for help. They will fall into the life style around them, they will need more help from the City in the future if they can not receive the help we provide them now.

To withdraw staff from the clinics is only going to make it harder for our poor to get the help they need. The lines are already so long, and the waiting is forever. People are getting sicker, and are not getting the treatment they need because of these cuts. Our daycare programs for both the young and old need to stay in place, we can not let the minds or bodies decay or be left to fend for themselves. We all have families, we know what is needed to take care of them, but sometimes we need the help of the City to take care of us.

I take care of my grandson full time, in doing so, before I received help from the City, I had to spend all of the funds left to me by my father so I could have him in day care while I worked a full time job. I was worried I would have to stop working in order to take care of him, but with the help of the City, he is in a good day care program and will be able to get into kindergarten in the fall of this year.

My daughter is in public housing in the City, thanks to the City helping her. For over a year she was not able to use one of the bathrooms in the house because of a tree root that had grown through the pipes below the house. She called ARHA many times, by removing the position of the building inspector, when someone needs help to have the process move, it will take longer than the year she had to wait to have repairs made.

I know there needs to be cuts, the budget is tight, its like that for everyone at this time. We all have to cut back. But, we can not do this at the risk of taking from the people that need this help. I work long, hard days to be sure everyone I need to help is taken care of. I do the best I can, I am not the only one that is working like this to help others, but without the help of the City we can not do it.

I ask of you, please reconsider the cuts that I have listed from the listing that is slated for budget cuts to our City.



I am writing as to implore you not to cut the 7 mental health, substance abuse prevention and early intervention positions from the city's Community Services Board that have been identified as part of the reduction in budgetary spending. I am an employee of one of the city's community health and family support centers and in my role as a therapist I have had countless opportunities to work along side these individuals, and to see the positive impact that their work has on the children of this community.

Without these positions, which focus on prevention and early intervention services, problems that might be identified and prevented or treated quickly and effectively will go unnoticed until they are too severe

to escape attention. At that time, the cost to the city will be much larger, as often these children become involved with police, court services, child protective services, etc. If the at-risk behaviors go unnoticed, they stand to develop issues that will require constant support (i.e. drug and alcohol abuse, violence, poor school performance leading to higher risk of poverty and dependence on city programs as adults).

intervening with these children before their problems become unmanageable, many of them will learn positive coping skills and learn ways to manage stress that do not put them at risk. They will have more positive contact with strong adult role models, and go on to become effective, independent members of society. In short, the city will reap not only the financial benefits of having such productive residents, but will save thousands of dollars on the resources to correct and manage anti-social behaviors that these programs are desgined to catch and prevent.



The Mount Vernon Genealogical Society is a local non-for-profit organization with over 300 members. We meet in the Hollin Hall Senior Center down toward Mount Vernon.

Our Society was established to

encourage people interested in the pursuit of their ancestral heritage throughout the world, and to provide a forum for the sharing of knowledge gained by individual members in their own research. The Society pro¬vides instruction in the use of genealogical research methodology, and adherence to standards of accuracy and thoroughness in genealogical research, and

collects, preserves, and disseminates genealogical, biographical and historical information. More details about our Society is available at our website, www.MVgenealogy.org

Most of our members live in Alexandria and rely upon the Special Collections Division of your Queen Street Library for their own research and to help others. We are writing to call your attention to this somewhat unsung division within the Alexandria Library System—the Special Collections Division—in hopes that a better understanding of its importance will mitigate the impact of possible funding reductions. Your Special Collections provide unique genealogical resources available nowhere else. For example, when I first moved to Alexandria seven years ago, I came to the Queen Street Branch to find what I could about 210 Prince Street, a house built by a Revolutionary War ancestor of my husband. To my delight, I discovered that the woman who had restored the townhouse (and written a book on Old Town) had also spent years collecting the family history of Col. Michael Swope, and then she donated nearly half a foot of files on the house and family to Special Collections!

The Special Collections Division is a well-known and much-respected resource among thousands of both local researchers and those from across the nation who are interested in the history of Alexandria. Patrons come to research their families, explore important aspects of Alexandria's African-American heritage, or learn the history of their homes in Alexandria's various neighborhoods. Among its patrons are City of Alexandria staff members from the Board of Architectural Review, the Planning Department, the Office of Historic Alexandria, and the Office of the City Manager, whose jobs require them to research a building, family, business or some other aspect of Alexandria from the 18th Century through the present. In order to provide such service, weekday and weekend hours are important, and adequate staffing is a priority. We know you value the Alexandria Public Library system just as we understand that you must find

ways to reduce spending. We hope that the intrinsic value of the Special Collections Division, and the support it has from its many patrons, will ensure that you give it every consideration as you shape Alexandria's budget.

Dear Mayor Euille and Members of City Council,

I am writing this e-mail

to respectfully request that you continue to invest in substance abuse and mental health prevention, early intervention and treatment services for Alexandria's children by not cutting these positions from the city's budget. I know how it would affect students I teach at George Washington Middle School where Benjamin DeRigge provides counseling and prevention services. Several of my students look forward to his boys' clubs, substance prevention group, and community peer mentoring programs and would be disappointed if these groups discontinue. They have made it clear that they are learning life skills that will help them in the future. Other students I teach learn coping skills in counseling sessions with him so they can make it through the school day. Beyond anecdotes, his services provide the intervention needed so that the children can focus on education and not choose the path of drugs, crimes, or teenage pregnancy, all of which would

cost the city more money in the long term than the prevention services cost now.

Comments:

GW has had a city counselor for more than two decades. In times of economic strife when families have to forego the cost of private counseling and extracurricular activities - if it was ever affordable for them keeping this school-based position is of a high priority. The city should consider alternative ways to keep funds for it: benefit luncheons, private grants, tax revenue, or even involving the youth in the fundraising process so they can take ownership in these services. The Alexandria City Public Schools have committed to make budget decisions that put children first and the City of Alexandria should do the same. I am deeply concerned about what will happen to the youth involved in the prevention groups or receiving counseling services should the budget cuts affect the city counselor position at GW. Maintaining it will ensure that there is no gap in our obligation to provide a community that fully attends to the needs of Alexandria's children. Prevention and intervention services are necessary for these children and will yield long-term savings and benefits for the community.

I understand that, in response to severe budgetary pressures this year, the City of Alexandria is considering the elimination of staff positions and the drastically curtailing of hours of operation of the Local History Collection of the Alexandria public Library. While I realize that the current deep recession will require painful cuts in all areas of city government, I urge you to do everything in your power to minimize the damage to the Local History Collection.

Over the past several years, I have had numerous occasions to visit the Barrett Branch of the Alexandria Public Library to make use of the holdings of the Local History Collection. These include many unique records, some dating back to the city's origins more than two and a half centuries ago. My visits have occurred at random hours and on random days, and each time I have been only one among a significant number of patrons using these services. The expert and knowledgeable staff have always been uniformly and willingly helpful, enabling me to accomplish my research efficiently. If staff positions are cut too far, I fear that the institution may not be able to recover when the economy again improves, as it surely will. 





understand that this is a difficult budget year, and I wouldn't write this unless I felt it was important. But I am concerned about the proposed cut of more than one-third in the city tree budget for contracted services for tree removal and pruning (about \$181,000 out of the current year's \$495,000). Contractors do most of the tree maintenance on city streets and in parks and other public areas. About \$350,000 of the \$495,000 budget went to tree removal in the most recent year. Tree removal is the top priority, because of the need to remove downed or unsafe trees. Yet if the need for tree removal is at the same level in fiscal year 2010, the budget cuts will mean that the pruning of trees in public areas could effectively be eliminated.

Proper care is critical to the health of an urban forest.

Lack of care undermines the investment we make in planting trees in the

first place. I urge you to ask staff about the repercussions of so severely cutting the tree maintenance budget. Is this a case in which because of short-term cuts, we end up paying even more in the longer run to repair the damage?

The new Urban Forestry Master Plan (in the city manager's possession for some months now) makes clear that we have been significantly underinvesting in tree care for a long time, and this is contributing to the declining health of our urban forest as a whole.

The plan also makes

Comments:

clear that while we have been busy designing an Eco-City Charter and an Environment Action Plan and winning awards for our "green" initiatives, the city has actually become less green—literally. In just this decade, the overall tree canopy has declined from 34% to 30%. The tree cover is expected to decline even further without a significant new city investment. According to the report, "Failure to make this investment could have serious long-term consequences for the city's environmental quality of life."

I realize that you can't provide the investment called for in the report right now. But our tiny arborist staff is struggling to meet even its very basic responsibilities. Virtually all of staff time is spent reacting to problems or potential problems. Virtually no time is devoted to proactive activities designed to enhance the urban forest.

I suggest

that after the budget work is done that you ask staff for creative suggestions for how we can move forward—planting more trees and caring for more trees—even in a difficult fiscal environment. Could the day-to-day responsibilities of our three arborists be altered in ways that allow them to focus more on tasks that will enhance our urban forest? What is the possibility of developing public-private partnerships with civic or business groups to plant more trees and care for more trees? How can we make more effective the contributions of the budding volunteer group, the Tree Stewards of Arlington and Alexandria?



The proposed city budget proposes not opening the Colasanto pool in fiscal year 2010 because of inadequate use and the high costs of maintaining an older pool. The pool is only open during the day on weekdays for a couple of months in the summer. It seems to me that this pool would get much wider use if it was open at different hours, say from late afternoon to early evening on weekdays and during the day on weekends. I'm curious as to what people think about this pool and whether it is worthwhile trying to save.

The city is now considering doing away with some of the existing outdoor pools in the city and replacing them with spray parks. But this would not happen until fiscal year 2014, and the plan is to replace the pool at Ewald Park with a spray park. But even that plan depends on money, and there is a big shortfall in the city's capital budget projected for the next five years.

I agree that Colasanto pool is much better for young kids than Warwick. I have long been disappointed that we can't use it more because of the schedule. My daughter and I were only able to go three times last summer when I took days off from work and so we were home when the pool was open. For what it's worth, all three times I thought that it was fairly busy without being overcrowded. We did use the Warwick pool in the evenings and on weekends, but I would have loved to have been able to have the more clam (and certainly more walkable for us) Colasanto pool as an option. I would love to see it available for use (by kids, not just adults) on the weekends and during weekday evenings. As others have said, I wouldn't be adverse to paying for it, either. WRT the question about what is the basis for our belief that more people would use the pool if it were open other hours, that can only be anecdotal, but could easily be beefed up by an unscientific poll. My children and I have used the Colassanto pool every summer except last summer. My children and I go to the pool together; I go with just my youngest; or my older children take my youngest. My information is based on my past observations and not information I received directly from the city. The pool is a neighborhood pool that is open to children 14 and under and parents/guardians accompanying younger children. There is no charge to use the pool. Most of the children who use the pool are African-Americans and Hispanics. The lifeguards, I think, are employed by the city just as lifeguards at the Cameron Street/Old Town and the Warwick pools are. The Warwick pool is a city pool not limited to use by residents in Warwick Village any more than parks in one part of town are limited to nearby residents. Stephanie Campbell <sjcampbell@comcast.net

I would be very sad if the Colasanto pool closed. I have two children, and we went there almost every day. Colasanto does not get the busloads of kids or adults and teenagers playing basketball like Warwick and so it's easier to let my kids practice swimming. It's relaxing.

Most days that we went to Colasanto pool it was pretty crowded--particularly in the afternoon. It closes earlier than Warwick and in the summer of 2007 some days when we would show up it would be closed because they had difficulty staffing it. That didn't seem to be a problem during the summer this past year.

I do think the pool hours and rules could be restructured if needed. Right now, Colosanto is for children, which is great. It's also free. I'd hate to see some kids be turned away because they couldn't pay, but I would have been happy to pay as much as I do at Warwick (if not more). Maybe it could remain a free pool for kids during the day during the week, but adults could pay in the evening hours and on weekends. I would LOVE to have access to a pool later in the evenings.

As far as the splash park goes, as nice as they are, I'd rather not see a pool become a splash park. I love this area, but having grown up at the Jersey shore, I get a little sad when the hot, humid days of summer hit. I don't want to sit in the air conditioning, and I don't want to run around at the splash park in my bathing suit. Getting in the Colasanto pool with my sons brought back a love for summer I had been missing.

We live very close to Colasanto pool but don't use it as a family. That being said, Creative Play School uses it quite frequently and it would be a real loss for them. It might be better used, as suggested if the hours were better.

We would be very upset though if they closed the Olde Towne or Warwick pools. Having moved from Falls Church where there were no public pools, and not having the budget to join a private pool, we have found these public pools to be a blessing. If we have a voice in this we would certainly argue against closing them. markaudra@verizon.net

The City operates the pools themselves. Many of the managers/head lifeguards are local teachers, either in Alexandria or Fairfax County. The lifeguards are usually high school and/or college kids, so they tend to be short-staffed by Labor Day weekend - it's unfortunate, since the pools could probably remain open on weekends only through September (I've lived in condo/apartment complexes where this occurred, since the weather is usually good).

I don't have kids and thus, have never had occasion to utilize the Colasanto pool. It seems like extending hours, even once or twice a week, would do a lot to boost attendance.

That said, I'm a regular on the weekends at the Warwick pool, which is usually packed on Sunday afternoons. Saturdays tend to be hit or miss - depending on whether it's a holiday weekend, the weather, etc. Unfortunately, there does not seem to be a concerted effort by the City to improve the pool; to the contrary, the City seems reluctant to spend any money or effort on the pool - there are about 1/3 of the needed amount of lounge chairs there (no matter how empty/crowded the pool is, there aren't enough seats), there have been no upgrades to the pool (other than paint) in my 6 years in Del Ray, the diving area is not always open, there is no dedicated lap lane, there always seems to be an excess of lifeguards doing nothing, kids/tweens are allowed unaccompanied by parents, the rules aren't always clear, and even when the rules are clear, they aren't always enforced.

Regardless of my complaints, I enjoy having access to the pool and utilize it as often as possible. I'd be happy to pay more for the privilege if it led to improvements. IMO, this is a community, and the pools are just another part of that - it's a place to see your neighbors and meet new people. Just like everyone has a vested interest in improvements to our schools, parks, business district, and homes, it's

important to keep the pools well maintained. Beyond that, I don't have any answers.... halliebrok@aol.com

- What is the basis for believing that if the hours were extended, dual income parents would utilize the pool more?
- Could the Warwick Village pool be made more attractive to non-Village residents?
- Colosantos Pool is in poor condition, as are the tennis courts.

We have never gone to Colasanto because the hours are not congruent with our working schedule. However if they were to change them to those similar to Warwick Village, I would much prefer walking 3 blocks versus getting in the car to go to the OT or Warwick Village pools.

One thing for the city to consider is that swimming is a life skill - one that everyone should have. We live in an area with a lot of water and having the ability to swim can save lives. Even the small pools such as Colasanto can provide a place for people to become comfortable in the water so when a situation occurs they do not panic.

Closing pools for 'spray parks' while it would save funds doesn't sound like a good idea to me. Again, if they changed the hours I think a lot of people in Del Ray would use the small pools, even for a fee.
