

SUBJECT: RESOLUTION ESTABLISHING A COMPLETE COUNT COMMITTEE FOR THE 2010 U.S. CENSUS

ISSUE: The establishment of a Complete Count Committee for the 2010 U.S. Census to ensure an accurate count of the City's population.

<u>RECOMMENDATION</u>: That the City Council:

- (1) Approve the resolution (Attachment 1)establishing an Alexandria Complete Count Committee;
- (2) Authorize the Mayor to select a person to serve as Chair of the Committee; and
- (3) Authorize the City Manager to solicit and appoint members to the group.

BACKGROUND: The United States Constitution requires the Federal Government to conduct a national census every ten years. The next Census will be in April of 2010. In order to make this census as accurate a count of the country's population as possible, the U.S. Bureau of the Census has requested that local governments to establish "complete count committees." The purpose of these committees is to encourage local residents to participate in the Census. In light of the Census Bureau's request and because the City has been undercounted in the past, there are good reasons to establish and fund an Alexandria complete count committee for the 2010 U.S. Census. The committee will need to be established by the late spring of 2009.

For the 1990 U.S. Census, the last census for which undercount figures are available, Alexandria had an estimated undercount of 3,281 people or 3.0% of its official 1990 population. As was often the case in other jurisdictions across the country, the undercount was highest among minorities with an 8.6% undercount of the City's Hispanic population and a 5.12% of the City's Black population. People under 18 were also undercounted with 5.8% of the City's youth population not counted. As a result, minorities and young people especially should be targets of the 2010 Complete Count Committee's efforts.

The City's official population figures for 1990 and 2000 were not adjusted by the federal government to take into consideration population undercounts. A similar undercount for 2010 will have two effects. First, it will mean less money from the Federal Government which often distributes certain monetary grants based on Census data. Second, a more accurate census count rather than one with a large undercount allows the City to plan its programs, services and land use with more confidence and accuracy. The ability to plan is further jeopardized because future periodic between census American Community Surveys will use the 2010 U.S. Census as a base and if the base is inaccurate the data from future surveys will also be inaccurate.

DISCUSSION: The Alexandria Complete Count Committee (Committee) should represent a broad cross section of Alexandria's population. It is particularly important that the Committee have strong representation from civic associations, community-based organizations and organizations that serve the population that is most likely to be undercounted.

The Committee will work together to develop a program to educate and promote public participation in the upcoming Census. Highlights of Alexandria's 2000 Complete Count Committee's program included:

- Representatives of 33 organizations located in the City formed the 2000 Complete Count Committee.
- Sent out post cards to Alexandria's residents reminding them to complete and return their Census questionnaires.
- Printed and distributed leaflets in neighborhoods that may have poor response rates.
- Addressed church and civic groups about the need to have people complete the Census form and distributed leaflets to these groups.
- Created posters in four languages encouraging people to complete their Census forms and placed them on Dash buses and in shop windows.
- With the cooperation of Arlington County, the Complete Count Committee published a comic book about the Census and distributed the comic book to school children in the City so that they could make their parents aware of the need to complete a Census form.
- The City's Complete Count Committee held two Census awareness fairs in Alexandria neighborhoods with large minority populations.
- Purchased advertising in newspapers geared toward minority readership asking people to cooperate with Census enumerators

Proposed Complete Count Committee Composition: It is proposed that the Complete Count Committee consist of members representing neighborhood civic associations, community-based organizations and nonprofits, business organizations, and city agencies. A list of groups represented on the 2000 Census Complete Count Committee is attached to the memorandum (Attachment 2). Of the 45 groups identified on the list, 31 people participated on the committee.

<u>Appointments</u>: It is proposed that the Mayor will select a person to serve as Chair of the Committee and the City Manager will solicit and appoint the members of the Committee.

<u>Staff Support</u>: City staff will provide support to the Committee lead by staff of the Planning and Zoning Department. For the 2000 Committee, staff from other City agencies that participated include: Police Department, Health Department, Department of Mental Health, Mental Retardation & Substance Abuse, Human Services, and Recreation, Parks and Cultural Activities.

FISCAL IMPACT: For the 2000 Census, City Council provided a budget of \$25,000 for the Complete Count Committee. For 2010 a budget of \$30,000 would support about the same level of effort. This represents a 20% increase over 2000, which is less than overall inflation (which was 27% over the period). Postage and printing provide examples of increases in costs since 2000. The cost of sending a post card has risen 35% since 2000 increasing from 20 cents to 27 cents. The costs of printing have also increased.

A conservative request for funding is being made because of the City's current budgetary situation. Since the 2010 Complete Count Committee has yet to be appointed, a work program has not yet been developed. The Committee's projects may include programs similar to those of 2000, but also might include new technology such as YouTube which would be affective in reaching younger people (and is free). Not all of the City's 2010 Complete Count Committee's activities can be expected to be free, which means that funding will be needed for the Committees' work to be successful.

If Council through the FY 2010 budget process determines that \$30,000 is available for this effort, then a targeted work program can be developed.

Staff estimates a minimum of 500 hours of City Staff will be needed to support the Committee. The estimate consists of staff time that will be spent on meeting preparation, post-meeting activities, meeting attendance, community outreach, and preparation of the annual status report.

RESOLUTION NO.

WHEREAS, the United States Census Bureau will conduct a decennial census in the spring of the year 2010; and

WHEREAS, the Census Bureau believes that there has been a substantial undercounting of population in Alexandria in previous censuses, and that there will be a substantial undercount in the year 2010 unless an effort is mounted to encourage the public to participate in the Census; and

WHEREAS, the City Council wishes to establish a Complete Count Committee charged with the responsibility of ensuring that all City residents participate in the year 2010 Census.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF ALEXANDRIA, VIRGINA THAT:

- 1. There is hereby established an ad hoc committee known as the Alexandria Complete Count Committee ("Committee").
- 2. The Mayor will appoint a Chair of the Committee and the City Manager will appoint the members.
- 3. The Committee shall consist of up to 35 members representing a represent a broad cross section of Alexandria's population. It is particularly important that the Committee have strong representation from civic associations, community-based organizations, the business community, and organizations that serve the population that is most likely to be undercounted.
- 4. The function of the committee shall be as follows:

(1) Consult with the Bureau of the Census and other persons who can provide estimates about what groups have a high likelihood of being undercounted in the year 2010 Census;

(2) Establish a list of groups that will be targeted for priority attention in an effort to encourage their members to be counted in the year 2010 Census;

(3) Develop a program to encourage participation in the year 2010 Census by the public generally, and by the target groups in particular; and

(4) Prepare recommendations to the City Manager about expenditures of funds to accomplish item number 3 above in an amount not to exceed the funds appropriated by City Council.

5. The Committee is empowered to adopt rules and regulations in regard to procedure and other matters so long as the same are not inconsistent with the City Code including, but not limited to, the establishment of subcommittees through which it may carry on its functions and purposes.

6. The City Manager shall appoint such staff to provide administrative and logistical support to the Committee as the City Manager shall deem necessary and appropriate, subject to the availability of funds and staff.

7. The Committee shall prepare a report of its work upon completion of its activities and submit the report to City Council.
