

- Energy Efficiency Block Grants -\$1,372,800
- Homelessness Prevention \$512,214

- Byrne Justice Assistance Grants \$323,939
- Workforce Investment Programs \$173,400
- Senior Nutrition Program \$30,213

### **Competitive Grant Programs**

- Violence Against Women Act applied for \$500,000 to provide transitional housing and support services to victims of sexual or domestic violence.
- Proposal was made in partnership with the Arlington-Alexandria Coalition for the Homeless.

## City "Liaison" Group Funding

- Alexandria City Public Schools (over 2 years) \$8,364,857
- Alexandria Redevelopment and Housing Authority - \$1,791,960
- Alexandria Neighborhood Health Services, Inc. - \$300,177

#### Short Term Plans for Grants

- Transitional Housing Program for victims of sexual or domestic violence already mentioned
- Byrne Public Safety Grant application due May 18; plans for projects must go to Council this week

# Short Term Plans for Grants (continued)

- Application for Energy Block Grant due May 26
- City must adopt an Energy Plan before it can draw down significant funds
- Energy Plan will be developed in-house to conserve City allocation for other purposes

# Short Term Plans for Grants (continued)

 Staff is also working with Councilmen Krupicka and Wilson to investigate the possible use of a portion of the City's energy block grant funds to set up a loan program for City property owners who want to make clean energy improvements

#### Council approval of ARRA grants

- Staff is concerned about what are often short deadlines for ARRA grants
- Implementation committee reviewed several options for addressing this concern
- Discussed recommended option with Council Stimulus Subcommittee

# Subcommittee approved recommendation for grants

- ARRA-related grant funding applications will be exempt from the requirement for Council endorsement prior to formal submission
- Applications will continue to require prior approval of the City Manager, who will ensure appropriate coordination and identification of fiscal impacts

- Monthly summary reports will be given to Council
