REQUEST TO MODIFY THE MEMBERSHIP OF THE ALEXANDRIA-CAEN

SISTER CITY COMMITTEE

**ISSUE:** Request from the Alexandria-Caen Sister City Committee to convert the designated position for a representative from the Sister Cities Committee to a citizen position (Attachments 1 and 2).

**RECOMMENDATION**: That City Council (1) approve the request from the Alexandria-Caen Sister City Committee to convert the designated position for a representative from the Sister Cities Committee to a citizen position; and (2) request the City Attorney to draft an ordinance that makes this change for introduction at the first meeting in June.

<u>DISCUSSION</u>: At its April 13, 2009, meeting, the Alexandria-Caen Sister City Committee voted unanimously to recommend that the designated position for a representative from the Sister Cities Committee be converted to a citizen position. The position has been vacant for over a year and the Sister Cities Committee has no objection to the change (Attachment 3). Steven Rich, the new Chair of the Alexandria-Caen Sister City Committee, has indicated that the workload and time requirements of its activities are such that having a full complement of members is important. Mr. Rich also notes, as does Mary Jo Johnson, Chairperson of the Sister Cities Committee, that the Committees will still fully cooperate and coordinate with each other on exchange programs and projects. Therefore, I support this recommendation to convert the designated position into a citizen slot so that the Alexandria-Caen Sister City Committee has 17 members to work on its activities.
