Dear Ms. Boyd:

I write to thank you for your role in appointing me to the Alexandria-Gyumri Sister Cities Committee (AGSCC), a position I have held since September 11, 2007, with great pride both in the City of Alexandria and in the AGSCC's dedicated committee members. Regretfully, rules of my appointment require that I resign from the committee effective June 1, 2009, as I deploy to Iraq for a one year tour of duty with the United States Department of State.

As Chair of the AGSCC Grants Subcommittee, it has been my great pleasure to play a role in delivering modest funding to a truly worthy cause – approximately 80 orphans in Gyumri, Armenia, who will receive vocational training and food assistance as a result of our grants award. I am grateful to you, the City, and citizens of Alexandria for supporting our cause and attending our fundraisers.

I can attest to the difference we are making in these orphans' lives. I served as both a Peace Corps Volunteer and, later, as a Foreign Service Officer in Armenia, and witnessed first-hand the tremendous difficulties many Armenian children must endure. It makes me proud that our city – through volunteerism and humanitarian outreach – is doing something about it.

Civic participation makes this city a better place and I appreciate our local government's dedication to enabling its citizens to contribute. To that end, I would be interested in serving the city in a similar capacity when I return from my tour in Iraq. I would hope to consult with you to discuss opportunities.

Thank you for your support over these last few years, and I look forward to working with you in the future.
