<u>ISSUE</u>: Consideration of an ordinance to change the election of the Mayor and City Council to the November general election cycle.

RECOMMENDATION: None

<u>DISCUSSION</u>: On February 13, 2008, Mayor William D. Euille and Councilman Justin M. Wilson submitted a memorandum to the members of the City Council analyzing various issues (including the changing of the election date). The matter was deferred for later consideration and action.

Va. Code § 24.2-221.1 (1950 as amended) authorizes a city or town to move its election for Mayor and Council to the November general election date. Once the elections are moved to the November cycle, the then newly elected officials will commence their term on the January 1 immediately following the election. The code provision is a general grant of authority and does not appear to require any further Charter amendment.

The grant of authority is a limited one on the face of the statute. It provides that the elections may be moved from May to November but does not grant any authority to move the elections back from November to May. There is also an alternative proceeding that is authorized whereby the registered voters of the city or town may file a petition with the circuit court asking for a referendum on the question of changing the election to the November general election cycle. The two procedures are exclusive of each other and either one may be used.

Finally, if the elections are moved to the November cycle, the Mayor and Council Members then in office at the time of the new November cycle shall continue to serve until their successors have been elected and qualified to serve.





VOTER PARTICIPATION

WHY VOTING IS IMPORTANT

Voter turnout has been a problem from the very beginning. Even the inventors of democracy in ancient Athens had to let election officials corral voters with a red-dyed rope, herding them from the marketplace to the Assembly's voting area at the nearby Pnyx. Athenian officials in later years simply paid voters to attend the Assembly's. In contemporary Italy, those who fail to vote face the prospect of having their names posted by the mayor on the communal notice wall and of being branded a nonvoter in official papers. In California, a voting stub obtained after casting a ballot has entitled voters to a free half-dozen "Yum-Yum" doughnuts.

Carrots and sticks have been employed to increase voter turnout since the birth of democracy, in reaction to what rational choice theorists have termed "the paradox of voting": given the infinitesimal chance that one's own vote could affect the outcome of most elections or the stability of the electoral system, it often appears rational to abstain from voting. The paradox facing rational choice scholars is that many people do vote in the absence of visible carrots or sticks, although not in the same numbers in comparable elections or across state or national boundaries.

A defining feature of advanced democracies is universal suffrage: Everyone has the right to vote. However, not everyone exercises this right and voter turnout varies considerably, both over time and across countries and individuals. This variation is not random; across individuals, it is a stylized fact of the empirical voter turnout literature that better educated individuals participate more frequently in elections, as do those with greater wealth and higher incomes (Wolfinger and Rosenstone 1980).

"Unequal participation, whether in general elections or in direct democracy settings, has an important implication: First and foremost, political participation is an instrument of representation and, therefore, unequal participation can distort the pattern of representation necessary for democratic responsiveness, leading to real effects on policy outcomes. In an encompassing survey of voter turnout across countries and over time, Lijphart (1997, 1) concludes that "unequal participation spells unequal influence," and this stylized fact forms the basis of recent political economy models such as Benabou (2000). Second, participatory inequality is a problem if democratic participation is seen as an intrinsic good (Pateman, 1970) in addition to its role as a representational instrument, and it may create doubts about the democratic legitimacy of a given political setting."

VOTER REGISTRATION

Voter registration was introduced as a means of preventing voter fraud, but previous studies had concluded that a side effect was to reduce voter participation significantly (5%-10%). An extensive scholarly document identifies registration as a substantial barrier to voting. The logic is simple enough. Crudely put, people weigh the benefits of voting against the cost, and the higher the cost, the lower the participation rate (see for example Rosenstone, Steven J. and John Mark Hansen, 1993, Mobilization, Participation, and Democracy in America, New York: MacMillan Publishing Company). For some people, registration represents one more hassle that they do not feel strongly enough about to address. Others do not think to register until the final week of campaigning piques their interest in the election, long after registration deadlines have passed.

By use of more robust methodology and wider comparative, Ansolabehere and Konisky² conclude that the voter registration does have an effect, but that it is much smaller than what people think; in the range of 3% to 4%.

The authors conclude that reformers' disappointment about the modest impacts of the National Voter Registration Act of 1993 (NVRA) and other electoral reforms (Traugott, 2004³) might reflect biases in previous statistical estimates of the effects of registration on turnout, rather than failures of the laws. They draw an even more important conclusion that early on, voter registration did indeed negate the rampant voter fraud that was taking place, and therefore, it did reveal a significant impact in the early studies. But this is an effect that has significantly subsided as the fraud effect disappeared and in the long run, the cost effect having been isolated turns out to be quite small.

INFORMATION IS KEY

The scientific efforts to understand why voters turn out, or not as the case may be, begins with observed empirical regularities. Based in large measure on work performed by Wolfinger and Rosenstone (1980)⁵ which looked at education as a predictor of voting, Feddersen and Pesendorfer (1996, 1999)⁶ argue that informational differences among voters can help explain the observed variation in political participation.

In their models of single issue elections, uninformed citizens' optimal choice can be to abstain from voting, even if they prefer one alternative to the other (the swing voter's curse). Instead, they effectively delegate decision-making powers to informed voters, thereby increasing the likelihood of the optimal policy being chosen. Matsusaka (1995)⁷ and Ghirardato and Katz (2002)⁸ also consider the effects of being informed on the propensity to vote, but their explanation relies on subjective uncertainty about the quality of information and, hence, the risk of making the wrong decision, rather than through the strategic reasoning applied in Feddersen and Pesendorfer.

David Dreyer Lassen parlays this parleys this information into a complete seminal work in which he is able to discern the effect of directly educating a voter group about a referendum and compare it with a group that was not. He concludes that;

"Theoretical work, with roots in observational empirical studies of voter behavior, has argued that being informed affects the propensity to vote. Using a unique natural experiment referendum, where a random fraction of the electorate was exogenously informed, the empirical analysis presented in this paper suggests that information acquisition is endogenous and demonstrates that there is a causal effect of being informed on the propensity to vote in a referendum setting. The estimated effect is considerable: I find that the average treatment effect of being informed on the propensity to vote is 20 percentage points, which is more than the effect estimated by conventional methods."

This study further explains the often quoted relationship between the level of education and voting, because the more educated education enters directly into the calculus of voting by educing expected utility costs associated with voter registration and information acquisition, rather than through contextual or socialization effects.

NORM BASED VOTING SOMETHING WRONG IN THAT ARGUMENT

William Ricker and Peter Odershook using data collected by the Survey Center at University of Michigan (national Election Study) drew the conclusion that there was a strong correlation between voting and "sense of patriotic duty".¹⁰ This led to a host of studies into the field of comparing voting to a consumption article and the utility of feeling good about having voted.

This line argument has since been superseded by informational voting view found on page 4. Nevertheless, it is precisely the genesis for Governor Gilmore and the Republican state legislature deciding to grant Local jurisdictions the ability to move the Local elections to coincide with State and Federal.

The State and Federal elections have a higher turnout and the norm based explanation is that the Civic Duty is higher for those elections. Therefore, the logic goes that by coinciding them, voters will vote for the local as well as the State and Federal while in the booth. Recall that Virginia was a heavily leaning Republican state at the time the Republicans enacted this proviso. So, it is entirely fair to conclude it was designed largely on the belief that as the Federal goes so will the Local.

This is a rather simplistic election policy view, especially in light of the studies that have demonstrated the value of educating the voters about the issues. It is also why deep down the vast majority, including the task force created by the Mayor to study this issue, conclude that by moving the election date, the local issues will be lost. Current science tells us that it is dissemination of information not marginalization that will matter. The voters have national outlets for dissemination of national election information, the local have far fewer, which explains the disparate turnout. Further increasing the cost of getting information on local elections by marginalizing the local information flow does not help.

In essence it is not the cost of physically going to the polls that matter, it is the cost of getting acquainted with the issues that does.



Realizing, of course, that this is not a scientific poll and there is a certain margin of error, it is still a very overwhelming number and should be clear to anyone what the voters want.

I ask you to please

follow the advice of your own non-partisan commission, appointed by you, which recommended against this move in a 7 to 2 vote. A move like this by a lame-duck council is unconscionable. At the very least, put this on the ballot at our next election and let the voters decide.





If you decide to press



This effort, which will fundamentally change the way

Alexandria elects its leadership, will not increase voter participation. To the contrary, it will diminish the amount of time and energy that is spent focusing on Alexandria-specific issues--lumping our city elections at the bottom of a long list of offices for which voters must select candidates.

Further, to rush a decision on moving elections—without a full and thorough discussion with the voting public—is a serious and suspect mistake. At the very least, Council should vote against this resolution, or vote to table it until further public comment can be considered by the newly-elected council.

If Council's attempt is to increase citizen participation, there are many ways to accomplish this goal without fundamentally altering our election laws.

One suggestion is to ensure

that government and elected officials continually reach out and seek the opinion of constituents. An engaged electorate is an electorate that votes. Instead of shifting election dates, council should appoint a special commission on civic involvement. This commission should determine the most effective way of engaging the electorate and inspiring the citizenry of Alexandria to increase their involvement in local affairs, including but not limited to voter registration, town hall meetings, citywide customer service, citizen outreach, and accessibility to service on boards and commissions.

Another option would be to convert one version of the city newsletter to a printed sample ballot, mailed to each resident. This cost-neutral move could increase turnout by up to 10 percentage points for the May elections.

I look forward to speaking on Saturday about this issue, and again, I respectfully encourage you to vote against the effort to move our citywide elections.

Dear Mayor Euille and Members of the Alexandria City Council:

Unfortunately, I will be unable to attend the Council's public hearing this Saturday, June 13, 2009, on the proposal referenced above which would move future City Council and School Board elections from May to November. This proposal is limited to that movement of the month of the election and does <u>not</u> propose other changes, such as an increase in the term of Council or staggered elections for Council members.

I will be in Williamsburg on Saturday for the Democratic State Central Committee when we will accept the challenge and opportunity of the November, 2009 election to elect state wide Democratic candidates for Governor, Lt. Governor, and Attorney General as well as the majority of members of the House of Delegates. Because of this conflict, I want to get this letter to you to confirm my opposition to this proposed movement of the election date.

You may recall that I was a member of the nine-person Election Process Review Committee which was appointed to consider the Council and School Board elections process in the City. Our reasons for opposing this change were summed up in a report to you dated June 21, 2007. In order to refresh your recollection of that report, I have attached as Exhibit A hereto the portion on page 4 of the report dealing with the proposed date change from May to November. Please note that the vote in opposition to that change was 7 to 2 and that the vote did not break down along political party lines.

I continue to oppose the movement from May to December although such movement would in my judgment probably increase the chances of electing Democrats. I do not think our party needs that added advantage and that the general civic welfare is enhanced when the election is focused on local issues only rather than the combination of local with state or national issues. I believe that the standing of the Democratic Party as the majority party is enhanced when the general civil welfare is enhanced.

I have called other members of the Election Process Committee to urge them to attend the public hearing on June 13. Lynwood Campbell has confirmed that he will attend.

I also want to take this opportunity as the term of this Council comes to a close to thank each of you for your dedicated service to the City and its citizens.


Moving elections to November. The Committee¹ recommends that the City continue to hold Council and School Board elections in May. Seven Committee members (Hobson, Davies, Calhoun, Campagna, Campbell, Cleveland, Henley, and Woodson) voted to retain May elections. Two (Calhoun and Leider) prefer having the Mayor and Council elected for a 4-year term in November, in the year before each presidential election year (this is the odd-numbered year in which all General Assembly members are elected; it is also the year when many Virginia counties hold their elections for Boards of Supervisors).

Several years ago, the General Assembly authorized cities and towns, which have traditionally held elections in May, to move them to November, when most national, state and county elections are held in Virginia. Since then, some City residents have suggested that turnout for City Council and School Board will be increased if these elections are held in November, when voter turnout is higher (turnout for the last 3 Council and School Board elections has ranged from 20 to 27 percent, while that for November elections is usually 40 to 50 percent, except for presidential elections, when it increases to 75 to 80 percent).

The Committee considered the value of increased turnout, but heard from some residents the concerns that (1) the consideration of local issues would suffer when joined at the November election with federal and state candidates and issues, and (2) the increased turnout would be made up primarily of voters who were uninformed about local issues. Based on this and other concerns that were expressed (such as the difficulty local candidates would have in attracting campaign contributions and volunteers in the fall), the majority of the Committee agreed that elections should not be moved to November.



Dear Mayor Euille and Members of City Council:

I regret that I cannot be present at the public hearing this Saturday. I write to you as a former member of the City Council and as a member of the Council-established Election Process Review Commission. You have received an e-mail from the Chair of that Commission, Richard Hobson, expressing opposition to any change and an excerpt from the Commission's Report on this issue. I agree totally with Mr. Hobson's comments and would add the following.

First, I do not see the need for the change. Although most Virginia cities that have elected a change to the November election cycle have done so to save money by eliminating an election, the motivating force here from certain members of the Council is the low voter turnout. This is said to be due to the fact Alexandria voters "are not used to Spring elections." The media and certain civic groups routinely deplore low voter participation. However, it is not obvious that pumping up the numbers leads to better government if the additional number is made up of voters who not concerned with the governing of the City but are more focused on national or state issues. Further, I am not persuaded that a low turnout is due to the timing of the election. Alexandria is a relatively well-governed City and for many people there is nothing to motivate (read, make them upset or angry) them enough to vote. A further factor, noted by several speakers at the Commission's public hearing, is the lack of electoral competition. As one speaker put it, why bother to vote if you know that the Democratic caucus often decides the election. As the recent election has shown, this is not always the case; however, moving elections to the Fall is bound to make such competition more difficult.

Second, there is no real public support for this change. At the public hearing held by the Commission, there was little support for changing the date, largely for the reasons summarized in the Commission's Report. What little support the idea had was usually coupled with support for other changes in the election of the Mayor and Council. As Mr. Hobson's e-mail notes, the Commission voted **down this change by a vote of 7-2**. I am shown as, in effect, voting twice

since I do not have a problem with a Fall election, provided certain other changes are made such as keeping the elections out of the Federal cycle, some form of a district system, etc.

Third, I question the timing. This subject received very little attention in the recent Council election, and this Council has no mandate to consider it. Since, it cannot take effect until 2012 in any event, a respect for the decisions of the voters would suggest that it be left to the new Council for consideration. At the same time, I would hope that other changes, which require Charter amendments, could be considered. In this connection, the argument that Charter changes are too difficult is, in my opinion, a false issue. Most larger Virginia cities have made changes in the structure or size of their City Council through a Charter change. In my experience, if such changes have the support of the legislative delegation, they will easily pass the General Assembly.

No further action should be taken on this Ordinance.


Lastly, in order to truly move

On Moving Local Elections from May to November:

Dear: Mayor Euille, and Members of the Council,

I am concerned and wary about the idea of switching our city elections from May to November.

Those who typically support moving elections normally do so in support of an admirable goal: increasing voter turnout. Unfortunately in our case, it seems in part that moving the Alexandria city elections from May to November is being driven by a small minority's selfish political agenda.

While we all agree there is a need to increase voter turnout, the fact is, however, that changing the election from May to November is not a solid means to the end. If we increase turnout numbers through moving a date, we will also gain more voters who are unfamiliar with the candidates, policies and issues that affect Alexandria. If we encourage apathetic voters to vote for city council simply because they are on the same ballot as President or Governor, is our great city really benefiting? I say no.

As many of us know, Alexandria is a very transient city. Where I live in the West End, we are thriving with young professionals, immigrants, students, interns, just-married couples, recently divorced or widowed middle-aged folks trying to start over, and people moving to the area from out of state, all of whom continually cycle through my apartment complex for one, two, or even three years. These people will register to vote and do so for the President, because he manages the whole country, or the Governor because he or she manages the entire state, or even for Congress and U.S. Senate because they have broader districts and constituencies. Even though these people plan to move, odds are, those for

whom they vote in November will still have the chance to represent them, and shape policy that affects them. These are the people-who-live-in-Alexandria. They have no desire to engage local politics, elections, community organizations, budget, taxes, schools, etc.

It is important to note that people-who-live-in-Alexandria are different from *Alexandrians*. *Alexandrians* are actively engaged in the issues most important to our great city. They care about the school system and may have children in it; they have decided, at a minimum, to make Alexandria their home for the mid to long term; and they want what is best for Alexandria because they plan to have their future here. For *Alexandrians*, Alexandria is not a temporary residence; for *Alexandrians*, Alexandria is home.

Because they view Alexandria as home, Alexandrians vote in local elections, while the people—who—live—in—Alexandria do not, because they know their stay will be for a short time period. So the question is: should people who live in Alexandria for a short time period, who have no intention of staying or being actively involved in our community really alter the course of city politics? Please realize that these voters will be voting for a party, not a candidate based on his or her policy initiatives. These one—party voters won't bother with finding out the valuable stances and issues behind the candidates. Should our city's future be dictated by people who vote for candidates based solely on party affiliation without regard to what is important to our city, or even worse vote with any random uninformed method?

Granted, more people will vote in November, but the increase in voters will very likely be less informed. If locally elected officials want better voter involvement then they must find ways to actively engage the constituents. Holding more town hall meetings, open mic forums, tele-townhalls, or more actively campaigning, sending quarterly newsletters or going door-to-door in non-election years, etc. will help reach our goal. It will lead to increased voter turnout and it will create a more knowledgeable and engaged electorate.

One more reason we should continue the tradition of May elections is that it is important for the legislative body to be connected closely with the electorate. May elections best suit Alexandrians and our form of government. If we switch to November elections, the elective offices will be coupled with any number of other offices that will undoubtedly and understandably garner more media attention and spend a lot more money.

In today's elections it is not uncommon for a State Senate candidate to spend \$750,000 and a state delegate candidate to spend more than \$100,000. With fall elections being monetarily over inflated, it would be difficult for local candidates to raise enough money to raise their name ID, let alone run a solid campaign. Their mailings would be lost in the wash, and their efforts would be in vain. It would feed a situation where people with name ID, usually incumbents, would easily win reelection. At this point the voters would no longer be voting based on policy, rather on name ID, party affiliation, or worse, randomly. The voters would likely become more detached and disengaged. Over time, the inability to

raise funds and campaign effectively would drastically decrease the number of challengers and quality of candidates. Though some people say it will be convenient, adding two more elective offices with upwards of 15 candidates for City Council and six for School Board per district to the fall ballot could potentially create voter fatigue as well as voter disengagement.


Furthermore, in today's political arena, we are quite far removed from our representatives. In our form of federalism, the citizens are supposed to be closely connected with their legislatures. In fact, the most sacred level of federalism is the closest to which the people are, in this case the local level. If we disengage our voters by moving the elections to November, Alexandrians will lose that close and sacred bond with their locally elected officials.

Holding our city elections in May is the logical way to engage Alexandrians, and truly represent the people who are engaged in the community. With May elections, the candidates are more likely to engage the voters with their policy and messaging without being overwhelmed by larger, more media-centric offices. The local candidates would be able to understand their electorate better and separate the Alexandrians who care about their city from the people-who-live-in-Alexandria and do not plan to make our city their home.

Ultimately, we all seek higher voter turnout, but I submit that the few extra voters we would see if we change the date of the election would not equate to better voter engagement, participation and good governance. Keeping the elections in May is crucial to assist the candidates in effectively engaging Alexandrians with their message and provide the voters with the knowledge to elect the Mayor, City Council and school board members they believe will best lead our city and maintain a close electoral bond. For all of these reasons, I urge the City Council to continue holding local elections in May.

Dear Mayor and City Council Members:

I am writing to express my disappointment that again this council is considering moving our local Alexandria elections to November.

As you know I was a member of the commission you established in 2007 to consider this idea. The commission was bipartisan and included several former elected officials. The commission's opinion: keep the local elections in May. I concurred with the commission's opinion.

Citizens in Alexandria know me to be an avid supporter of democracy through citizen engagement in public policy and public affairs. I do not agree with council members who believe moving the local election to November enhances democracy. In fact, I do not think moving the election has anything to do with democracy. I would like to share my opinions and my questions:

- 1. Voters are not disenfranchised they are disinterested. Whose fault is that? In part it is the voter's fault for not taking democracy and their right to vote seriously. In part it is the politicians fault for not giving voter's a reason to be excited about an election. In the absence of spirited debate and diversity of thought at all levels in the democratic process, to include running for office and serving in office, some voters may become disinterested.
- 2. Getting attention will be much more difficult for local issue in the fall when the line-up is top-heavy with higher-level elections. This increased level of attention scarcity will make each candidate's cost to run that much higher.
- 3. Raising money for local elections will be much more difficult due to competition with higher-level office races. Increasing the cost of an election will adversely impact minority candidates.
- 4. Why is it okay to have primaries in the spring but not okay to have elections in the spring? Why not have primaries in the fall and the election the following fall if the primary reason to move the election to the fall is to increase voter turnout?

- 5. What about the school board election? School board elections are at the same time as the city council elections but the total school board vote is not the same as the total city council vote. Why were at least 2000 fewer votes cast for school board members? Voters are enfranchised to vote for everyone on the ballot but they don't. I believe school board attracts less attention and so garners fewer votes. Is it possible the same people who vote for city council in the spring will be the ones voting for city council in the fall? Is it possible the people who vote for city council or school board do so because they are interested in those elections, know the candidates and know the issues?
- 6. Will school board candidates have a chance of getting their message across in the fall crowded as the ballot will be with other races? We have had a difficult time electing minorities in each contested school board race since we switched from appointed to elected school boards, yet minorities make up over 75 percent of the school population.

Yes, more voters vote in the fall, but it is not because they are only enfranchised to vote in the fall. I believe if candidates give voters a reason to become more engaged and if the effort to get people interested in voting and civic participation is not limited to "elect me" campaigns every three years, we will see more voters turnout no matter when the election is held.

I fear moving the election to the fall will dilute local issue, adversely impact minority and independent candidacies due to increased cost, and ultimately serve to silence dissenting community view points from rising above the din of political committee machines.

Democracy is not supposed to be about one political party gaining advantage over another political party. It's supposed to be about giving people the power to determine their destiny. If greater voter participation is truly what you seek then put out the effort to get and keep the electorate involved everyday – and not just when you are asking for their vote.

GO BACK TO THE FUTURE

The purpose of my remarks are to persuade the city council to reinvigorate democracy in Alexandria not so much by changing the date on which local elections are held, but more by restoring the manner by which council members are elected.

Changing the season from spring to fall in which elections are held is just kicking the can down the road.

Certainly, simply combining our local elections with national ones will--

- A. increase the number of votes cast for both despite running the risk of confusing voters with a plethora of choices, and
- B. will allow the city council members to focus in May on its fiduciary responsibilities instead of electioneering

However, if the city council wants to...

- -- make its members accountable to the voters; and
- -- give residents a single council member elected solely to represent the interests and needs of the community in which they live;
- -- drop the façade that Alexandria is a small village for which At-Large elections are ideal;
- -- eliminate the legacy left by Jim Crow to keep minorities from being elected to city council
- -- go back to the future by re-establishing the manner of electing council members by wards as it was done in the time before Jim Crow
- -- buttress civic associations focused on neighborhood issues
- -- give fundamental reasons for city residents to vote in local elections because the outcome determines whom among their neighbors will represent their community interests on city council,
- -- then the council should seek authority to--
 - 1. change the city charter moving the date for local elections from spring to fall, and
 - 2. change the manner in which council members are elected by re-establishing wards
 - 3. require council candidates to live in the ward whose interests they seek to represent on city council, and
 - 4. tailor ballots so each ward allows voting only for the contenders within that ward; not for every candidate city wide.

RESULT: Neighbors are engaged, voter turn-out increases, democracy is re-invigorated

Local Elections

The proposal either to move the election to another month will probably increase the number of votes cast, but it won't invigorate our local democracy or establish a compelling reason to vote.

The anemic voter turn out for the last city council election didn't have anything to do with the month, or the number of days allowed to cast a vote, or the issues. It had much to do with the pointlessness of voting in the first place.

Frankly, if residents can't select from among their neighbors someone to their city council person, then why bother voting in a local election, especially since the election outcome is preordained?

Let's face it: the great majority of Alexandria residents align themselves with or are in fact proud members of the Democratic Party. There's nothing wrong with this fact, especially if you are a Democrat running for public office.

However, what it means in practical terms is, if the Democratic Party caucus anoints you for a city council seat, it's almost certainly yours. The act of voting is just sop to those who still believe in democracy.

Several cycles of this process of having a political party caucus effectively appoint members to city council has spawned apathy, frustration and disinterest.

It also means its pure theater when candidates listen to voter concerns, explain solutions to vexing problems or take stands on anything. The poor community turnout for the recent candidate forums is testimony.

The solution is for the Democratic Party, which controls the city through its party member, who occupy all but two of every elected city office, to change the city charter to enable future city council elections so contenders are elected by wards, not at large.

This will ensure our city council is composed of individuals who really represent their neighborhoods, who know personally its issues and a lot of its residents, who walk their dogs on its streets, who know where the potholes are and where a small park could be located.

Moving the council elections to November will increase the number of votes cast for contenders for city council if for no other reason than more voters show up for these elections.

However, unless the Democratic Party lets residents of Alexandria select neighbors from their communities to represent them on city council, then changing the month within which these elections occur will be all that changes.

Once again there was low voter turnout for the Alexandria City Council elections. And once again there is a call to move the elections from May to November as a means to increase voter turnout.

I agree that something should be done to increase voter turnout, and moving the elections to November will, in some years, increase the turnout substantially.

But we are not just talking about voter turnout. If we were, then the answer is simple. Move the election to coincide with the presidential elections – period. But in fact, that is not what is being proposed by at least one council member. Reasons are being given for using the odd-year elections, implying that there are other factors to be considered.

And the truth is that there are many factors to be considered, but those arguing for this apparently simple change of May-to-November are focusing only on simple changes to our election process in order to make the election cycle math work out. Also, most of their arguments lack any references to actual studies, or draw on results from national elections, or include phrases like "having faith in the voters."

I found Poul Hertel's analysis of the importance of information acquisition by the voters to be very interesting, and consistent with the results of a nationwide survey by the PEW Research Center (people-press.org/reports/pdf/292.pdf) which indicates that 76% of rare voters and 60% of intermittent voters "Know little about the candidates." Not surprising, especially when you consider some of the sources of election information in the city:

- According to the city's adopted mission Strategic Plan, government "engages the entire community as it plans for the future." Then why was the fyiAlexandria newsletter, which was sent to all the city's residents, mailed after the election. It had a nice article telling us the results of the election, but wouldn't have done more to "engage the entire community" if it had been sent out before the election and encouraged everyone to vote on May 5th.
- It is my understanding that in general the candidates don't send their literature to every household, rather they target their mailings.
- The elections were covered in the local newspapers, but many people don't read the local papers - plus even if every Gazette Packet was read, they only have a circulation of 15,000.
- All those campaign signs were not much help either. I don't believe any experienced candidate had the date of the election on their sign. To their credit, most (all?) of the new challengers did.

So if a person didn't get a mailing, or read a local newspaper, or see a new challenger's sign, then there is a good chance they didn't know the election was on May 5th, let alone know anything about the candidates, the issues, etc.

This is not to say that the problem is that voters were confused by a May election. It is true that everyone learns that federal and state elections are in November, but "The timing of local government elections varies enormously in the United States." (*The Timing of Elections*, Christopher R. Berry & Jacob E. Gersen). Delaware County, PA, where I grew up, has local elections in the spring, as does the city of Pittsburg. In New York, 533 out of 563 villages in New York hold elections in the spring. In California, 19% of the cities hold their elections in the spring (*Municipal Institutions And Voter Turnout In Local Elections*, Zoltan Hajnal & Paul G. Lewis), including Los Angeles. This was hardly meant to be an exhaustive list. There are over 87,000 local governments (*Encyclopedia of U.S. Campaigns, Elections, and Electoral Behavior* by Kenneth F. Warren) in the US. The vast majority of them do not hold November elections (*Transforming Votes into Victories: Turnout, Institutional Context, and Minority Representation in Local Politics*, Zoltan Hajnal & Jessica Trounstine). Alexandria is hardly an oddball.

The problem of low voter turnout has many facets that we have not touched on at all. Studies show that voting districts, the council/city manager form of government, and non-partisan elections tend to reduce voter turnout. The tendency of voters to not get to the end of a long ballot is well documented. Some studies show that the non-voters tend to think the same as those that vote, so that increased turnout rarely affects the results of an election. Other studies confirm that minority representation and access to government goods and services are helped by increasing voter turnout, although interestingly, some minorities are helped more than others. The studies also say that increasing voter turnout does not ensure greater civic engagement, and that the concerns that aligning local elections with state and national elections would draw attention away from local politics and issues are real.

The National Civic League has developed the 8th edition of the Model City Charter, a publication that has profoundly influenced local government structure since NCL printed the first edition in 1900. In the current edition, they state, "Traditionally the Model has advocated separating municipal elections from state and national elections to allow a clear focus on local issues. State election laws and city charters frequently schedule municipal elections in the fall of odd-numbered years or in the spring of the year. However, recent evidence suggests that turnout is higher during state and national elections. Some now advocate moving local elections to coincide with state and national elections to increase participation in local races. The Committee that developed the Model recognized the trade-off involved with each choice and decided not to express a preference." (emphasis mine)

And that's the point! There are trade-offs and potentially unintended consequences, and we have not done our homework, not now nor with the previous election committee. We have not truly identified and brought all the issues to the table, discussed and debated them, and reached a consensus. A hand full of opinion pieces in the local papers, a blog

or two, even this public hearing, hardly constitute a serious public debate. We deserve better! Charter changes involving the fundamental right to vote should involve significant public participation and discourse. That way, when the request is sent to Richmond, it can be said to truly represent the desire of the electorate.

We are an award-winning city with a AAA bond rating and various programs that are considered as models to be emulated. Given the status of things in the City, the history of our City and the influential people that have lived here over the centuries, I would hope that if we are going to alter the election process and other aspects of how we are governed that we find solutions that are uniquely Alexandrian, that truly serve our needs, and are nationally acknowledged as models for others.

I'd like to close with a quote from Councilman Krupicka's Blog: "And lastly, voters are smart enough, and have the right, to decide for themselves how they vote." If that is so, then why are the seven of you and not the citizens of this city deciding this now?

STATEMENT OF CARLYLE C. ("CONNIE") RING

RE: LOCAL ELECTIONS IN MAY

I strongly urge that the local elections remain in May. Attached are two letters I have written expressing more fully my views. In summary, my points are as follows:

- A public hearing is meaningful if each member of Council has an open mind to receive and consider the views expressed in the public hearing. Otherwise the public hearing is a charade.
- It is more appropriate for the newly elected council to decide whether there should be a referendum for an expression of voter preference or whether any change at all should be made.
- A decision made now may be irreversible so should not be made in haste.
- The objective of every election should be for an informed electorate to choose the best persons to make decision in the public interest with a diversity that reflects the make up of the electorate as a whole.
- The committee appointed by this Council to study the issue voted 7 to 2 to continue local elections in May.
- Meaningful competition for seats on the Council is the major factor in turnout. To the extent diversity is discouraged and competition thereby reduced, turnout for the local elections will diminish for the lack of meaningful choice.
- Representation of minorities has been fostered by May elections from the successful campaign of Ira Robinson as an independent and other elected independents some of whom were government employees, and of Republicans.
- Dialogue and consensus building is better achieved in the open and refreshing dialogue from those with different perspectives.
- Any decision of this Council will be scrutinized under the Voting Rights Act.
- Full public input is better achieved by a referendum at the appropriate time.

Dear Editor:

In the recent May edition of the Times, an informative table of declining voter participation was included. However, I believe it does not tell the whole story of why participation has diminished.

The biggest factor is reduced competition and thus choice for the voter. When there have been meaningful races for Mayor the participation has been greater – and most of those contests were in the 70s and 80s, and also a period in which Independents and Republicans held 3 out of the 7 seats on Council for much of those two decades. The highest vote was in 2003 when there was a three way contest for Mayor namely Euille, Cleveland and Van Fleet. That was a turnout of 20,221. The second largest turnout was in 1988 when I challenged Jim Moran for Mayor -- a turnout of 19,262. The third best turnout was in 1985 when Jim Moran, running as an Independent, challenged Chuck Beatley – a turnout of 19,146. When there was no race for Mayor or a low key race, your figures show the turnout was less.

The figures show that competition and choice for the voter is a factor in reduced turnout and consequently, in moving the local elections to November, the interest and the number of voters marking their ballots for City Council and Mayor at the end of a long ballot may also drop off dramatically.

In addition to the decline of competition, there are two other factors that have played a role in my opinion. The first is the changing demography of Alexandria. It has been my observation that the turnover rate of the Alexandria residents has accelerated. People who live in the City for short periods of time are less

connected to the city's civic activities and less likely to take an interest in local elections.

The last factor is that the increased ease of registering to vote (a good thing) has increased the rolls for national elections but because of the resident turnover rate mentioned above, the interest does not manifest itself for local elections. Thus another cause for reduced percentage participation by registered voters.

Your table showing the history is informative but the conclusions to be drawn from it need added information analysis.

Retribution or Realpolitik? Let The Voters Decide

The proposal to change local elections from May to November may place partisan advantage over the best forum for dialogue on city issues and selection of the best people to serve on Council. It is in my view wrong to make any change now for the following reasons:

A decision by a lame duck Council on June 13 may be perceived as retribution for the electorate selecting three new members of Council on May 5 and as a blow to the benefits of diversity on Council.

The discussion of city concerns in November may well be overwhelmed by the attention given to national and state candidates, greatly diminishing the dialogue so important to maintaining a consensus and sense of community in Alexandria.

Voting in November may encourage factional voting (party line voting) for local offices rather than voting for each candidate on his or her individual merits.

Two Virginians warned against factions (relying upon parties) rather than selecting the best people to represent us. George Washington in is his Farewell Address wrote:

"I have intimated to you the danger of parties... [T]he common and continual mischiefs of the spirit of party are sufficient to make it the interest and duty of a wise people to discourage and restrain it...It serves to distract the Public Councils, and enfeeble the Public Administration. It agitates the Community with ill-founded jealousies and false alarms, kindles the animosity of one part against another, and foments occasionally...There is an opinion, that parties in free countries are useful checks upon the administration of the

Government, and serve to keep alive the spirit of Liberty. This within certain limits is probably true....And, there being constant danger of excess, the effort ought to be, by force of public opinion, to mitigate and assuage it. A fire not to be quenched demands uniform vigilance to prevent its bursting into flame, lest, instead of warming it should consume."

James Madison in the Federalist Papers wrote:

"Complaints are everywhere heard...that governments are too unstable, that the public good is disregarded in the conflicts of rival parties, and the measures are too often decided not according to the rules of justice and the rights of the minor party but by the superior force of an interested and overbearing majority."

The counsel of Washington and Madison was not only relevant then but applies today. It is not wise for a lame duck Council composed all of one party to impose a rule upon a newly elected Council with diversity of viewpoints what may be an irreversible decision. The haste will be perceived as one for partisan advantage.

The public policy choice is whether the city is better served (i) by individuals elected when the full attention is upon local matters and the individual merits of the candidates, or (ii) in November for national or state elections when the local matters will be suppressed and factional voting may determine the outcome but larger participation may be achieved. It is a valid policy debate but one appropriate for the new Council and, if they consider it appropriate, a referendum which the electorate will decide.



MOVING LOCAL ELECTIONS FROM MAY TO NOVEMBER:

INCREASES PARTICIPATION, SAVES MONEY, AND IS THE RIGHT THING TO DO!

- <u>May Elections Aren't Working.</u> Only 15% of Alexandria voters participated in our May 2009 elections. There has been a steady decline in May elections over the past decades: in 1976 turnout was 41%, in 1985 it was 36%, and in 2006 it was 19%.
- <u>Citizens Vote in November.</u> Across the country, local, state and national elections are held in November. In Virginia, half of cities that had local elections in May have moved to November, including Virginia Beach and Charlottesville. In Alexandria, in November 2008 voter turnout was 73%, in 2006 it was 59%, and in 2004 was 81%.
- **Saves Money.** Moving elections from May to November will save the City approximately \$60,000. It's fiscally responsible to move our elections and it will increase participation.
- Alexandria Residents Are Smart and Can Handle This. Opponents of moving elections state that those residents that care about Alexandria vote in May, implying those that don't vote must not care about Alexandria and/or are uninformed. 87% of our residents hold a high school degree and we all live just a few minutes from Washington D.C. we are well educated and understand politics. We can make thoughtful decisions about who to elect; it's insulting to suggest that 85% of our residents don't care about Alexandria or understand the issues.
- Let our Council Concentrate on the Budget, PLEASE! One of, if not the, top priorities of our Council and Mayor is to pass a responsible and thoughtful budget in late April/early May each year. It is unbelievable that during the budget season we have Council members spending large amounts of their time campaigning and not working on the budget. We need more budget sessions and hearings—not less. We need more input from the citizens on how our tax dollars are spent—not less. Having the budget passed literally days before the May elections is irresponsible and turns valuable attention away from the budget. The City Council is responsible for a half a billion dollar budget—we need them to concentrate on the budget, and for more citizens to participate and decide who gets elected to handle such an important task- not 15% of voters.
- Force Candidates to Reach out to ALL Voters! Unfortunately, our tradition of low turnout is being sustained by candidate outreach strategies. 

Dear Mayor Euille and Members of City Council:

I write today in favor of moving our municipal elections to November and I urge you to support this item which is on your docket for Saturday. Over the years we have seen a consistent decline in voter participation in our local elections, mostly recently a 15% turnout this past May. Ironically, the decisions made by our City Council directly affect our citizenry and yet fewer citizens are engaged in these important elections. Now is the time to make the first of a number of reforms which would help boost turnout and engage our citizenry, and moving local elections to November is the first step.

Moving the elections to November will time elections to coincide with normal voting for other offices, and November elections are habitual for many voters. With turnout much greater in November than in May, more citizens will be aware of local issues and will weigh-in as part of the electoral process. I would argue that with more citizens engaged in the electoral process the better the ultimate result. As a participatory democracy we should always look to increase participation and remove artificial barriers to participation in our governmental process.

If we assume a 50% voter turnout in a gubernatorial year along with a fall-off in participation in local races to 30%, that figure is twice the turnout we experienced last May. This higher turnout represents a significant improvement and will be the result of one simple step, namely changing the election to November.

Additionally, I feel there are a number of other reasons supporting the move to November:

- Virginia counties hold elections on November and turnout is higher and they experience no adverse effects;
- Many other Virginia cities have moved to November elections once the General Assembly gave them the option; and
- May elections were originally put in place to suppress minority participation, and I believe that we as a society have moved far away from

that rationale and should look to promote participation amongst all citizens.

As I mentioned, moving our local elections to November is an important first step and Council should also consider others. I favor lengthening the term of office for City Council to four years (I believe that Alexandria is the only jurisdiction in the Commonwealth with three year terms), and terms of office should be staggered with three seats up for election every two years. Such a move would focus more attention on fewer candidates and ending the cattle call of up to twelve or more candidates seeking office. This series of reforms would make it much easier for candidates to participate in neighborhood forums, and voters could much more easily examine the candidates' respective records and their stands on important issues to our city. Again, the result would be more participation and a more effective electoral process since we will have increased the frequency of our elections along with the timing of the elections.

Coupled with moving the elections to November, these reforms will allow us to engage a larger constituency, encourage candidates to seek office and more effectively conduct campaigns for local office. Increased competition and more attention paid to local elections will ultimately yield an engaged citizenry and a responsive Council.

Now is the time to initiate these reforms, namely on the heels of our last City Council election. Any reforms must be initiated now at the beginning of a new term so we can develop appropriate transition strategies. Accordingly, I urge your prompt action and support for moving to November elections for City Council.



Statement of Michael E. Hobbs for the Alexandria City Council June 13, 2009

#21 – Changing the Election of the Mayor and City Council from the May General Election Cycle to the November General Election Cycle

Thank you, Mayor Euille, Vice Mayor Pepper, and members of Council. I am Michael Hobbs, residing at 419 Cameron Street.

I have participated in the civic life of my community as Co-Chair of the Alexandria Federation of Civic Associations; as President of the Old Town Civic Association; as Treasurer of Agenda: Alexandria; as chair of my local political party; as a volunteer and/or contributor in the campaigns of several candidates for public office, of both parties, and the manager of one; and as a voter in every primary and general election—both in May and November—since I became eligible to vote. My opinions about our election process are, I hope, informed by those experiences, but I write today for myself, not for any organization.

The active engagement of our citizens in the governmental and electoral processes of our city is a hallmark of our public life. It is central to what makes ours a great city, a real community, and a government of the people, by the people, and for the people.

The objective of moving our municipal election from May to November presumably would be to increase the number of people who cast votes for our local offices. That would almost certainly be the superficial result. But the unintended consequences of such a move could do grievous harm to the quality, intensity and importance of real and meaningful public participation in our public life. We might strengthen the <u>appearance</u> of public participation in our elections and government, but in fact do critical damage to the <u>reality</u> of that ideal in Alexandria.

Approximately 15,000 citizens typically vote in our city elections in May; the number is often more if there is a Mayoral election contest. If the election were shifted to November, that number would probably increase significantly, at least in years in which a presidential or gubernatorial election headed the ballot. But would that mean that the quality and importance of citizen participation in Alexandria government has increased proportionately, virtually overnight? Certainly not, and perhaps quite the contrary. It would simply reflect the reality that many more people vote in national and statewide than in local elections, and that having come out to do so, many of those additional voters might vote also for the local offices if they were included on the same ballot.

It is argued that moving the election to November would increase voter <u>turnout</u>—but in fact it is very unlikely that it would increase the number of Alexandria citizens who actually come out to vote in November. Eligible voters who ever turn out for <u>any</u> election (including virtually all of those who ordinarily vote in our local elections) probably vote in Presidential elections already: it is unlikely that any additional voters would be motivated

to turn out in November just by the addition of local offices to the ballot. Indeed, the <u>aggregate</u> number of voters participating in Alexandria elections over the course of a year would almost certainly <u>decline</u>. With the present cycle, we might have, typically, 15,000 voters in May and a modest to a much greater number in November, depending on whether there were a Presidential or Gubernatorial contest on the ballot. With the addition of the City election to the ballot, we might have a <u>very few more voters than would otherwise turn</u> out in November . . . but we would have 15,000 fewer turning out in May, by definition.

The sheer number of votes cast for local offices on election day is but one measure of the significance and importance of public participation, and by itself probably not the most useful. The value of our public participation in Alexandria is measured more importantly by the engagement of citizens in our political campaigns, both as volunteers and as contributors. It is measured by the openness of our process to new candidates, representing new energy and fresh ideas, in both parties. It is measured by campaigns featuring robust debate and competitive candidates. It is measured by the engagement of parents and citizens representing a broad range of opinions and a shared commitment to our children, in our nonpartisan School Board elections. It is measured by active participation in the public policy debate once the government has been elected, at public hearings such as this, and in other contacts with our elected representatives, both through our civic associations, community groups, and individually. And it is measured, perhaps most importantly, by the focus of public attention on the Alexandria candidates, the Alexandria issues and the Alexandria policy alternatives during our city election campaigns—the sort of concentrated attention which engages most of our citizens in that discussion through local media coverage, candidate forums, campaign events, and family and neighborhood discussions whether all of them actually turn out to vote on election day or not.

By all of these measures, the quality and importance of public participation in the choice of our local government would be drastically reduced by shifting our municipal elections to November.

In Virginia, election of one or more national or state offices heads the ballot every November. With a closely contested presidential, senatorial or gubernatorial election heading the ticket, the ability of city council or school board candidates to attract campaign volunteers would be seriously impaired. Contributions would flow first to the highly sophisticated national and state fundraising campaigns, leaving little for the local candidates. Local candidates, especially new candidates, and most especially school board candidates, would find it virtually impossible to get their message heard amidst the torrent of communications about the national and state campaigns, and prohibitively expensive to do so. Which contest will the media, and the voters, concentrate on: Obama vs. Romney (or Condoleeza Rice!) for President? Webb vs. Allen for Senate? Deeds vs. McDonnell for Governor? Or what the order of finish will be among the Democratic candidates for Council and thus who becomes Vice Mayor?

Probably the single most important determinant in whether or not people vote in an election is how important they think it is to them to do so. They will vote if they believe, first, that the outcome of the election is important to their interest and quality of life, and second, that

their vote may be important in determining the outcome. If they feel that both the election and their vote is important, they will vote; if not, they won't.

Why don't more Alexandrians vote in our May elections? Probably because they're seen as less and less competitive over time. We Americans become engaged and involved if it's a truly competitive contest—whether it's Allen vs. Webb, Clinton vs. Obama, the Caps vs. the Penguins, or T.C. vs. Petersburg. Moving our local election from May to November, and thus removing the last vestige of uncertainty from the result, will probably not increase voters' interest in our local races, but reduce it still further.

It has been suggested that you should adopt this change in the election cycle because the recommendation of the blue-ribbon panel which you appointed to study it was unclear or inconclusive. Quite the contrary! That distinguished panel included members of both parties, a majority from Alexandria's majority party, and included former public office holders, both state and local, from both parties. It followed an exemplary process in developing its report, including the publication of pro-and-con issue papers on all of the alternatives it considered, and the solicitation of testimony both before and at a full-day public hearing on those alternatives. The process was a model of fairness, openness, objectivity and balance. In the end, two of the nine members recommended that the election be moved to November—but only if the term were changed to four years, and moved back to the year before the Presidential election year, so that it would never compete with a gubernatorial or Presidential election. Seven recommended that the election not be moved to November at all.

After the Hobson Commission's report, you appointed a special committee of two Councilmembers to review its work and make recommendations to the full Council. That committee reported that an earlier group, the 1993 Ad Hoc Committee on Election Procedures, had recommended "changing the time of City Council elections to the fall"—and thus that, faced with conflicting recommendations from the two commissions, Council should proceed on its own.

That characterization of the 1993 committee's report is incomplete and misleading, at best. The fact of the matter is that six of the seven members of that committee recommended

... that City Council elections be moved to the fall, <u>in years coinciding</u> with the quadrennial election of State Senator and Delegate to the General Assembly. These are the years when neither presidential electors nor governor is chosen. (Emphasis supplied.)

(The seventh member, who voted against moving the election to November even in "General Assembly" years, was the then-Chairman of the Alexandria Democratic Committee. He was concerned that "issues arising during the General Assembly contests might overshadow and obscure the local issues that ought to be the basis for City Council elections.")

Four of the seven members of the 1993 committee recommended that the term be lengthened to four years; three recommended "retain[ing] the present three-year terms, unless City Council elections are moved to the fall." (Emphasis supplied.)

In sum, not one member of either of the distinguished bipartisan panels that studied the issue in 1993 or 2007 recommended that the election be moved to November regardless of any other changes—which is precisely what it is now proposed that you do by adopting this ordinance.


Indeed, even your two-member subcommittee (Mayor Euille and Councilman Wilson) recommended in their February 2008 report that, "in recognition of the significant community interest in this issue," you adopt an ordinance moving the election to November only if, and after, an advisory referendum of the citizens and voters of Alexandria indicated that was their preference. It is now proposed that you adopt this fundamental change in the structure and composition of our government without any such referendum, and irrespective of the views of the voters.

It is suggested, finally, that Alexandria should move its elections to November because that is what many other jurisdictions do. But the general rule for the far-more-numerous counties under the Code of Virginia is that the election of the supervisors takes place every four years in the November before the Presidential election year; and the general rule for independent cities and towns is that the election of the Mayor and Council takes place in May of even-numbered years. To be sure, some cities and counties have taken advantage of the exceptions permitted under the Code to elect some or all of their governing body members in November. But I know of no other county, city or town in Virginia which has chosen to elect all of its members on a three-year cycle including Presidential and Gubernatorial Novembers—which is precisely what the ordinance you are considering would do, and all that it would do, irrevocably.

Your vote on this question will have a profound and decisive impact on how our community is governed, and whether those of us who truly care about our local government and policy will continue to have any effective voice in that process. You certainly have the authority and the political power to move the election of the Mayor, Council and School Board from May to November if you want to; it is far less certain whether it would be in Alexandria's best interest for you to assert that power.

Conducting our city elections all by themselves, in May, tells our voters that this is the most important election they should follow and participate in as citizens of Alexandria, and in which they can have the most important impact. Shifting the election from May to November shifts it from the most important election to the least, from the top of the ticket to the bottom.

As a citizen who treasures the unique degree to which we now have the opportunity to participate in our local government, I implore you not to jeopardize our rich tradition of citizen government in Alexandria by moving the election to November.





Dear Mayor Euille and Members of Council:

I regret that I am unable to be present today as you consider moving our municipal elections from May to November, an issue of extraordinary interest and importance to a great many Alexandrians. I have a conflicting commitment that has pulled me to Charlottesville. My UVA Sorensen Institute Political Leaders Program meets this weekend with college student leaders from around the Commonwealth to discuss geographic interdependence and ways we can all come together to make Virginia a better place to live.

I write to ask you kindly to defer consideration of moving our elections from May to November. As you all are aware, you do not retain the ability to wholly consider the issues of interest to our electorate on this topic at this time. It simply does not make sense to consider this issue piecemeal.

I have written opinion editorials on this topic and the 2007 Hobson Commission report in the *Alexandria Gazette Packet* and make these comments in the spirit of those editorials. I note for the record, based on an article written by Michael Lee Pope in this week's edition, that Former Alexandria Mayor and State Senator Patsy Ticer agrees with the position I have taken that we need to seek authority from the General Assembly to make changes to our charter before moving forward at all.

This Council approved, and the Mayor appointed a Commission of concerned citizens ["the Hobson Commission"] to consider making election changes. After studying the issues for three months and a period of public comment, they voted seven to two to leave the elections in May. And the two in favor of a move to November, Bob Calhoun and Ana Leider, conditioned their support on terms that you lack the authority to perfect.

While you may now be kicking yourself for not doing it sooner, this Council could have easily, in either the 2008 or the 2009 Legislative Session, sought authority from the General Assembly to enable changes to the length of terms, to determine staggering terms, and whether to put elections in each year preceding an election year, etc. And though the same would make Item 21 ripe for discussion and a vote today, you did not. As a result of this fact and the most recent election, moving forward now looks more like a political power ploy than as a real concern for the interests of our electorate. Public service requires that we put people first. A vote today on this issue is not keeping Alexandrians first. And for at least two of you, a vote today represents a conflict of interest, because you stood for re-election and were defeated.

While there may be one or two of you stating a wholehearted intention to make additional changes to our elections later but just wanting to get the ball moving now, in the absence of a vote, the same holds no weight, because your intent does not effect change, absent authority.


If you move forward today, you do so against in the desire of a great many Alexandrians who transcend neighborhoods, race, socioeconomic status and political affiliation. If you

do make this change today, there are more people standing against your decision than with it, and this is representative government. While we cannot always make everyone happy, we have seen that people here do vote their concerns and have long memories on issues that affect them in manners they dislike. The people will remember and what a horrible legacy this will be.

In closing, I do understand that when this matter does pass, it must go to the Department of Justice for pre-clearance pursuant to Section 5 of the Voting Rights Act. Your intent to make additional changes does not go with it. It stands alone. Given the history and struggle of minorities for the right to vote in this country, anything that triggers the Voting Rights Act must be treated very delicately. Today's action goes to the heart of a fundamental issue – the right to vote, which includes how and when we vote. The Justice Department has grave concerns for classes of persons the Voting Rights Act was designed to protect, namely minorities, having/retaining the ability to elect their candidates of choice with this move. While I do understand the argument that greater turnout will ensure this, there are certainly arguments against this point that merit consideration.

I have been advised that Justice will contact elected officials of color, past and present, and concerned community groups for comment. I can only think of one living African-American elected official in Alexandria, past or present who will support the move from May to November under today's conditions. The others, who have run and won in May as Democrats, Independents and Republicans alike are all against a move at this time with your limited authority. In view of the foregoing, implore you to please defer this vote. Thank you for your consideration and

What's Wrong With Local Elections In May?

- Extra cost to the taxpayer to run this election (and related March Council primaries if conducted in future)
- Incumbent Council members should be studying budget options in Feb/Mar/Apr -- not campaigning
- Very few people vote and this impacts turnout in June as well
- Being out of step with election cycles of most of the rest of the State makes for conflicting schedules with state agencies/state political parties
- Hard to explain the need to election weary citizens some May voters thought they were voting for Governor
- Too close to the June primaries which can't be moved
 - Compromises training for June election officials
 - If May recount required, June primary hard to conduct
 - City candidates have a hard time raising money and being heard whenever June primary race(s) are contested
- A better option exists -- November of Presidential Year + 3
 - Campaigning and turnout for State Senate/State Delegate/Clerk of the Court races is seldom very great but this election must be held
 - Getting there will be awkward because the election in November 2012 will also include races for Congressman, one Senator and the President
 - However, a three year term election for Council in 2012 (till Presidential Year + 3 i.e., 2015) will set up that year to be the perfect time to elect members to the first four year terms
 - This timing gives several years to debate the exact nature of the other aspects of the necessary Charter Change
