SUBJECT:

ORDINANCE TO AMEND CITY CODE SECTION 4-2-21, TO IMPLEMENT CHANGES TO THE VIRGINIA STATEWIDE FIRE PREVENTION CODE, TO REMOVE FEES FROM TABLE 107.2 AND ADOPT FEES BY RESOLUTION.

ISSUE: Consideration of an ordinance to remove Fire Prevention Operational Permit fees from Section 4-2-21 of the City Code so that future changes in the fee schedule can be considered and amended by Council resolution.

RECOMMENDATION: That City Council pass the ordinance (attached) on first reading and schedule it for public hearing, second reading, and final passage on Saturday, June 13.

<u>DISCUSSION</u>: Building permit fees currently are amended by resolution in accordance with City Code Section 8-1-29. The proposed ordinance will remove Fire Prevention Operating Permit fees from Section 4-2-21 which requires an ordinance to amend fees governed by this Code section. By passage of this action, future actions to amend these fees will be by Council resolution. The Office of Building and Fire Code Administration has proposed a separate resolution to amend Building and Fire Prevention Operating Permit fees for fiscal year 2010.

FISCAL IMPACT: There is no fiscal impact associated with this action.
